Wisconsin Dells Prepares for District Convention to be Held in August

As you know, Wisconsin Dells was the unanimous choice of the delegates at the Marquette Convention last summer for the 1940 Wisconsin-Upper Michigan District

Before the invitation was extended to the District a committee was appointed to make a complete survey to determine whether the "Biggest Little City in the State of Wisconsin" could meet all of the requirements necessary to satisfactorily entertain the Convention. This committee having reported favorably, a convention committee was appointed consisting of Dr. R. D. Boynton, General Chairman; Rev. E. C. Dixon, Vice Chairman; and George M. Pike. A convention fund was set up and the members of the club, amounting to about 50 voted both individually and collectively to aid the convention committee in every possible way.

A tentative outline for the program of the Convention suggests that when you arrive at Wisconsin Dells on Sunday afterarrive at Wisconsin Dells on Sunday afternoon, August 25, you and your party register at the Convention Headquarters in the Community Building, the home of the Wisconsin Dells Kiwanis Club. After registering and getting located at your hotel, it is suggested that you drive up to Camp Wawbeek, the summer camp of the Wisconsin Association for the Disabled, a vast estate located several hundred feet above the city at its eastern limits. Here one can witness at first hand the wonderful job being engineered by our own Past Govbeing engineered by our own Past Gov-ernor "Bill" Faulkes. Guides will escort you about the camp and to the top of the castle where an excellent view of the surrounding country and The Dells Region can be obtained.

If you choose, you may secure your evening meal at the camp and remain for the usual semi-religious program which will be in charge of Rev. J. W. Davies President of the Wisconsin Dells Kiwanis Club.

The past officers club will breakfast together Monday morning.

On Monday morning the Convention proper will open in the Auditorium of the Community Building, at noon the meeting will adjourn to the gymnasium of the high school where luncheon will be served, following the luncheon the Divisional Conference of the control of the business of the control o ferences will be held in various rooms of the high school.

At 4:00 P. M. the delegates and guests will meet at the Dells Boat Company Landing where their General Manager, Kiwanian George M. Pike will direct the

party through the nationally famous Upper Dells by motor boat, making stops at Cold Water Canyon, Witches Gulch, and Stand Rock, where a high-class box luncheon will be served, community singing and a real Kiwanis get-together held. Following this, we will be entertained by the Indian Ceremonial held in the natural amphitheater at Stand Rock, the only ceremonial of its kind in the world. As a prelude to the ceremonial about 30 minprelude to the ceremonial about 30 min-utes will be given over to a special program honoring distinguished guests.

Following the ceremonial we will return by boat down the Wisconsin River to Wisconsin Dells, enjoying enroute the singing of Kiwanis songs led by Indian artists, the fantastic outlines of the river bank as shown by the search lights of the fleet of launches and the moon, which by the way will be the same moon, but bigger and better then when seen at Marquette. and better than when seen at Marquette last year.

The delegates to the Nomination Conference will be assigned a private launch where they can hold their deliberations under the guidance of Past Governor George.

After returning to Wisconsin Dells Monday evening the delegates and guests will be entertained at the Governor's Ball.

On Tuesday morning the delegates will reconvene for the regular morning business session at the Convention Hall, the business session will be followed by luncheon and afternoon business session at the high school gymnasium.

Ladies, Gents, and Juniors Golf Tournament will commence at the close of the afternoon session at previous assigned nearby country clubs, trophies and awards will be presented at a banquet following the tournament at Dell View Hotel on Tuesday evening. Under the able leadership of Staff-Bandmaster Ray Ogg the band displayed a high grade of musicianship and showmanship, a smoothness of performance which bespoke an unusually fine spirit of cooperation among the players, and well balanced, varied, appealing programs.

Comfortably billeted in Marquette at Comfortably billeted in Marquette at the Hotel Clifton—through the courtesy of Kiwanian Roe H. Hill, manager—after a 400-mile drive from Chicago, the Staff Band's initial engagement was a half-hour broadcast by a small group over Station WDMJ, the radio voice of the Daily Mining Journay. The program was presented through the kindness of Station Manager Gordon Brozek.

On Friday evening at the Northern State Teachers College auditorium the band played to the largest and most enthusiastic audience of the entire tour—1,200 persons, who cheered and applauded the performers' every effort.



- 6. Arrange for at least ONE interclub meeting sponsored by your club.

The real objective of any Kiwanis club is betterment of the community in which it exists. This alone justifies its existence; the time it takes from busy men and the money spent in it. This alone will attract and hold worthwhile membership. The reason for submitting to you an achievement report is to make you realize that back of all the fun and frolic, the good times and speeches, there have been real things done for the community.

Achievement—The success of any Kiwanis club depends upon the achievements of its memberships. We hope that what follows will give you added pride in your

Agriculture—Two meetings. Planned and sponsored club meeting for February seventh at which twenty-two leaders of various farm organizations were special guests of the club. The farmers brought gift packages, from eggs to radishes which were awarded as prizes. The recognition and encouragement of the agricultural leaders adds much to the pride of the farmer and strengthens his determination to stick to an intelligent tilling of the soil.

Attendance—Three meetings. They assigned all members of the club having poor attendance records to some member of the committee who is to be responsible for contacting these men and urging their attendance. Attendance at Kiwanis meet-ings is as essential to the welfare of the organization as food is to the body.

Automobile—No meetings. But, at the request of the under privileged child committee, they furnish cars to transport eight clowns from the Shrine Circus for the en-

Boys & Girls—Two meetings. A new Scout master for the troop they are sponsoring was one of their problems, but that is solved. They arranged a hike for this troop and provided instructions in first aid. troop and provided instructions in first aid and simple forms of handicraft for a group of Girl Scouts. Just so long as men like these are rendering unselfish service there is no danger to our civilization.

Bowling-Thirteen meetings. The average attendance at the Monday night bowling was: January 35, February 37, March 34. The inter-club bowling gettogether April first and the tournament at Marinette made history. The worst solitude is to have no true friendships. Here is one of your best bets for making em.

Business Standards-No meetings reported, but have something coming. They realize that mere criticism is like shadow boxing. It may be good for the liver but it won't win the fight.

Conservation — Five meetings. The wildlife feeding program was carried out 100% by the members of the committee. They plan to broadcast and otherwise

spread the gospel of conservation to the public and to the schools. Just so long as men have deep in their hearts the desire to leave the world a little better place than they found it, just that long will Kiwanis

Entertainment — No meetings. We leave more to do when we die than we have done, so why take life so seriously! Let's get limbered up for that great picnic that will soon be here.

Finance—One meeting. The budget was prepared, approved, and is now within limits. Money is not paid into a Kiwanis club to be saved. It is for the sole purpose of being spent in carrying out the objectives of the club. Each year should see the entire income expended in some good work.

Golf—Two meetings. Five meets have been scheduled as follows: May 15—Westmoor, June 26—Tuckaway, July 24—North Hills, August 28—Tripoli, September 18th -North Shore. As an inter-club gesture, notices to the other clubs in the division will be sent inviting their members to join our golfers.

Inductions—Two meetings. new members were properly inducted the first quarter. They were given to under-stand that the men who put the most personal service into Kiwanis become automatically the most enthusiastic.

Inter-Club — Three meetings with "nothing to sell" but the thought that we have more neighbors today, but less neigh-borliness and we should do something a-bout it. The bowling, golf and program committees are in cahoots with the interclub relations committee in weaving that welcome mat for our front door.

Kiwanis Education—One meeting. The twenty-fifth anniversary of Kiwanis International was appropriately celebrated with the reading of the president's message to all clubs, followed by a Dakin gem, "Kiwanis As An Adventure". Also a sum between \$100.00 and \$125.00 was set aside for camp expenses for crippled children at Camp Waubeek during the summer months. A member who wishes to remain anonymous, donated the cost of six V M C A memberships to under privalent. six Y. M. C. A. memberships to under privileged boys. There is no time a man stands so high as when he stoops to help a child. A book could be written on the splendid work of this committee.

Visitation-Committee made twentyfour calls on shut-in members. Many men find that Kiwanis not only gives them something to do, but it surrounds them with kindred spirits and friends.

Vocational Guidance—Three meetings. To have helped a boy or girl to find a vo-cation in life which will make his or her whole life a happy and a prosperous one, is a privilege enjoyed by few. Questionnaires were distributed among the membership to find out which of the members would be willing to interview individuals, lead discussions, or write material con-cerning vocation in which they are en-gaged. Letters were written to all high school principals in the city offering the services of the committee members and other members of the club in leading discussions, interviewing individuals, or talking to groups of students concerning the various businesses and professions.

Club Provides Hot Lunches in School

An Interesting Bit of Indian Lore

There are a score or more of hot lunch projects in the upper peninsula for the benefit of under privileged school children in lower grades, and to the Marquette Kiwanis club goes credit for pioneering the idea in a basement room at the Nester school on Bluff street. The project here

school on Bluff street. The project here has just completed its third year.

From 30 to 40 children from the first to the fifth grades are fed stews, soups, cocoa, crackers and cookies for lunch for 100 to 120 days in the school year, ranging from November 1 to May 1, and the increase in their weight and also the improved attendance record are remarkable, to say the least

to say the least.
It started in September, 1937, when Miss Margaret Wickstrom, then an instructor at Nester school, suggested the hot lunch project to a group of Kiwanians. It was presented to the club and approved by its board of directors October 21, 1937. In fact, whole-hearted approval was granted, for the club readily saw the value of serving meals to under-fed children and saw in it a civic project that ranks with the best.

The club came through with dishes and silverware and provided money to buy food. The WPA paid the cook's wages and the first lunch was served November 1,

1937

One hundred and sixty-five pupils are enrolled at Nester. Of this group, from 35 to 40 are selected to get the benefit of the hot lunches. Several organizations have co-operated in the plan by providing food

and equipment.

For instance, the conservation department turned over 250 pounds of illegal venison steaks last season. The children bring bread and sandwiches and other food from home—their regular lunch—which is supplemented by the Kiwanis club in this manner, and here's a typical week's menu:

Monday-Bean soup, cookies, canned

peaches.

Tuesday—Spaghetti, prunes, cookies. Wednesday—Venison stew, rice pudding.
Thursday—Baked beans, dried peach-

Friday-Macaroni and cheese, choco-

late pudding.
And then there is milk or cocoa to drink and corn bread to munch on. Not bad, eh? A hot dish a day is the rule and it's done wonders with the weight, general health and spirit of the youngsters.

There are similar projects in the peninsula and throughout the state. Some are state-sponsored and some privately handled, but as far as is known, the whole thing was pioneered, at least in this part of Michigan, by Marquette's Kiwanians.

As for expenditures, the Kiwanis club feels the amount of money spent each school year is small compared to the reward of seeing its "family" of Nester school children happier and healthier. The club spent \$125 the first year, \$131 in 1938-1939 and about \$100 this year. The 1939-1940 figure is less because of the food donated by the surplus foods commission.

GOVERNOR IN THE NORTH

Governor William T. Darling is spending July and August at his summer home near Hazelhurst. However, he is very much the governor as far as Kiwanis is concerned, and is meeting with clubs throughout the north and central areas every week.

Otto Heller of Brothertown, reputed to be "the best living authority on that little known era preceding the coming of the white man to the Garden of Wisconsin", sketched interestingly the early history of the Brothertown settlement in a talk before the Kiwanis club at the dinner meeting at Hotel Chilton Tuesday evening.

Mr. Heller said that the Brothertown settlement is unparalleled in some respects in the history of the United States. The view from the hill on Highway 151 overlooking Lake Winnebago, he said, is one of the most beautiful scenes in the state. He suggested that the early mound buildows the must have been impressed by this ers, too, must have been impressed by this entrancing beauty, as they have left evi-dence of their settlement there in the form of several mounds which are still visible

in the vicinity.

The name of the Brothertown Indians, Mr. Heller said, signified their determination to live at peace with one another. As early as 1813, he said, they had cleared for cultivation 2,000 acres of land in the vicinity of Brothertown. They early acquired knowledge of the white man's ways and made woolen and linen cloth.

They were, in some cases, he said, exploited by the white man and found themselves unable to compete with him. From a population of 150 in 1890, the Brothertowns had shrunk to 29 in 1935 and today according to Mr. Heller, there are only 13 left, none of them under 50 years of age.

The first church in the settlement was a Methodist church built in 1834. Although the settlement was located 50 miles from the nearest store and the nearest point at which they could receive medical aid, the settlers seemed to like the location, Mr. Heller said. By 1836 the Military road gave them an overland route to Green Bay.

Mr. Heller traced the history of the tribe in the east before they established the Brothertown settlement. He paid high tribute to the Brothertown Indians for their faithfulness to the white man and for the part they took in wars, always on

the white man's side.

The attendance was most gratifying and a substantial sum realized to further work among the unfortunate kiddies. Full mention should be given to Dr. A. W. Hankwitz and his committee of F. Dean Cardinal, Ed. Perschbacher, Jack Fenny, E. F. Zillman and A. C. Niemann, all of whom labored long and hard to insure the success of the undertaking.
