5. Description of physical appearance:

The LaRoche House is a two-story frame residence clad in novelty siding with a lateral gabled roof and a one-story hipped porch across the façade. The five-bay wide façade has a single entry with transom and sidelights. Roofing is standing seam metal. The low brick pier foundation and chimney at the west gable end are early 1930s replacements.

The façade of the LaRoche House is seen in a ca. 1922 photo (Thompson, "Rockville," p. 44) with a hipped porch across the center three bays, and a door opening with transom at the second floor center opening. By 1931 (p. 119) the second floor door had been reworked as a window, and soon afterward there was a more extensive modernization. A 1971 photo (p. 45) reveals the changes: brick foundation piers lower than the original tabby piers, the porch roof replaced (columns appear to have been unchanged), chimney relocated to the west gable end, and novelty siding installed. In 1990, the porch was extended across the full façade, with new wood posts, slat balusters, insect screening, and an open front deck installed; and the window sash were replaced.

At the north rear side of the house is a long wing, one and one-half stories, with one-story extensions at sides and rear. In 2004 this wing replaced unsound non-historic additions that had resulted from several remodeling projects. The modern wing, with siding and roofing to match the main house, is sympathetic to the historic building and the surrounding historic district. It is recessed from the side elevations and clearly distinguished from the rear of the historic building. Despite the exterior alterations over time, the residence retains its essential historic design and is a contributing property to the district. A modern two-story garage/apartment is set northwest of the house.

The interior plan is typical of antebellum Sea Island residences, with a center hall serving as stair hall and through-corridor, flanked by the principal parlors. A short upper landing connects the two upstairs rooms. Its north side was partitioned as a bathroom in the early twentieth century. Originally fireplace(s) were set at the north wall, but these were removed ca. 1930 when the chimney was relocated. The interior retains much of its historic fabric: heart-pine flooring; late-19th or early 20th century newels, pickets, and rails at the stair; wood door and window surrounds with inset panels beneath the first level windows; and paneled interior doors.

6. Statement of significance:

The LaRoche House is a fine example of a mid-nineteenth century summer residence. In setting, size, scale, mass and material, the building contributes to the surrounding Rockville Historic District. The non-historic garage is not a contributing property to the district.

Historical background

Richard Jenkins LaRoche (1788-1846) of Wampee Plantation and his wife Martha Seabrook Jenkins (1792-1859) had nine children. The youngest son was Joseph Edings LaRoche (1835-1898). In 1856, when he reached the age of 21, he received his portion of his father's estate: Wampee Plantation (subject to Martha LaRoche's life tenancy) and a half-interest in Caty's Hill Plantation. Although no deed was found, Joseph E. LaRoche also inherited his parent's ca. 1835 house in Rockville, which Richard J. LaRoche had bequeathed to his widow for life.

Joseph Edings LaRoche and his wife Ella Elizabeth Murray kept their summer residence at Rockville into the 20th century. In 1913 Mrs. LaRoche sold it for \$1250 to the Sea Island Yacht Club, whose clubhouse was next door. The club gave her a mortgage, then struggled to make payments. In early 1919 Susan G. Seabrook, wife of Edmund Bellinger Seabrook, paid the LaRoche heirs \$850, and received title to the property.

The LaRoche House is still used as a summer residence.

Built ca. 1835 for Joseph Edings LaRoche (1835-1898) and wife Ella E. Murray (1836-1917) Later owner Edmund Bellinger Seabrook (1871-1948) and wife Susan Girardeau Jenkins. 1922 photo shows hipped porch one-story, width as today, but with single door opening at center bay above. Elias Bull's 1970s photo shows the house on lowered foundation, with porch roof reworked, window has replaced upper door; chimney is relocated to west side. P. 119: house shown in August 1931: porch as in 1922, upper opening has been changed to window; chimney not at west gable. Thompson p. 9: first row of one-acre lots along the creek established 1824 by Benjamin Adams. Second row developed around 1828. By 1835 William Seabrook had built his landing.

Richard Jenkins LaRoche (1788-1846) and Martha Seabrook Jenkins (1792-1859); nine children: eldest John Julius LaRoche b. 1816; youngest Joseph Edings LaRoche (1835-1898) and Martha Evelina (1836-1909. Joseph Edings married Ella Elizabeth Murray 2/1857; Martha married JC Seabrook 1855). (Rivers, "Jenkins" in *Seven Lowcountry Families*)

Will of Richard J. LaRoche, written 12/27/1843 proved 3/6/1846. To my wife Martha, my plantation and my house at Rockville for life. Divide real estate among sons. (Book 44, p. 25) Inventory made May 1846. Slaves totaling \$51,321; boats, horses, cattle sheep, household furnishings, hogs... totaling \$2607.50. Does not reference or distinguish among his real estate. (Inv Book B, p. 208)

6/21/1856 Richard J. & James LaRoche, executors RJ LaRoche, to Joseph Edings LaRoche. Ref to will of Richard J. LaRoche: to my wife Martha, the tract where I reside, afterward to my children. Rest & residue divide among children John J. LaRoche (who has recently died), Elizabeth F. Jenkins, Richard J. LaRoche, James LaRoche, Amaranthia S. Jenkins, Daniel J. LaRoche, Edward W. LaRoche, Joseph E. LaRoche, and Martha E. LaRoche (who has married James C. Seabrook). Divide my real estate among my sons.. clauses re specific lands. Each child to receive his share at 21 or marriage.

Estate now consists of the plantation left for life to Martha LaRoche, known as the Wampee Plantation, also Caty's Hill plantations, purchased by the executors with the sale of personal estate and certain slaves.

To Joseph E. LaRoche, Wampee Plantation, 400 acres, subject to Martha's life estate, also undivided moiety of Caty's Hill, 700 acres B&B north on Bears Bluff Road, south Dr. Whitridge [Rose Bank]; also slaves. (RMC V13, p. 602)

2/8/1913 Heirs of JE LaRoche (JM LaRoche, Martha E. Seabrook, Lydia E. Bentz, Amaranthia E. Anderson, Lena W. Sosnowski, Mary F. Hart, Richard T. LaRoche, Esther E. Loggowski, South by Bolicket River West by lands of
Sea Island Yacht Club and North by lands of J. E. Benty.

Together with all and singular the Rights, Members
Hereditaments and Appurtenances to the said Premises
belonging, or in anywise incident or appertaining.

To Have and To Hold all and singular, the said Premises
before mentioned unto the said Sea Island Yacht Club, its
successors and assigns forever.

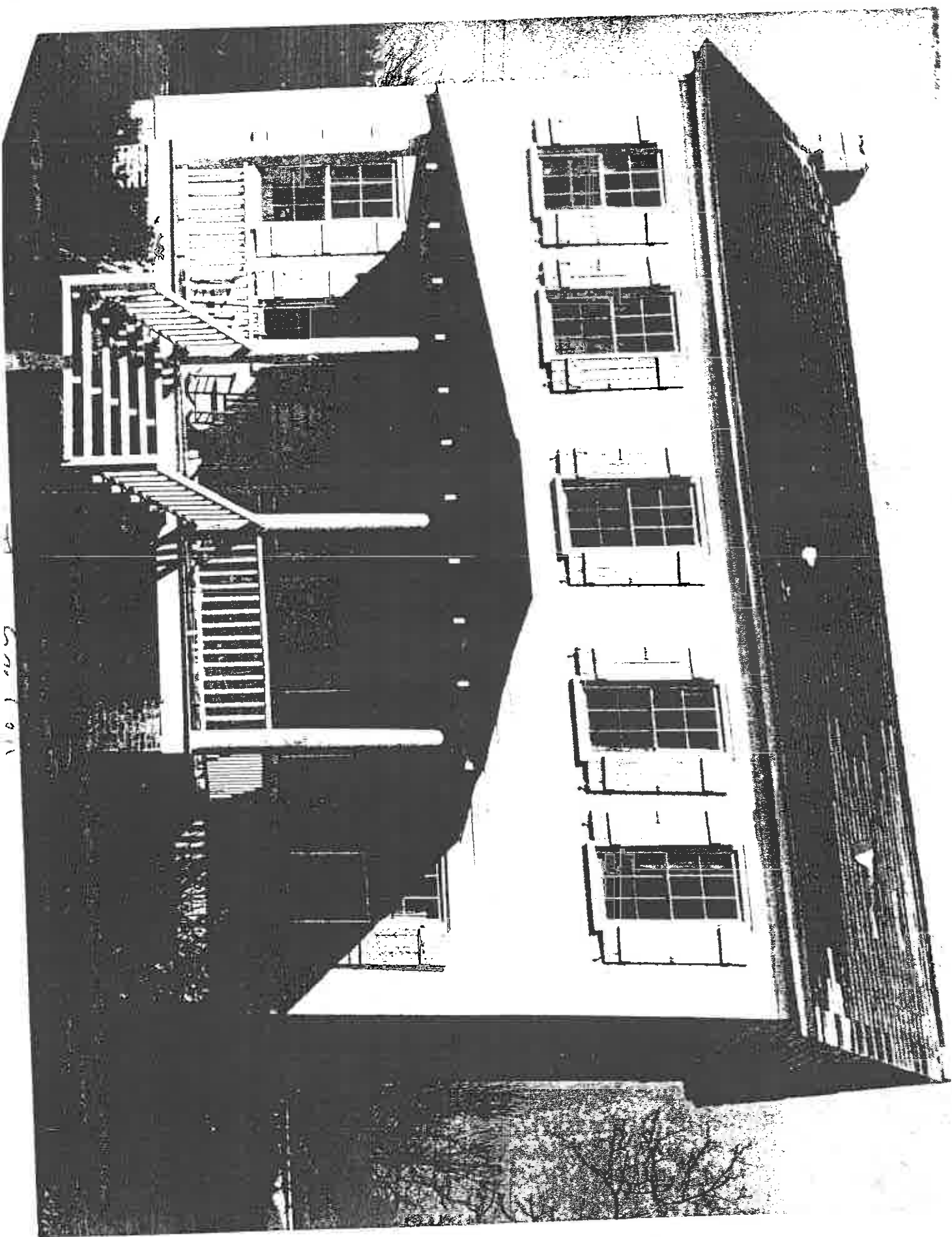
And we do hereby bind ourselves and our heirs, Executors

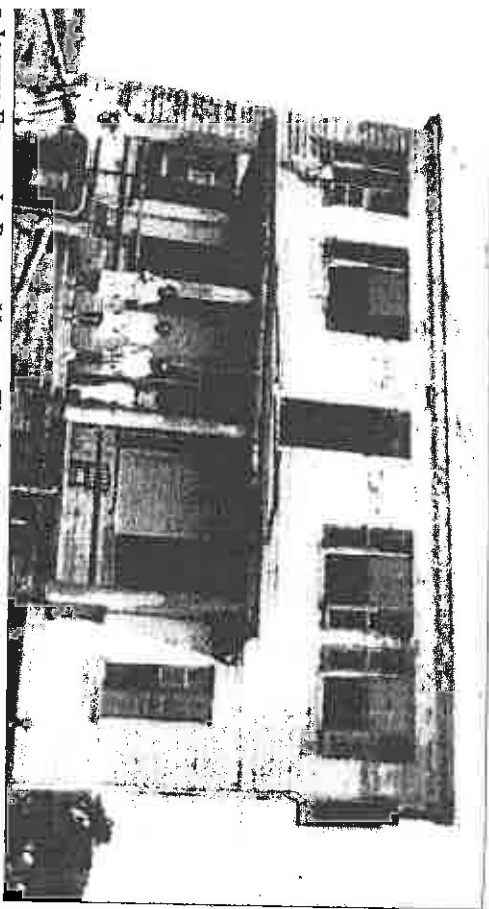

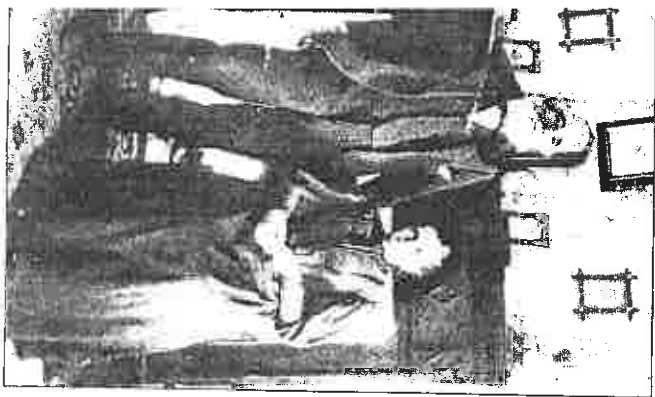

E JOSEPH EDINGS LAROCHE HOUSE. This house, next to the Sea Island Yacht Club, was built around 1835 for Joseph Edings LaRoche. The house is also referred to as the Ned Seabrook house, for Edmund "Ned" Bellinger Seabrook and his wife, Susan "Susie" Girardeau Jenkins, who used this summerhouse next. Ned farmed at Jenkins Point on Johns Island and used to himself across Bohicket Creek to work each day. This house stood previously on a tabby foundation but was lowered in the 1930s. Standing on the porch in this 1972 photograph are, from left to right, daughters Annie G. Seabrook and Virginia L. Seabrook, Florence "Floresie" Seabrook Boykin, and "Susie" Seabrook. 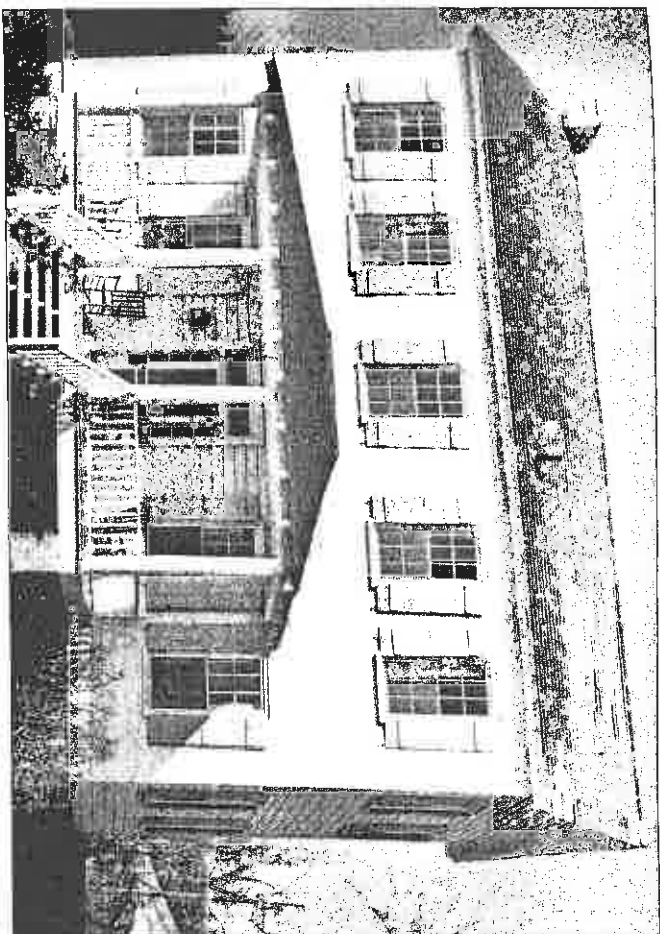

THE JOSEPH EDINGS LAROCHE HOUSE. Elias Bull tells that "the porch, and the house itself, is located about three feet off of the ground. This building is somewhat unusual for Rockville in that it is built near the ground without the usual tabby foundations. This house is built from a utilitarian standpoint to receive the maximum amount of air and light by the spacing of the windows and its orientation to the prevalent breezes from the south, which it faces." DANIEL JENKINS LAROCHE. Daniel owned the last piece of land on the western edge of the village and built a house on it around 1842. On September 19, 1872, Daniel wrote to Julian Mitchell regarding the title to the Rockville house and lot and the payment of \$50 for the use of LaRoche's new steamer to float the house around to New Cut Plantation, located on the other side of Wadmalaw. He needed it done as soon as possible because he had to get his cotton picked. The third hall was then built on this property, and the surrounding marsh was filled in for parking.
