SIGNIFICANT COMMAND/MANAGEMENT EXPERIENCE OTHER THAN SHIP COMMANDS:

November 1945 - January 1948: Assistant Director Congressional Liaison,
Department of the Navy, Washington, D.C. Coordinated handling of all Navy
Department correspondence, telephone inquiries, special projects, etc., with
both Houses of Congress, The White House and other Executive Departments.

July 1960 - November 1963: Executive Assistant to the Assistant Secretary of the Navy for Installations and Logistics. This office was responsible for management and policy direction of all Navy procurement, ship construction, real property construction, contract administration, etc.

September 1965 - June 1967: Commanding Officer, U.S. Naval Destroyer School with staff of 77, student body of 180 Lieutenants (junior grade)/Lieutenants and 100 enlisted. Responsible for complete management of school including curriculum development, discipline, plant maintenance.

November 1968 - January 1970: Commander, Mine Force, U.S. Atlantic Fleet with staff of 100. Responsible for command, training, logistic support of seventeen minesweeps, numerous small minesweeping craft, and 2,000 personnel.

January 1970 - July 1971: Commander, Cruiser-Destroyer Force, U.S. Pacific Fleet with staff of 300. Responsible for command, training and logistic support of 200 destroyer and cruiser type ships, plus six destroyer tenders, with a total of 47,000 personnel.

August 1971 - July 1972: Deputy Chief of Naval Personnel, Washington, D.C. Responsible for management of Bureau of Naval Personnel with 1065 military personnel and 1300 Civil Service employees. Participated as the Deputy Chief in the policy development and management of Navy-wide Personnel programs, including personnel procurement, training, distribution, discipline, promotion and retirement. Acted as Congressional witness in support of various pieces of personnel legislation.

July 1972 - January 1973: Commander SECOND Fleet/Commander Striking Fleet, Atlantic (NATO). This is the principal operating fleet in the Atlantic area, and the command is responsible for the command and conduct of all major fleet operations including joint operations with Army and Air Force forces. The Commander serves concurrently as Commander of the Striking Fleet and is responsible for all major Atlantic fleet operations under NATO. The size of the fleets varies depending on the forces assigned for any particular operation. This SECOND Fleet is one of four major operational fleets of the U.S. Navy. (FIRST, SECOND, SIXTH and SEVENTH).

January 1973 - August 1975: Deputy Commander in Chief and Chief of Staff, U.S. Atlantic Command and U.S. Atlantic Fleet. With and for the Commander in Chief, responsible for management and operation of U.S. Navy forces in the Atlantic Fleet and of forces of all other U.S. Armed Forces for Joint exercises and in time of crisis. Directed both day-to-day functions of, and long range planning for, these forces which consisted of approximately 315 ships, 168,300 military and civilian personnel.
