1762 December 25. Advertisement in the South Carolina Gazette
The subscriber intending to open a Boarding and Day SCHOOL for young ladies, as soon as a proper house can be had, gives this notice, that, for the full discharge of her duty to the young ladies, she limits her number to Twenty boarders, Two assistant-boarders, and Ten day scholars. - 1672 The Grand Model of Charles Town was ordered laid out on Oyster Point. On it Lot #193 had a frontage covering present day #73 and #75 King Street and ran back to Orange Street. The oldest existing copy of this model, as reproduced in the South Carolina Historical and Genealogical Magazine Vol. IX, shows this as #195, but records in the Mesne Conveyance Office plainly show this to be an error.
- 1694 May 9, Lots #193, #194, and #195 were granted to John Hill, Glover.
- 1753 At some unknown time John Hill sold a portion of #193 to Miles Brewton, the elder. This seems to have been the properties that are now 73 King Street and 98 Tradd Street. July 20, 1753, Robert Brewton sold this land to William Elliott, who previously had obtained the land that is now 75 King Street. RMC O Bk. PP page 73.
- 1729 That Hill, or some of his family, had owned this northern portion of the lot until 1729 is shown in the conveyance of Jonathan Drake to Elias Hancock of a southern portion of Lot #194 (just north of #193) which gives a south boundary on Hill RMC O Bk. L.P. 98.
- 1765 William Elliott willed "Houses and land on King Street, now in occupation of Mrs. Mary Stokes, Schoolmistress," to his wife Sabina (Codner) Elliott. Probate Court Will Book 11, p. 171.
- 1784 Sabina (Codner) Elliott leaves her estate to her son-in-law, Col. Lewis Morris, who in 1783 married Anne "Nancy" Elliott,

in trust for her daughters, Anna Elliott Morris and Sabina,
known as Binkie Huger, the wife of Daniel Huger. Will proved
30 Dec. 1793. Probate Court Will Book 25, p. 238.

- 1802 Binkie Huger Will, made 15 October, 1786, to trustees for her
children, was proved February 17, 1802.
- 1827 Sept. 11. Commissioner in Equity deeds to Simon Magwood, Trustee,
lot at corner of King and Tradd that seems about to cover the
premises of #73 and #75 King Street. This is at the suit of
Daniel Elliott Huger, son of Binkie, and the aforementioned Lewis
Morris and his wife, Anne, to clear up an incorrect deed to the
property from William Hasell Gibbes, Master in Equity, to William
McElmoyle.

CONCLUSION concerning house. The oldest houses along this
portion of King Street that now exist appear to have been
built from about 1750 forward. The indication that William
Elliott bought this property at #75 some time after 1729 and
enlarged it by further purchase in 1753 would show an interest
in it that probably produced the big substantial house some
time, probably just a bit before that date or not too long
after it.
