Just wanted to update you on my research progress of 114 St. Phillip! Sadly I have not uncovered ANY pictures...but I have found some other information.

The Gibbes Museum archive does not have any information on properties that far up, so my next stop was the Charleston Library Society. The librarians directed me to the Charleston City Directories. These books were published every year or two years.

Beginning in the 1914 book I looked up the family name, and for the store's listing under "hardware" in the back of the book. I was able to find the family name, but never once did I find the store listed under "hardware". Finally in 1940, along with the family's name it made a reference to an advertisement. I have printed this advertisement that lists the store under "fuel" and not "hardware". With this information I went back to the books beginning in 1914, but never once found the store listed under "fuel" either. Strangely the first mention of the store I could find was in 1940.

Here I have copies of the Westendorff listing in 1915, 1918, and 1940, and the store advertisement in 1940.

I plan to continue my search at the S.C Historical Society and the S.C. Room at the public library! I'll keep you posted.

Also, I was able to find Clarence W. Westendorff's (of C.W. Westendorff and Sons) death certificate. I have attached copies here; it is of interest because it lists his occupation as "retired merchant" and the store name. I found this by logging onto my mother's ancestry.com account.

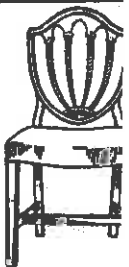
