The background narrative will provide a historical overview of the development of the survey area and should emphasize and logically interpret the circumstances under which the area was shaped and developed. It must include a description of the historic resources identified. It should be brief, concise, and based on scholarly research with sources identified. It should also cover the following topics:

- A. geographic setting and characteristics (location, topography)
- B. background history (Indians, early settlers, origin of name)
- C. establishment (incorporation, population, original development)
- D. government (government buildings such as county courthouses, city halls)
- E. economic history (agriculture, industries, and commerce)
- F. transportation (roads, railways and waterways)
- G. military history
- H. religion (churches)
- I. education (schools, libraries)
- J. ethnic or minority heritage (immigrants, blacks)
- K. entertainment and recreation (theaters, fairgrounds)
- L. social activities (organizations, newspapers)
- M. landscaping (parks, tree-lined streets, medians)
- N. important builders or architects
- O. events peculiar to the area (celebrations, anniversaries, festivals)

10. Footnotes and Bibliography.
11. Properties in the Survey Area that are Listed in the National Register.
12. Evaluation of Survey Data.

This should include properties potentially eligible for the National Register and the National Register areas of significance as specified in "National Register Bulletin 16: Guidelines for Completing National Register of Historic Places Forms." Eligibility will be based upon National Register criteria. The list of potentially eligible properties will be reviewed by the SHPO before becoming part of the final survey report.

13. Data Gaps.
14. Compiled Inventory.

The compiled inventory should include the topographical quad number, site number, address or location, the historic name or common name of the site, the type of resource, and the date of construction.

15. Recommendations.

The Survey Report concludes with recommendations for future historic preservation activities in the area and the identification of potential threats.

This letter is an attempt to relieve some concerns and misconceptions which Council members may have concerning the requirements for the substantial grant offered by the S.C. Department of Archives and History. This grant would cover a significant part of the cost of an architectural and archaeological survey of rural Charleston County.

The process involved includes qualifying the County Government as a Certified Local Government and creating an historic district or landmarks commission. If there is concern on the part of Council that this commission would have to be granted power and authority comparable to that given the City of Charleston's Board of Architectural Review, such is not the case. On the contrary, the commission would have only such power and authority as Council allotted it. While there are state and federal regulations relating to such commissions, they are broad and leave considerable latitude for Council to design its own package. The primary regulations are that:

1. The Commission must consist of a minimum number of members
2. Where available, one member must have a background or interest in local history and a second member should meet the same qualifications in archaeology
3. The commission must have the right to comment on sites within its jurisdiction that are nominated for inclusion on the National Register of Historic Places, and
4. The commission must operate within a set of guidelines prescribed by County Council.

Geographically, the County encompasses an area rich in pre-Columbian, Colonial, Revolutionary, post-Revolutionary, and Civil War sites which are an important record of our past. Many of these sites are not a matter of public record; as a result, some have been lost -- most recently the Revolutionary fort at Stono Ferry. Unless all remaining sites are identified and catalogued, others surely will disappear. We urge Council to take advantage of the opportunity to accomplish this and to do so at a bargain rate. If Archives and History were to come in at their maximum grant level, as they appear willing to do, and if Historic Charleston Foundation were to contribute toward the cost, which they are willing to do, the County's share could be as little as 15% of the total. In return, the County Planning Staff would have information on hand that would enable it to respond constructively to land use proposals whether they be for public rights-of-way, utility easements, commercial or residential development, recreational areas or public parks.

Charleston County would not be the first to receive designation as a Certified Local Government. Horry County, which probably is under as much developmental pressure as any area in the state, is one of several counties that already have qualified as Certified Local Governments. Charleston County is the oldest governmental entity in the state and one of the most enlightened, and as such, it would be entirely appropriate to add its name to the list of Certified Local Governments. We request that you support this effort to save what survives of our past.

SUBJECT: SELECTION OF CONSULTANT FOR COUNTY-WIDE INVENTORY OF HISTORICAL, ARCHITECTURAL AND ARCHAEOLOGICAL RESOURCES

DATE: DECEMBER 18, 1990

In September, 1989, Council authorized staff to seek a matching grant from the S.C. Department of Archives and History (SCDAH) for the purpose of hiring a Consultant to conduct an inventory of historic, architectural and archaeological resources in Charleston County. The grant application was submitted in February 1990, and we received a \$50,000 grant award from SCDAH in April 1990. Project design, methodology and timetable were then developed, and a broad-based citizen committee, representative of the project sponsors and other county-wide land use community and preservation groups, was selected to choose a consultant.

The RFP was issued in October with two responses received prior to the November 15, 1990 deadline, - Preservation Consultants, Inc., of Charleston (\$68,500), and New South Associates of Stone Mountain, Georgia (\$57,791). On December 10, 1990, the Selection Committee heard presentations from both Consultants. The Committee's choice, by a vote of 10-3 (with two absent), was Preservation Consultants, Inc. (see attachment for Selection Committee and Selection factors).

Unless there are any objections, we will now begin contract negotiations with Preservation Consultants, Inc., with an anticipated project start-up date of January 15, 1991.

I hope this finds you well. This letter is written to update our sponsors on the progress of the Countywide historic survey, and to solicit your participation and support in upcoming meetings.

After receiving the nod from our blue-ribbon citizen selection committee, Preservation Consultants Inc. of Charleston began work in January. Thus far they have done preliminary archival research, and have begun field survey work on Wadmalaw and Edisto Islands. The remainder of Phase I (through September) will be spent in field work on Edisto, Kiawah, and Seabrook Islands, and along Ashley River Road (Hwy 61). **HIDDEN HISTORY:** A new list of 700 local sites will help county officials and residents know what's worth preserving.

A new survey of Charleston County's countryside lists more than 700 sites of historical importance, and experts said the list may help the significant locales survive.

"This is a real cause for celebration," senior county planner Steve Dykes said. "We have heard about historic sites in jeopardy, but it's been hard to respond to those concerns because we had such a murky idea of what was out there."

Much of the county — including peninsular Charleston, Mount Pleasant, Sullivan's Island, James Island and John's Island — already has been surveyed for historic and architecturally significant sites.

The new survey — recently released to County Council — concentrates on the more rural areas. It includes 38 properties already on the National Register of Historic Places, and it found another 70 properties that may qualify for the register.

The survey also includes the historic districts of McClellanville and Rockville, and it found that Adams Run, Meggett and parts of Edisto Island also may qualify as historic districts.

Of the approximately 770 sites found, most are residences of some sort. However, schools, cemeteries, churches, farm houses, roads and other sites also made the list.

Approximately three-fourths of the sites are in the unincorporated area, while 180 of the 770 sites are inside towns or cities.

The survey was more than two years in the making and began after residents in several rural areas asked the county for help protecting their historic sites, Dykes said.

The continued sprawl of Charleston County's urban and suburban areas pose the greatest threat to many historic sites, the survey found. "Increased population in rural areas tends to result in widened roads, new commercial zones and ostentatious architecture, and the principal threat to historic resources is usually defined as 'development,'" the survey says.

Having the list of historic sites will help planners and property owners know what's worth preserving, said Lawrence Walker, president of the Historic Charleston Foundation.

"I think as a planning tool, it can save embarrassment, it can save time, and it can save sites," Walker said. "We've had problems already with some Civil War fortifications we've mangled and done away with. Given the importance of historical preservation to the tourism industry, Walker said, it makes sense to protect historically significant areas outside the city of Charleston. "I think preservation can only increase its importance economically. It's clean and it provides a considerable job base."

Being listed in the county survey is strictly an honor and does not restrict the property owner. Even a listing on the national register doesn't offer much protection, although it becomes relevant if a federally funded project may affect the site.

However, Walker said, "people like to have their possessions recognized as having historic value, and a listing on the register is something very many people would be very pleased to have."

The survey recommends that the county notify the owners of historic sites to inform them that they may qualify for the National Register. And beginning next week, the county also is planning a series of six public hearings to show the survey results to the public.

The first of those hearings is set for Nov. 10 at McClellanville Town Hall; the second for Nov. 17 at Edisto Island Community Center; and the third for Nov. 23 at St. John's High School. All hearings will begin at 7 p.m.

The county also plans to hold hearings in the St. Paul's area, in the Highway 61 area, and in the Mount Pleasant-Awendaw area, county planner Joe Heard said.

"We'll hope to learn what people feel about these historic sites — how much they value them and what they want to do to protect them," Heard said.

Dykes said the planning staff will look at new ways to give additional protection to the sites.

However, he said it's premature to speculate on what kind of preservation ordinance County Council may be asked to consider. "We've been asked to look at the full gamut of those kinds of things," he said.

Preservation Consultants Inc., a private consulting firm, handled much of the \$102,500 survey.

The Historic Charleston Foundation, County Council and the municipalities of Charleston, Ravenel, Klawah and Seabrook each contributed funding or services to match the state grant of \$5,250.

Also, the Preservation Society of Charleston and the S.C. Institute of Archaeology and Anthropology do.

# Plans to be unveiled to protect historic buildings, sites

The Charleston County Planning Department will unveil its efforts to protect historic structures and sites at upcoming meetings of citizen's groups from Wadmalaw, Edisto, Kiawah and Seabrook islands.

The county has hired Preservation Consultants Inc. of Charleston, which will attend the meetings, to survey about 1,200 sites in 736-square miles. But the county needs to meet with citizen groups to best determine if new laws are needed to protect the sites, said J. Steven Dykes, senior planner with the county.

Laws may not be needed to protect historic sites. Rather, review boards may determine whether a developer can disturb a historic site, Dykes said.

"I think the mere knowledge of where

they (sites) are will protect them from people who might upset them inadvertently," he said.

"We want to get a good sense at each one of those meetings of what kind of issues are on the community's mind in terms of historic resources and the protection of them," he said.

After the meeting, Preservation Consultants will ask residents to share information about historic sites in their neighborhoods.

The consulting firm will use various techniques, such as archival research, site inspections and resident interviews to identify

The firm began its research in January and moved to the field, starting on Wadmalaw Island, in March. In phase one of the project, which will continue through September, the firm will survey the western Seabrook and Edisto islands and the Highway 61 Corridor.

Phase two, which will end a year later, will focus on the eastern and northern parts of the county. Meggett, Hollywood, Ravenel, Lincolnville, McClellanville, Folly Beach and the eastern portion of the county from S.C. Highway 41 east to the county line will be studied in phase two.

Upon completion, the firm will provide the county with topographical maps that

identify historic structures and sites by par-

ticular site, a written report that

categorizes sites and highlights major

trends in county history and their relationship to the structures and sites.

The survey is the upshot of various citizen land-use groups that advocated as early as 1983 the preservation of historic sites, Dykes said.

By 1989 "the local historic groups threw their weight behind it also," he said, and Charleston County Council instructed its staff to seek grants for a historical survey.

In April 1990, the S.C. Department of Archives and History granted the county \$50,000 to be disbursed over two years. County Council, Historic Charleston Foundation, City of Charleston, Town of Ravenel, Seabrook Island, and Kiawah Island contributed \$32,500. The Preservation Society of Charleston has donated technical assistance.

James and John's islands' historical sites

were surveyed by the same firm for the

county in 1989. St. Andrews Public Service District will be included in the archival map-and-plot research because of its old suburbs, such as Byrnes Downs and The Crescent, Dykes said.

"They're going to do enough research on the St. Andrews area to give a future consultant a starting point to actually do a detailed survey," Dykes said.

"There are certainly some things to be looked at there, but it was beyond the scope of this project in terms of time and resources," he added.
