


30 Blake Street (two-story house) – Front façade



30 ½ Blake Street (one-story cottage) – Front Façade









Philip Simmons' Workshop -- Front Façade



30 & 30 ½ Blake Street Timeline

- Approximately 1820: Thaddeus Sobieski purchased lot 90 in Hampstead, which included 30 Blake Street.
- 1825: David Ball purchased a parcel of land in trust for Rebecca Bell Payne.
- **1876: A two-story wood building was constructed at 30 Blake Street by the Payne-Gruber family.**
- 1917: Mamie Margaret Bevis purchased 30 Blake Street then sold it to Kate Welch one month later.
- 1921: Kate Welch sold 30 Blake Street to John A. Rink, who then sold it to D. W. King
- 1944: D. W. King sold 30 Blake Street to Elizabeth H. Brown.
- **1946: A one-story frame dwelling was constructed at the rear of the lot.**
- 1959: Elizabeth H. Brown sold 30 Blake Street to Philip Simmons.
- Approximately 1959: The property was divided into two, 30 Blake Street and 30 ½ Blake Street.
- 1959-2007: Philip Simmons maintained both 30 and 30 ½ Blake Street, adding multiple additions to 30 ½ Blake Street.
- **1967: A workshop was constructed on the rear of the property.**
- 1992: The Philip Simmons Foundation was formed.
- 2007: Philip Simmons sold 30 Blake Street to his grandson, Elmer Gilliam, for \$10.00 and “love and affection.”
- 2008: The Philip Simmons Foundation purchased 30 ½ Blake Street from Philip Simmons for \$500,000.

History of 30 & 30 ½ Blake Street

Around 1820, Thaddeus Sobieski purchased several lots in the northern part of Hampstead. In 1825, he sold a large parcel of land that included 30 Blake Street to David Ball in trust for Rebecca Bell Payne. Rebecca and her husband, Robert Keith Payne, passed the property to their daughter, Maria Torance Payne Gruber, and her husband, George H. Gruber. When George H. Gruber passed away, 30 Blake Street passed to Maria and their son, George W. Gruber.


According to the 1870 *Ward Books Tax Assessments*, 30 Blake Street was vacant, and by 1876, a two-story wood building had been constructed, according to the 1876-1879 *Ward Books*. Shown on a city plat in 1882, a one-story addition was added on the north-east corner. Later, a larger addition across the entire northern length of the house was added and differentiated from the original hip roof by its shed roof.

The property was sold to Mamie Margaret Bevis in 1917, who then sold the property to Kate Welch one month later. In 1921, Kate Welch sold the property to John A. Rink, and in 1944, Mr. Rink sold the property to D. W. King. Between 1917 and 1944, the property experienced many changes, including the removal of a rear stable and outbuilding sometime before 1929 and the addition of an auto garage built before 1944.

Starting in 1944, the property was repeatedly sold between Elizabeth H. Brown and Adele C. Brown. During this time, the house was used as a single-unit rental. In 1946, Elizabeth H. Brown pulled a building permit to build a one-story frame dwelling in the rear of the lot, intended to be a one-family dwelling with two rooms.

Philip Simmons purchased 30 Blake Street for \$7,350 from Adele C. Brown, and it was around this time that the lot was divided into two properties, 30 Blake Street and 30 ½ Blake Street. 30 Blake Street was split into a duplex, and Mr. Simmons rented it out. During his ownership, Philip Simmons maintained maintenance on the property, including repairs, the addition of a gate in 1977, and the addition of a concrete path leading to the porch of 30 Blake Street. A bathroom addition was added either shortly before or during Philip Simmons' ownership due to the splitting of the house into a duplex. In 2007, a permit was approved to build a bathroom addition on the rear of 30 ½ Blake Street, as well as a ramp to access it. Another addition was made on the rear of the building, and an office was added to the side of the front porch.
