

# **A Study of the Development of 158 Church Street**

Charleston, South Carolina

The property located on the northeast corner of Church Street and Cumberland Street, presently known as 158 Church Street, has had several functions from private residences to Charleston's first Irish bar, to its current function as an Italian restaurant, Bocci's, since the beginning of Charleston's development. This property, known as Lot Number 218, according to the Grand Modell laid of Charleston laid out in 1680, is located on one of Charleston's original streets. When St. Phillip's moved to its current location in 1710, the street became known as New Church Street, but soon "New" was dropped and it simply became Church Street. While Cumberland Street, as it stands today, was not one of the original streets laid out in the early development of Charleston, another street known as Amen Street, existed in a similar location.

According to the Grand Modell of Charleston, laid out by Henry A. M. Smith, Joseph Pendarvis was granted lot 218 on March 20, 1694, as well as lot 217 next to it.<sup>1</sup> Joseph Pendarvis is thought to have come from a family from the community of "Pendarves," in the Parish of Camborne, in Cornwall, England. Pendarvis was a captain in the provincial militia and joined the Sayle Colony of Barbados in 1669. Pendarvis arrived in Port Royal on the "First Fleet" on the *Blessing* with his soon to be wife, Elizabeth Stonehall, a widow, and her daughter, Priscilla, on March 17, 1670. On July 2, 1672, Pendarvis was granted Lot 45, and in 1682 he was granted Lot 66. On March 20, 1694, William, Earl of Craven, Palatine, and the Lords Proprietors, by grants signed by landgrave Thomas Smith, granted Lots 217 and 218 to Joseph Pendarvis.<sup>2</sup>

Joseph Pendarvis was a captain and a planter, and he and Elizabeth had a son, John, and two daughters, Mary and Ann, as well as Elizabeth's daughter, Priscilla. Pendarvis was one of the receivers of funds raised for an expedition from Carolina against Spaniards at St. Augustine under the Act of the Assembly of South Carolina on October 15, 1686. He was also on a committee in charge of the preparation of a bill which originated the present day method of drawing jurors. Furthermore, in 1693 he was on a committee that considered a method for drawing up a system of government and a form for the granting of land. In 1693 he was elected as a member of the Colonial Assembly and during the same year was also elected Justice in the Commission of the Peace.<sup>2</sup>

In his will dated November 19, 1694, Joseph Pendarvis granted his son "a house at Charles Towne," his daughter Mary, "one other house of mine at Charles Town," his daughter Ann, "my brick house and one other house standing by it at Charles Town, together with one Lott and a half, belonging to the said house." The will also states that he "likewise give unto my said daughters Mary and Ann my other Two Lotts in Charles Town, fronting the Lotts of M. Brutell, to be equally divided between them both." By studying the Grand Modell, it is likely that the two lots Pendarvis speaks of are Lots 217 and 218, as they front the lots of M. Brutell. Through examining the will and inventory of Joseph Pendarvis it is clear that he became a very wealthy man in Charleston. Listed in the inventory of Joseph Pendarvis were twelve slaves, three plantations, four town lots, three houses, numerous farm animals, and household furnishings including brass and silver.

According to a deed dated July 27, 1697, Mary and her husband, Giles Titmarsh, a shoemaker, and Ann and her husband, William Carlile, a tanner, mutually agreed that Giles and

Mary would take the south lot 217 and that William and Ann should take the north lot 218 as their part. On August 25, 1697, William and Ann Carlile conveyed lot 218 to a merchant, Jonathan Amory, in which Mr. Amory already owned the land west of lot 218.<sup>3</sup> The deed also states that the conveyance of the property includes the “buildings, ways, paths, passages, water, woods, etc.” This statement shows that there were in fact buildings on the property, but whether or not they were residences or possibly a place of business is uncertain. Since the inventory of Joseph Pendarvis lists “the housing and land where Joseph Pendarvis lived in” as being separate from the two lots in Charleston town, it is not likely that Pendarvis lived on buildings located on Lots 217 or 218. Also, since William and Ann Carlile did not own the property for longer than a month, it is not likely that this would have been their place of residence either. However, in his will, Joseph Pendarvis mentions his houses where other persons “now dwelleth,” and have rent due to him. It could be possible that the buildings on Lot 218 could have been houses Pendarvis owned and rented for a residence or a place of business.

— In his will dated November 2, 1697, Jonathan Amory appointed his wife sole executrix of his estate and authorized her to sell any part of his real estate. After her death Amory appointed their two sons, Thomas and Robert, to handle his estate. Martha died shortly after Jonathan, as did their infant son Robert. Since Thomas was in England at the time, Martha appointed her “dearly beloved friend Sarah Rhett, wife of Captain William Rhett of Charles Town” Exexutrix of her estate. According to a deed dated March 30, 1709, Sarah Rhett convinced the General Assembly that in order to pay debts, etc., that the estate should be sold, otherwise “the estate would run to decay & become a great charge to hold till the heirs came of age.” On March 1,

1700, Sarah was appointed administratrix with power to sell the estate with the advice and consent of Job Howes and Ralph Izard.

On March 30, 1709, Sarah Rhett conveyed Lot 218 to a joiner, Thomas Stewart. In his will dated March 17, 1721, Thomas Stewart bequeathed all of his real and personal estate to his wife Ann, and then to his four children, Thomas, Mary Ann, Susannah, and William, to be divided equally. On April 2, 1741, Thomas Stewart and Thomas Heathy, a shipwright and husband of Susannah, convey to Arthur Nash, a mariner and husband of Mary Ann, the northern part of Lot 218. On April 16, 1741, Thomas, Susannah, and Mary Ann and Arthur Nash conveyed the middle part of 218, to John Steel, a tavern keeper. On February 20 and 21, 1744, John Steel and his wife Mary conveyed Lot 218 to the Honorable Joseph Wragg, Esquire. On July 7, 1750, Arthur and Mary Ann Nash conveyed the northern part of Lot 218 to back to Thomas and Susannah Heathy.

A plat of Church and Cumberland Streets from November 7, 1835, shows Sarah Farguharson as owning Lot 218. On August 13, 1838, Sarah Farguharson surrendered her title to part of Lot 218 to the City of Charleston for the proposed new street called Cumberland, previously Amen Street.<sup>4</sup> The following plat shows the yellow lines as being the proposed street and the red lines as being the ones actually constructed for the new street. Through this plat it is clear that while the property belonging to Sarah Farguharson, Lot 218, was once on the south side of Amen Street, it is now on the north side of the Cumberland street and on the east of Church Street, which is as it stands presently.

On August 10, 1854 John Molony, a native of Ireland, purchased the property. Four small brick buildings on the lot were destroyed in the fire of 1861.<sup>5</sup> John Molony died in 1865 and the lot remained vacant until it was conveyed from his estate to his wife, Mary, on September 10, 1867. A mortgage dated March 14, 1868, describes the property as having buildings on it, indicating that Mary had improved the lot since the property had been conveyed to her. The present structure, constructed between 1867 and 1868, was originally built as a combination of a business and a residence, with a grocery store on the first floor and the family home above. The Sanborn Fire Insurance Map of 1886 shows a two story brick structure with a two story frame structure attached, along with a kitchen. James Molony, the son of John and Mary, operated a grocery store and saloon on the ground floor, and the saloon became known as Charleston's first Irish bar. During statewide prohibition in the 1890's the bar was secretly moved to the back room of the grocery store and was called a "café."<sup>5</sup> James Molony operated the family business until he retired in 1910. The Molony family owned the property until 1919, then the property was leased to several different businesses. On January 25, 1990, the property was conveyed to its current owner, Betty S. Mornier. The ground floor now operates as an Italian restaurant, Bocci's, while the remaining floors function as apartments.

The present structure is a three story brick building with a two story kitchen wing, as well as a double piazza above the first floor on the left side of the principal facade. The building reflects the Greek Revival influence in Charleston during the mid-19th century. The Church

Street facade retains its original storefront with four segmental-arched openings. The interior has plain mantels, woodwork, and simple beading and molding.<sup>5</sup>

Since the early development of Charleston this property has had a rich and diverse past. It has undergone significant changes from earthquakes, fires, openings of streets, etc. that have shaped how it exists today. The present structure is a great example of architecture in Charleston during the mid-19th century, and it continues to be a well functioning, well preserved structure that greatly contributes to the atmosphere of historic downtown Charleston.


