Scope and Content of Collection*:

The Aiken-Rhett Collection contains a multitude of items that pertain to the lives and business of the collective family members through the nineteenth and first half of the twentieth century. Its 94 boxes, books, and lock drawer have been arranged into twelve (12) series, including a lengthy "Miscellaneous" grouping. Extra care has been taken to organize that grouping in like kinds with extensive finding aid notations to aid researchers.

- 1817 built for John Robinson
- 1825 property released to Charles Edmundson, William Aiken, Sr., and Lewis Petroy to settle debt, eventually acquired by Aiken as sole owner
- 1831 death of William Aiken, Sr., house passes to widow, Henrietta Wyatt Aiken, and son, William Aiken, Jr. (Governor), who makes it his main residence
- 1887 death of William Aiken, Jr., house passes to widow, Harriet Lowndes Aiken, and daughter Henrietta Aiken Rhett
- 1892 death of Harriet Lowndes Aiken, Henrietta Aiken Rhett, previously widowed by A.B. Rhett, Sr., becomes sole owner
- 1918 death of Henrietta Aiken Rhett, house passes to her five children: W. Aiken, Edmund, Harriet, A. Burnet, and I'on
- 1949 I'on Rhett purchases others' shares of property to become sole owner
- 1951 death of I'on Rhett, house passes to his widow, Frances Hinson Dill Rhett
- 1975 Frances Hinson Dill Rhett wills property to Charleston Museum
- 1995 Charleston Museum sells property to Historic Charleston Foundation
