<u>Historic Charleston Foundation</u> Endangered Structures Survey

Purpose:

The object of this survey is to create an inventory of

structures at risk by 1) neglect, 2) decay, or

3) development and to protect these vulnerable buildings and monuments and to set priorities for their future care.

Typical Stages of Decay

- 1. <u>Vulnerable</u>: when a vacated or tired structure enters the incipient stage of decay creating the potential for accelerated decay.
- 2. <u>Risk</u>: when a structure displays accelerated decay. It can still be useable but requiring major work to prevent irreversible damage.
- 3. <u>Crisis</u>: when the decay has accelerated to a point where the investment required to stabilize the structure is more than the value of the structure.
- 4. <u>Loss</u>: when the decay of a structure is so far advanced it has entered decelerated decay and repair would require the replacement of a majority of remaining building fabric, effectively constituting a reconstruction.

Priorities:

- A Immediate risk of further rapid deterioration or loss of fabric.
- B Slow decay.
- C In fair to good repair, but no user identified or under threat of vacancy with no obvious new user.
- D Repair scheme in progress, and (where applicable) end use or user identified.
- E Risk of loss by threat of market demands or development.

Condition:

Very Bad refers to a structure where there is evidence of structural instability, structural failure or; major loss of roof covering resulting in significant interior deterioration; or where fire or other disaster has affected most of the structure.

Poor refers to a structure with masonry deterioration and/or a leaky roof and/or defective rainwater goods resulting in outbreaks of rot and general deterioration of building fabric; or where fire or other disaster has affected part of the structure.

Fair refers to a structure in need of minor repair or showing signs of deferred maintenance, but which is structurally sound.

Good means no significant repairs needed, structurally sound and weathertight

Occupancy: is recorded as vacant, part occupied, occupied, or unknown
