PARTIAL LISTING OF CONSTRUCTION PROJECTS

1884-5 Residence at 30 Mary Street built by **J.D. Murphy**, occupied by family by **1885**.

12 Jan. 1885 new railroad draw bridge completed at Drayton, over the Ashley River. The approaches on either side of the draw were built by Mr. **J. D. Murphy**, the superintendent of construction.

20 May 1886 **John D. Murphy** is building three residences, each 2 ½ stories on North side of Cannon Street.

9 July 1886 **John D. Murphy** driving piles for new rice mill on the Cooper River.

1888 Contractors **J. D. Murphy** and D. A. J. Sullivan completed the new Central Police Station for the cost of \$43,000.

1891-1892 **J. D. Murphy** was the builder-contractor for the building at 363 King Street for Poppenheim Hardware Store

Mar. 1892 **John D. Murphy** was awarded a contract for renovations to the Old American Hotel.

12 May 1892 **John D. Murphy** received the contract for building a Baptist chapel at the corner of America and Cooper Streets.

2 Mar. 1893 contractor **John D. Murphy** commenced work on the Unitarian Parish Home, Archdale Street south of the church.

16 Nov. 1893 or earlier “Architect” **John D. Murphy** hired to build three story stone and brick building for the Connelley’s Funeral Home at 309-313 Meeting Street.

16 Nov. 1894 **Mr. John D. Murphy**, chairman decorating committee has designed and will erect arch for the Pythian Fair at the Fall Festival.

20 Jan. 1897 Article on building for Hirsh-Israel Company at 275 Meeting Street, article stated fine work by contractor **J. D. Murphy**.

13 Oct. 1898 **John D. Murphy** advertises his professional services. Mentions latest works the floating docks of the Seashore road and the wharves and sheds for the company at Charleston and Mount Pleasant.

26 Sept. 1899 **John D. Murphy** awarded contracts to build two residences. One for Mr. W. Gregg Chisholm on East Battery and the other for Mr. W. M. Wallace at the corner of King and Ladson Streets.

John D. Murphy at his death owned dwellings at 14 Rutledge Avenue and 88 Radcliffe Street, which he might have constructed.

1888 Calhoun Day – 2nd division of parade included 150 members on the Mechanic’s Union No.1 under the command of President **John D. Murphy**.

Murphy** suggested the organization in 1868 and served as president 1883 **thru 1895** and was responsible for purchasing the Mechanic’s Union Hall at 424 King Street.

26 June 1899 Items stolen from the launch owned by **John D. Murphy**

1 July 1899 Mechanics Union No. 1 of Charleston to **J. D. Murphy** and others , trustees - property east side King Street for \$5

8 July 1899 John D. Murphy asking for discharge as executor of **J. B. Gist**

28 Aug. 1899 Sally Ann Murphy McLean, sister - died **28 Aug. 1899** in Charleston, SC, buried on Murphy lot, next to daughter **Margaret McLean**, Magnolia Cemetery, Charleston, SC, no marker

30 Oct. 1899 Filed to run as Alderman at Large from Ward 9.

11 Aug. 1899 John D. Murphy et al trustee sold premises on King Street for \$6,000.00 (Mechanic’s Union Hall)

26 Sept. 1899 John D. Murphy awarded contracts to build two residences. One for Mr. W. Gregg Chisholm on East Battery and the other for Mr. W. M. Wallace at the corner of King and Ladson Streets.

16 Nov. 1899 John D. Murphy again elected city Alderman from 9th Ward to serve **1900-1903**. Newspaper describes him as **Major John D. Murphy**, a well known contractor in Charleston. Ran far ahead of his competition.

14 Dec 1899 Alderman **J. D. Murphy** on City Commission for wood and brick buildings

28 Dec. 1899 sketch and article on **Alderman John D. Murphy**, reelected to City Council Ref: *Charleston News and Courier*

12 Apr. 1900 Carpenter's Union list of companies employing company men – **J. D. Murphy** on list

18 May 1900 listed as subscribing to Exposition with \$100 donation.

24 May 1900 Alderman **J. D. Murphy** Commissioner for bath houses

2 June 1900 John D. Murphy, Jr. died in Charleston, SC, cause of death, rupture of aorta aneurysm, hemorrhage - funeral from home at 30 Mary Street, death notice **4 June 1900** buried in Magnolia Cemetery, Charleston, SC – marker

NOTE: At time of death, Alderman **John D. Murphy** was on the following city government committees: Public Buildings; Wood and Brick Buildings; Fire Escapes; Claims; Steam Engines and Bath Houses.

5 June 1900 Laura J. Murphy asking for letters of administration **for John D. Murphy**, deceased Ref: *Charleston Evening Post*

9 June 1900 Federal Census Charleston, SC

John D. Murphey age 56, occupation contractor

Laura Murphey age 45

1900- 1902+ Summary of J. D. Murphy Probate Case #432, #22, dated 5 June 1900 – he died intestate – file consists of 74 documents.

Laura J. Murphy appointed administratrix with a \$4,000 bond
Adult children 21 and older: **Leila T. Murphy; Elizabeth Quincy; John D. Murphy; Thomas W. Murphy**

Infant children under 21: **Lila P. Murphy age 20; Florence Camile Murphy, age 16; Laura Vivian Murphy, age 13; Everett C. Murphy, age 9; and Lionel M. Murphy, age 7.** Guardian appointed to represent them.

List of personal property including bank account of \$468.45; one launch and small boat (sold for \$500.00); one sail boat; one horse; two mules; three buggies; rice crop on Spring Hill Plantation and other misc. items.

Stocks: Four companies – declared worthless

Notes due from various entireties: Carolina Yatch Club; son **J. D. Murphy, Jr.** and other parties –marked as good; others as worthless (two from **J. R. Mew**)

Real Estate: Dewees Island, consisting of 659 acres; a small Marsh Island west of Dewees Island, 75 acres; house on (#88) Radcliffe Street; house at 14 Rutledge Avenue (this house was occupied by **Rebecca Elizabeth Murphy Quincy, 1896-1899**); lot on Sullivans Island; Spring Hill Plantation (near Monck's corner, Berkeley County, SC, contained 735 and 56/100 acres.)

Dewees Island (659 acres) and the 75 acre Marsh Island were sold for \$2,200.00

House on Radcliff Street was rented out – sold at auction **10 July 1902**

House at 14 Rutledge Avenue was rented out. It sold for \$3,301.50

Lot on Sullivans Island sold for \$30.00

Spring Hill Plantation advertised for sale – Payment were made to workers and a watchman - no further info

NOTE: the family residence at 30 Mary Street was not mentioned in the Probate documents. **Laura J. Murphy** was still at 30 Mary Street in **1902**; had moved to 33 Smith Street in **1903**.

Deweese Island was under a one year lease dated **13 Apr. 1900** to **J. O. Milligan** "for the purpose of planting provisions and vegetables, also planting oysters and clams and cutting palmetto fans. The party of the first part to allow **John D. Murphy** of the second part 1/3 of the proceeds, the hogs on the Island to be taken care of and all that is penned and fatten, or caught for sale to be divided as above. The party of the second part reserves for his use the large two story building, the party of the second part to take care of same." This lease was bought out by the estate for \$90.00

7 Dec. 1901 cash distribution of \$102.03 were made to the children. **Lila P. Murphy** was listed as **Lila P. Rennie**.

3 July 1902 sale by public auction on **10 July 1902** property of **John D. Murphy** list of property to be auctioned:

Land and buildings on north side of Mary Street (#30)

Land and buildings on north side of Radcliffe Street (#88)

Plantation of land known as Spring Hill containing 735 and 56/100 acres in Berkeley County being on French Quarter Creek – (near Moncks Corner)
