I checked what's known as the Sanborn Maps and downloaded the maps for 1884, 1888, 1902, 1944, 1951, and 1955 for you so you can see the evolution of the property. I'm sending those to you via DropBox. You'll get an email with a link to the folder. Click on the link and download them to your computer. Please do this before August 17 when I will delete the folder.

From what I can see, that newspaper article may have been mistaken about it being associated with the bank at 16 Broad Street. A more thorough building history would be required to determine its true origin if you'd like the names of some professional researchers, I'd be happy to pass them on to you. But as to the question of what was next door, compare the maps to a Google satellite view and that should give you the answer.

Funny how a photograph can inspire curiosity!

She happened to be doing research when your email came in so I was able to get an instant answer from her!

Would you mind if I printed out the photo and added it to our photo files? If so, and so I can identify the photographer, what is your father's name and do you know if he lived there? The only thing in the property file is a newspaper article that indicates that the building may have been the carriage house of 16 Broad Street; that New York Life Insurance Co. had a branch office there in the 1950s; and that the pattern of the brick (Flemish bond) indicates the date of construction as antebellum or earlier.
