Introduction

Charleston is a city located on a peninsula on the southern coast of South Carolina. Along the East of the peninsula is a street running north to south, East Bay Street. In the 2014 Research Methods class of the Master of Science in Historic Preservation program of College of Charleston and Clemson University, students have taken a lot on East Bay Street and traced its chain of title and history. 194-196 East Bay Street is now a two-story building with a back parking lot, which Charleston Cooks inhabits now. The lot was once on the Grand Model plan of Charles Town now Charleston. When Carolina was establishing itself, the town of Charles Town began with a city plan with lots. The 194-196 lot is now between Cumberland Street to the North and Faber Street to the South. To the West is East Bay Street and to the East is another building and the Cooper River.

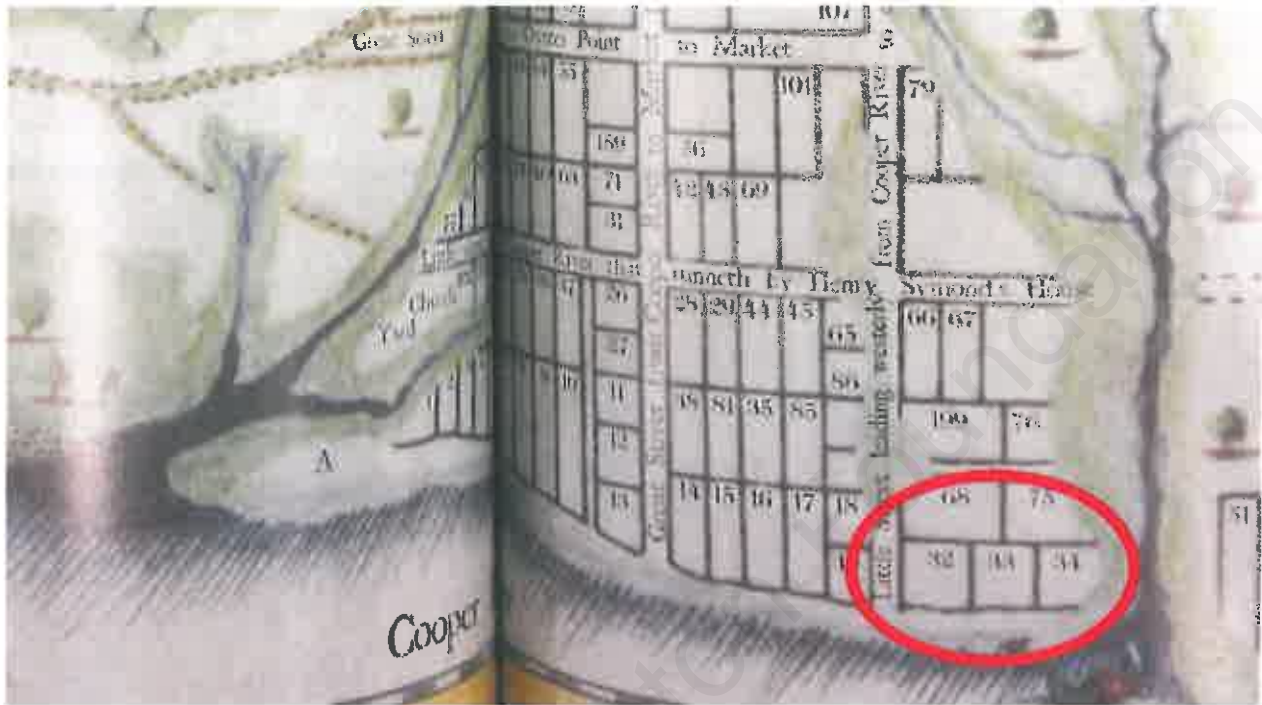


Figure 3: Grand Model, Proprietary Records

The Grand Model numbers are the original city numbers for the lots usually given by the Royal Crown. The area between East Bay Street and between Queen and

Market Streets was lot number 33.¹ The Grand Model Plat 1680-1700 (figure 3) shows the plat numbers with newer streets included to give an idea of where the lots would be today. The current 194-196 lot was between Gaillard St. and Faber St, which was completely underwater in the plan. As the land filled in and more wharfs are constructed, the lot develops into its own land lot. The first person to receive this lot was John Foster in 1678.² John Foster arrived in North America from Barbados before May 1672, was a member of the Grand Council, and was a Lord Proprietor's deputy.³ In 1693, John Foster "hath omitted and neglected to be built upon Contrary to the orders and the rules prescribed by the Grand Counsell [sic]: and by warrant dated 15 Feb 1692...I have laid out unto Capt. James Moore the sd [sic] same lot at Charles Towne known by the No. 33."⁴ John Foster did not build on the lot in the allotted time given by the Grand Counsel so the Governor gave the lot to someone else, Capt. James Moore. James Moore held many titles in Carolina such as Justice of the Peace, Lord Proprietor's deputy, Member of the Grand Council, Member of Commons House of Assembly and more.⁵ In 1700, Moore became the 17th Governor of the Providence.⁶ Two years after Moore acquired lot 33, in 1694; the lot was granted and deeded to Captain William Hewitt of Jamaica.⁷

Between 1674 and 1719, Robert Daniell purchased lot 33.⁸ In addition, on January 27th 1681 or 1682, Robert Daniell was given by a warrant, lot No. 34 by the Governor Hon. Col. Joseph West.⁹ Robert Daniell Sr., Lord Proprietor's Deputy and Landgrave, was married to Martha who later acquires the lot from her daughter-in-law.¹⁰ Robert Daniell died in 1718 and has a memorial in St. Philip's Church graveyard in Charleston.¹¹ In Robert Daniell Sr.'s will, the lots are given to Sarah Daniell, wife of Robert Daniell Jr.¹² The will also states that lot 33 and 34 are given to Martha, his own wife if Sarah dies.¹³ After Sarah's death, on April 16, 1719, the lots switch from Sarah Daniell to Martha Daniell.¹⁴ Also, in the Proprietary Records of South Carolina, a 1742 deed shows that part of lot 33 was owned by William Blakewey and Noah

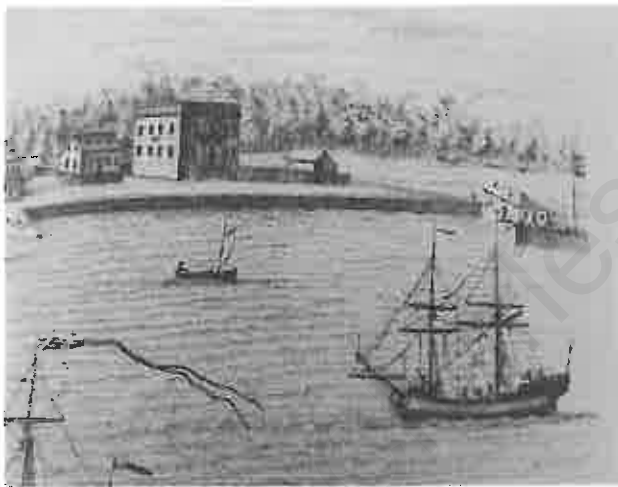


Figure 5: The Secretary's Office in the House of Mrs. Sarah Daniel Blakewey. 1739 engraving by William Henry Toms

Serre.¹⁵ In William Blakewey's will in 1727, he said Martha Logan, daughter of Gov. Daniell, gives him the land.¹⁶ Sarah Blakewey was William's wife and she was made executor of his property.

Mid to Late Eighteen-Century Property Changes

On January 27 and 28, 1742, Sarah Blakeway leased and released the land to Noah Serre.¹⁷ The lease and release still mention the Grand Model number, "...number 33 in the model of the said town on the Bay of Charles Town..."¹⁸ The east side of East Bay was still considered a low water mark, which means that it is part of the Cooper River and not solid land¹⁹

The northern part of lot 33 was William Blakeway's and he sold it to the Honorable Joseph Wragg Esq.²⁰ In the Register Mesne Conveyance book C4 on page 248, the description gives a chain of title. Lot number 33 was once William Blakeway's, then his executors sold the lot to Joseph Wragg Esq and John Dutarque occupied the southernmost part.²¹ Through the chain of title, the southern part of lot 33 was where current 194-196 East Bay is located. In the release from John Dutarque, the deed says Noah Sere gave his son Noah Sere the lot through his will.²²

Noah Sere (the son) departed from the Earth and so the lot passes on to his sister Mary Dutarque and husband John Dutarque.²³ On December 16, 1771, John Dutarque and Wife, Mary, leased and released the lot "all that flatt and shallow strand laying before the said part of parcel of the said lot #33 down to the low water mark" to John and Theodore Gaillard.²⁴ The parcel was

leased for five shillings current money and one ear of Indian corn after one-year lease.²⁵ When the property was released on December 17, it was for 10,000 pounds.²⁶ January 17, 1782 Theodore Gaillard leased and released to John Gaillard and Peter Porcher.²⁷ In this deed, the name of the wharf was called Wragg's Wharf.²⁸ This was the property on the east side of East Bay Street and was still labeled as a low water lot.²⁹ Usually the owner of a west lot on East Bay Street also owned the low water lot across on the east. The one-year lease was for two Shillings, and the release was for five Shillings.³⁰

Land Confiscation

The next transaction was a land confiscation. On January 8, 1782 the General Assembly of South Carolina's Revolutionary government met in Jacksonboro.³¹ Through January and February, they passed several Confiscation Acts.³² The Acts and the lists of names of loyalists were printed in Charlestown's *Royal Gazette* on March 20, 1782.³³ It was divided into six classes. Theodore Gaillard was listed in Class V, which was for "those who have borne commissions, civil, or military, under the British Government, since the conquest of this Province."³⁴ The Commissioner of Forfeited Estates leased and released the Gaillard's property to Alexander Gillon Esq. June 17, 1783.³⁵ The lot was described as "Wragg's Wharf, late the property of Theodore Gaillard, 110' on curtain line running to Cooper River, north on lands late

of John Scott (Son of Jonathan), south on low water lot late of Theodore Gaillard or John and Theodore Gaillard.³⁶ The property was leased for five Shillings, and released for 4,000 Pounds Sterling of Great Britain.³⁷

The Return to Gaillard

The Honorable Alexander Gillion did not have the property long and sold it three days later June 20, 1783 to John Vanderhorst for 4,500 Pounds Sterling.³⁸ The name Wragg's Wharf was still in the description but there was also a new name, Gaillard's Wharf.³⁹ John Vanderhorst's will was dated February 2, 1786 and he died before 1789. He stated in his last will and testament "...the remainder of my Estate I give and bequenth to be equally divided between my beloved wife Dorothy Vanderhorst and my beloved sister Sabinah Toomer the wife of Joshua Toomer Esquire to them..."⁴⁰ John Vanderhorst gives Sabina and her husband Joshua Toomer the parcel of land and wharf. Joshua Toomer and Sabina, wife, leased and released the land and wharf to Theodore Gaillard Jr.⁴¹ The water lot was leased for five Shillings Sterling and one year for Indian corn.⁴² The release was two Pounds, ten Shillings Sterling.⁴³ Theodore Gaillard Jr. built a house on the corner of Montague and ~~G~~adsden Streets and The Preservation Society has put up a sign at this property now called the Jefferson Bennett House.⁴⁴ Around

1800, Theodore Gaillard Jr. built the house, but it changed hands quickly after that.⁴⁵ According to the preservation plaque “From 1950-1951 the property was home to Palmer Gaillard, a direct descendant of the builder and a prominent man of Charleston.”⁴⁶

Nineteenth Century Property Changes

The property that was once lot number 33, then a parcel of land with a low water lot, to a wharf was becoming a piece of land on the east side of East Bay. Theodore Gaillard Jr. leased and released the lot to John Christopher Faber April 20 and 21, 1804.⁴⁷ In the Register Mesne Conveyance book M7 page 336 there was a plat (figure 9) showing the lines around the land

leased and released. It shows the neighbors, the wharf, and the streets. The yellow line around the brick stores and wharfs was John Faber's new property. John C. Faber was a pastor at St. John's Lutheran Church in Charleston from 1787 to 1800⁴⁸;

however, he was buried at St.

Philips. St. John's Church has close ties with the German Friendly Society, which was founded in 1766.⁴⁹ The Fabers were originally from Germany. John Christopher Faber's will and last testament showed the split between his two sons, Henry and Joseph Faber. Henry Faber inherited the South Range of John Faber's lot, which included a brick store, with East Bay on the west, the south was Faber Street, and the north was Gaillard Street.⁵⁰ Henry Faber has the

property until he dies between March 24 and 31 1839 at age 37 from fever typhus and was buried in the St. Philips Burial Ground.⁵¹ Joseph Faber was made Henry's executor⁵².

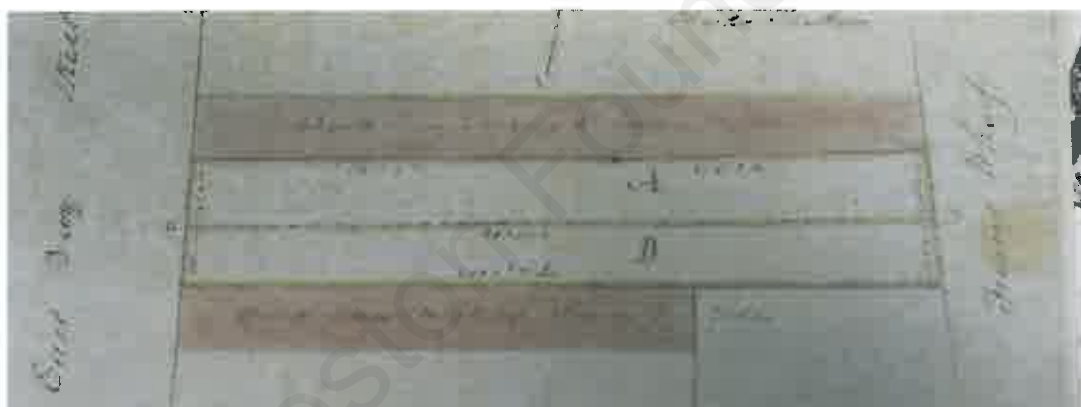


Figure 10: Mary Faber's Land was A and B, which turns into a pathway to the wharf

The wharf was still there and changes names throughout. Roads are starting to change and become roads instead of pathways. One example was when the Fabers own the land, they make a true pathway to the wharf. The plat (figure 10) with the two red rectangles and two rectangles labeled A, and B, was the forming Gaillard Street or now Cumberland Street. Their mother, Mary Faber, owned the land between John Faber's lot (above A) and Henry Faber's lot (below B) and it

was a pathway to the wharf.⁵³ 194-196 East Bay was starting to show through and become the lot it is in the twenty-first century.

In RMC book W12 page 407-409, Joseph Faber sold the lot to relieve debt March 2, 1853. The lot was sold to M.P. Matheson for \$30,000.⁵⁴ On July 17, 1876, the property went from M.P. Matheson to Master Clancey for public auction.⁵⁵ The reason for the sale was a foreclosure on a mortgage from 1871.⁵⁶ The auction takes place on July 31, 1879 and was sold to the highest bidder, George Witte and Trustees for \$8,100.⁵⁷ Along with Joseph selling the

land to Matheson, a plat was made by John Wilson, and is referenced often in future deeds.⁵⁸ At this time the building on the lot went from two three-story brick buildings to one one-story

building in 1880 under the ownership of Witte and Trustees.⁵⁹

The 1884 Sanborn Map (figure 12)

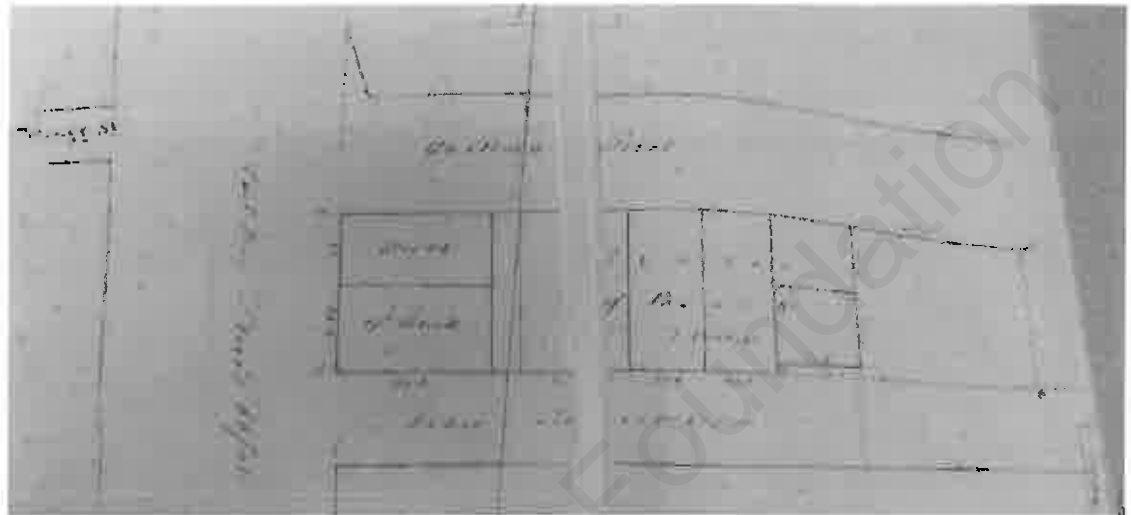


Figure 11: Y12 page 56 Plat describing lot sold at auction

shows the use

of the building was Ashely Phosphate Co. mixing room. The west side of the building was Keinet & Phosphate Storage Shed. The address was labeled at 126-128 East Bay between North Central Wharf Street and South Central Wharf Street.

In 1886, Charleston went through a strong earthquake that destroyed many

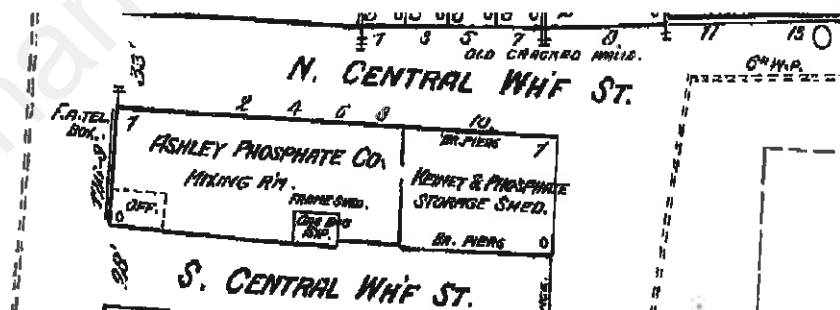


Figure 12: 1884 Sanborn Map

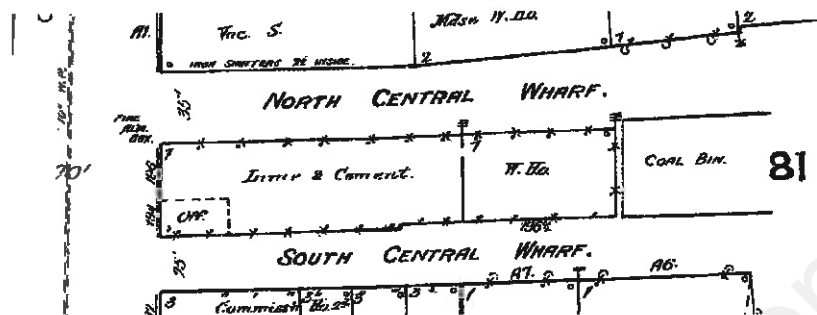


Figure 13: 1888 Sanborn Map

buildings. The earthquake

hit the city so bad, that the city surveyed buildings for damages and made a record. According to the 1888 Sanborn Map (figure 13), the uses of the building was for Lime and Cement. The building also had an office that was linked with the address number 194. The earthquake record

says C.O. Witte owned the property and used it as storage.⁶⁰ The brick building with a tin roof was in good condition after the

earthquake.⁶¹ George Witte was associated with the Witte Brothers of Charleston, who were cotton factors and commission merchants mostly on the South Atlantic Wharf. According to the Charleston City Directory for the years 1885-1886, central wharf, which was on the east riverside of 194-196 East Bay was used by cotton factors.⁶² John B Reeves, who later was Witte's executor, also was a cotton factor on Brown's wharf.⁶³ In addition, at this time in Charleston, a cotton textile mill was built in 1881 and was used as such until the early twentieth century.⁶⁴ It was the ideal time for Charleston merchants to be in the cotton business.

Twentieth Century Ownerships

The 1902, Sanborn Maps showed the use of the lot was Iron Works. It was a warehouse and storage; it could change uses quickly and for what was useful at the time. George Witte died on March 2, 1908.⁶⁵ The transaction was between John B Reeves and Earle Sloan Trustees, executors of the late George Witte, to Laura Witte Waring for \$5.⁶⁶ The Y12, page 56 plat (figure 11) was used to

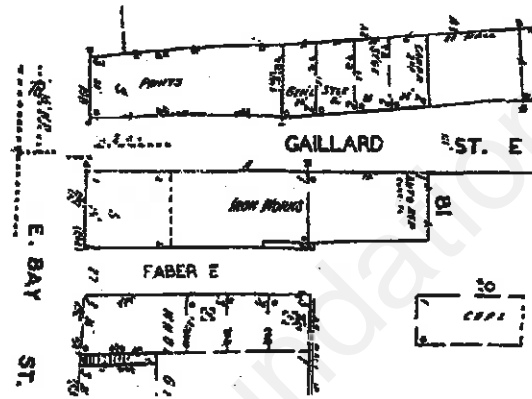


Figure 14: 1902 Sanborn Map

describe the boundaries for this transaction.⁶⁷ The description used in this conveyance was used for many following transactions for this lot.

The description is as follows:

“the southeast corner of East Bay Street and the Street leading to Central Wharf (across from Cumberland Street) in the City of Charleston and formerly known as No. 128, and now known as no. 194-196 East Bay Street, and more particularly described in a plan is extracted on an enlarged such shape and boundaries as are therein delineated, which said plan is extracted on an enlarged scale from a plan of the Wharf and buildings thereon situate on East Bay in the City of Charleston, belongs to J.C. Faber from the survey by John Wilson, which said deed with the plans is recorded in the office of the RMC for Charleston County in Book Y No. 12, pp 56-8.”⁶⁸

One picture shows one of the uses of the building while Laura Witte Waring had it. The picture is from 1944 and shows a one-story brick building with Parker's Poultry Store occupying it.⁶⁹ On April 3, 1964, Laura Witte Waring sells the lot to Nathan Addlestone for \$16,500.⁷⁰ In 1968, Addlestone was the president of Steelmet International and in 1976, he

owned Addlestone International.⁷¹ He moved around and had dealings in many companies. Nathan Addlestone then sold the lot to the Carasu Corporation for the “consideration of the issuance to the seller on one hundred sixty-five shares of common stock in Carasu Corporation to me in hand paid at and before the selling of these presents by Carasu Corporation.”⁷² Nathan Addlestone was the president of Carasu Corporation and the secretary was his wife Ruth Addlestone.⁷³ They use the same description of the lot given in the figure 11 plat.⁷⁴ The Carasu Corporation made a new plat July 5, 1966 that was used in their future transactions.⁷⁵ They split up part of the lot. On July 7, 1972, the Board of Directors Carasu Corporation sold the lot to Bevon International Inc. for \$100,000.⁷⁶ The description calls it 194-196 East Bay Street and

references the Y12 page 56 plat (figure 11). The Carasu Corporation conveyed a portion of the property to James S Fort in 1966.⁷⁷ Bevon International Inc. John E Bevon, were Custom House

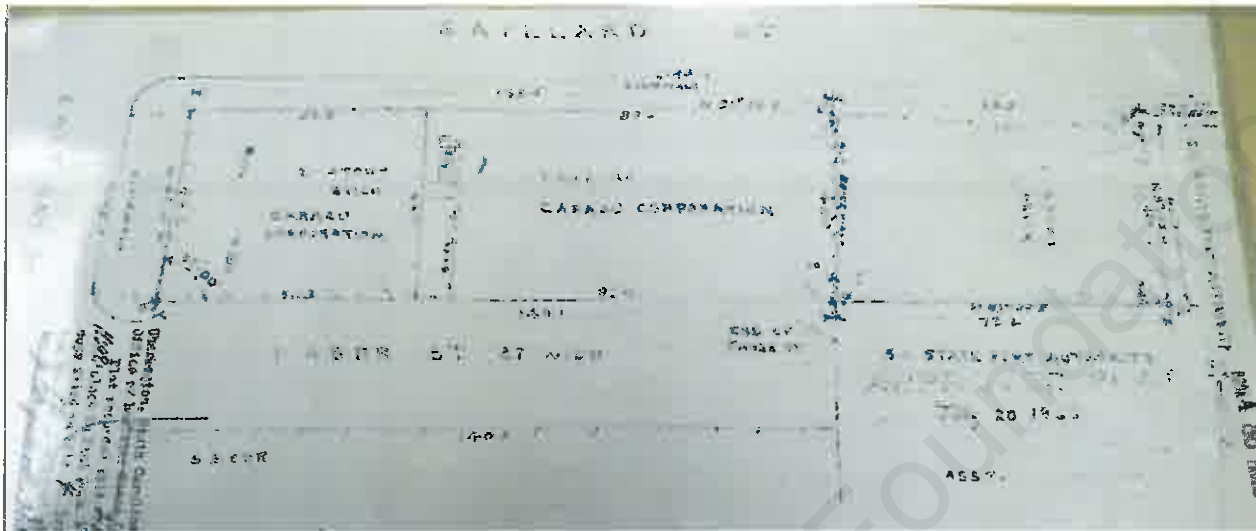


Figure 16: Carasu Corporation Plat 1966

Brokers.⁷⁸ On August 11, 1975, Robert G. Clawson, Jr., the trustee in the bankruptcy of the state of Bevon International Inc. conveyed the lot to Borris Chemical Inc. for \$148,000.⁷⁹ The same description from the Carasu Corporation still stands.⁸⁰ The Borris Chemical Co. was a chemical dealer and had other properties in Charleston distributing chemicals.⁸¹ The next transaction was on April 23, 1979 from Borris Chemical Inc. to Wilbur Smith and Associates Inc. for \$235,000.⁸² On May 16, 1983, James Decker, Wilbur Smith and Associates Inc. sold to East Bay &

Cumberland Street Associates for
\$360,000 using the same boundings.^{83,84}

East Bay & Cumberland Street

Associates seek to Edward L. Henning
for \$500,000 on November 11, 1985.⁸⁵

Edward L. Henning was the President of
E. S. Enterprises part of the McDonald's
corporation.⁸⁶ Edward L. Henning died

on July 27, 2001 and his will was from March 19, 2001.⁸⁷ Henning's last will and testament

"authorizes the personal representative to sell real estate...at the time of his death."⁸⁸ Charles F.

Ailstock was his personal
representative.⁸⁹ On April
18, 2003, Edward
Henning's estate sold the lot
to One Ninety-Four East
Bay, LLC for \$1,600,000.⁹⁰
The current owners,
Maverick Southern Kitchen
Headquarters, LLC, a South

Carolina limited liability company, bought the lot from One Ninety-Four East Bay, LLC for \$1,850,000.⁹¹ Maverick also owns 192 East Bay and has a restaurant called “Slightly North of Broad Maverick Southern Kitchen.”

Architectural Description

194-196 East Bay has changed buildings through its time. It started out as a water lot and moved up to the two-story brick building it is today that faces East Bay Street. The Ichnography map of Charleston is one of the earliest views. According to the map, a wharf extends into the water. It is labeled 94, which correlates in the table with Vanderhorst Wharf. The property has one ‘L’ shaped building located on it. In 1804, when Theodore Gaillard Jr. was selling the land to John Christopher Faber a plat (figure 19) was made. The plat includes the lands that were sold in a yellow outline. At this point, there are stores of brick. There appears to be more than one store. The number of stores can be inferred from the plat. It shows that stores on the property are directly on East Bay Street. In 1846, a plat (figure 21) by Charles Parker, surveyor, was made for the Fabers. Mary M. Faber, the

widow of John C. Faber and mother of Joseph and Henry Faber, had land between Joseph Faber and Henry Faber.⁹² She gave the land to use as a pathway between the two to the wharf.⁹³ The plat shows the land of each of the brothers.

In a plat by John Wilson in 1853, which is located in Deed Book Y-12 page 56 (figure 22). This plat was referenced through the twentieth century that describes the parcel. The plat shows the land between Gaillard

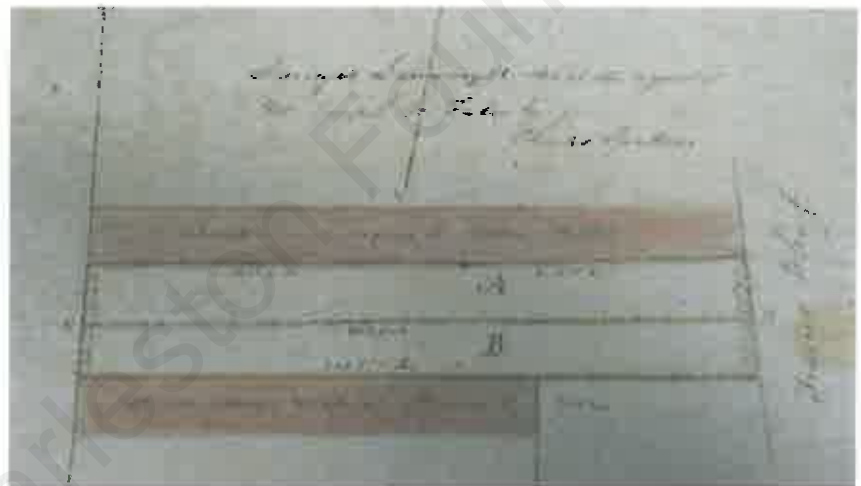


Figure 24: Plat of Mary Faber's Land

Street and Faber Street. The buildings have 44.3 feet on East Bay Street and approximately 140 feet of building with 60 feet of open space making it 44 by 200 feet lot. It shows many stores of brick that are three stories tall. The Ward books are used in reference to the owner, building description, and the street names surrounding the lot. The Ward Books from 1871 through 1879 have two three-story brick buildings on the lot that measures 44 feet by 200 feet.⁹⁴ In 1879, the

Ward Books show only one brick building that was one-story tall.⁹⁵ This description stays that same through the 1961 Ward Books. In 1872, the Bird's Eye view map shows buildings and the location to the wharf. It has three-story buildings across from Cumberland or Wragg's Street. The Sanborn Maps give building descriptions as well as use. According to the 1884 map, the building now has an office and has the address 126-128 East Bay Street. It has also gone from three-stories to one-story. The 1888 Sanborn Map uses the current address 194-196 East Bay Street and show a one-story building and includes windows along North Central Wharf and South Central Wharf paths. The building is clearly marked as one story at 194-196 East Bay Street in the 1902 Sanborn Maps.

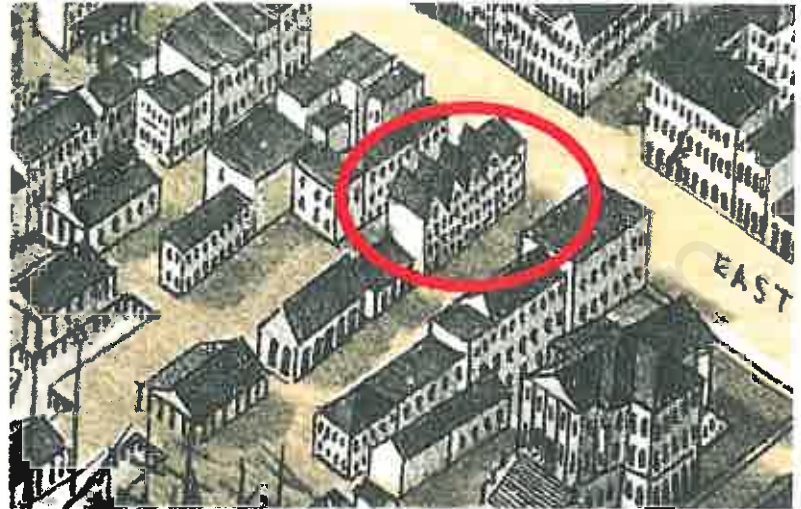


Figure 25: Bird's Eye View

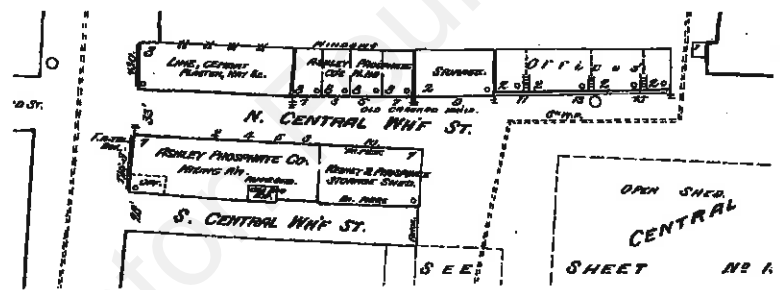


Figure 26: 1884 Sanborn Map

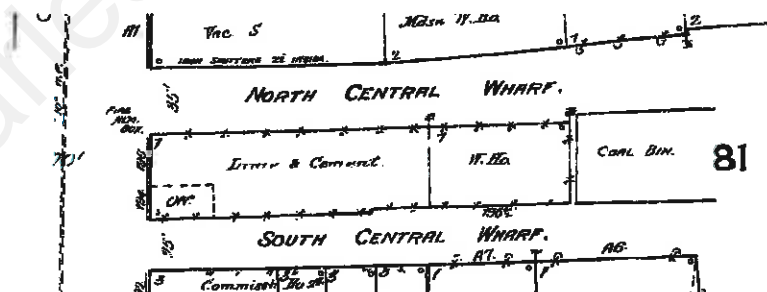


Figure 27: 1888 Sanborn Map

According to a property file at Historic Charleston Foundation, the current two-story office building was built in the mid-1960s and altered in 1986.⁹⁶ This was when the parking lot

was added east of the building that is shown in the 1966 plat, figure 24. This 1966 plat is the most current plat today. It includes a two story brick building that faces and touches East Bay Street that was 44.2 feet by 52.9 feet. East of that was a parking lot that is 42 feet by 87.2 feet. There was also a one-story brick building to the east of the parking that was 42 feet by 72.2 feet which was conveyed from Carasu Corporation to James S. Fort. This plat references the plat in Y-12 page 56 (figure 11 and image 32), which was the plat by John Wilson in 1853 during the conveyance between Joseph Faber executor and M.P. Matheson. The lot layout today looks like the layout in the 1966 Carasu Corporation plat. Charleston Cooks is in the building facing the street and there is parking to the east of the building. There is a building behind the parking lot; however, that was conveyed in 1966 and is no longer part of 194-196 East Bay Street. The building and lot has gone from a water lot with a wharf, through a transformation of three story brick buildings, down to one brick building one story high to the current brick veneer two-story building with a parking lot.

Significance of the Property

Every building and lot is home to a unique history that warrants its significance. In the case of 194-196 East Bay Street, its significance goes back to the Grand Model and documents Charleston's changes through

the Revolutionary War, natural disasters, the depression and up to the current day. Many of the

first owners were predominant men of Carolina and in the planning of Charles Town. Through the years, many commercial merchants owned the property showing the development of commercial property in Charleston and along East Bay Street. Also, the lot is close to the wharf, shows traffic to the wharf and the how important the port was to the merchants. The Witte Brothers were commission merchants; they needed to get what the customer needed by ship. The property was confiscated because Gaillard was a loyalist, which plays a role in the Revolutionary War history of South Carolina. The property is significant because of the owners and location for business owners.

Name Changes of Cumberland and Faber Streets

One change seen through the plats and maps is the name changes of the streets surrounding 194-196 East Bay Street, Charleston. It is interesting to see the name changes through time and sometimes switch back

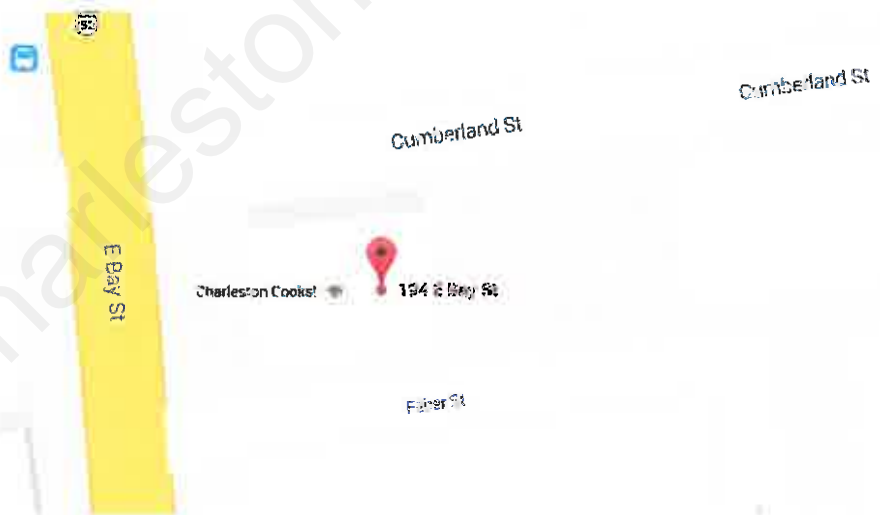


Figure 29: Present Day Google Map of 194-196 East Bay and Surrounding Streets

through time. The current lot is between two streets, Cumberland to the North and Faber to the South. The East side is East Bay Street and to the West of the parking lot is another building.

Faber Street

Faber Street first appears according to *Streets of Charleston*, in 1805.⁹⁷ Since the Faber family owned the lot for a while, it is assumed that the street is named after them. In the 1804 plat in RMC book M7 on page 336, Faber Street is a pathway to the wharf. In 1853 plat, it is clearly marked as Faber Street. In the Ward books from 1871 through 1925, the street is called Entrance to Central Wharf.⁹⁸ Some plats show the street as South Central Wharf. The City directories lists it as a street starting in 1930.⁹⁹ The plats recognize Faber Street in 1804, but the tax assessments don't recognize the Street until at least 1925.

Gaillard Street

Gaillard Street used to go from East Bay Street, east to the Cooper River. In the Ward Books, it is listed as Central Wharf until 1910.¹⁰⁰ It is also named Central North Wharf in the 1891 Directories.¹⁰¹ The *Charleston Evening Post* on November 24, 1943, shows that it was brought up by Ralph A. Baxter at a city council meeting to change "the one block of Gaillard running from the Copper River to East Bay Street, be changed to Cumberland."¹⁰² The plat shows the new road with letters A and B. The red is the lots, the top lot is now 198 East Bay Street and the bottom lot is now 194-196 East Bay Street. The land in between is owned by Mary Faber after

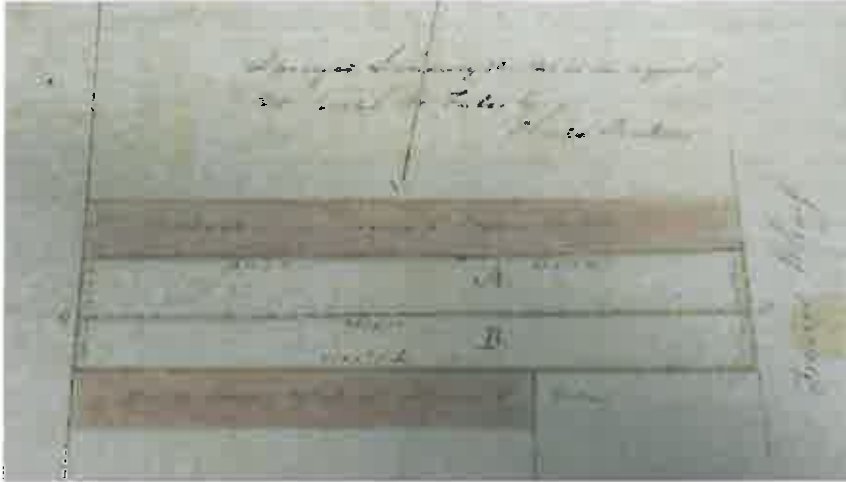


Figure 30: 1846 plat

Cumberland Street

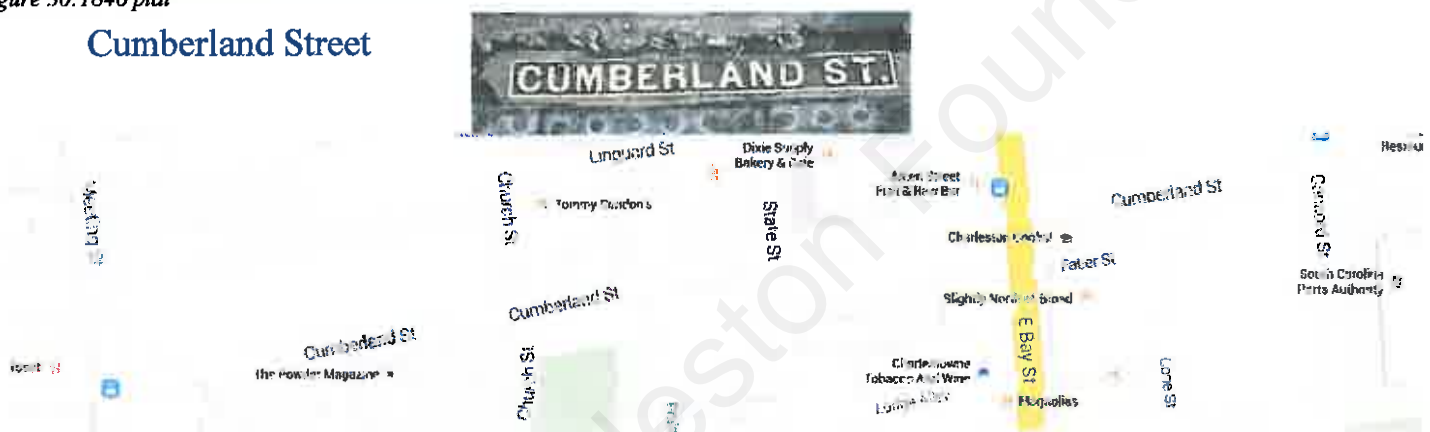


Figure 31: Present Day Google Map of Cumberland Street

Cumberland Street stretches between Meeting Street and Concord Street today as shown in the Google Map. Cumberland Street has had the names Wragg's Lane of Alley, Chamber's Alley, Amen Street, and Moore Street. In 1836 map, it shows Amen Street stretching from Church Street to East Bay Street and Cumberland from Meeting to Church. There was an approved plan according to the Minutes of Street Commissioners of South Carolina in 1838 to extend and move

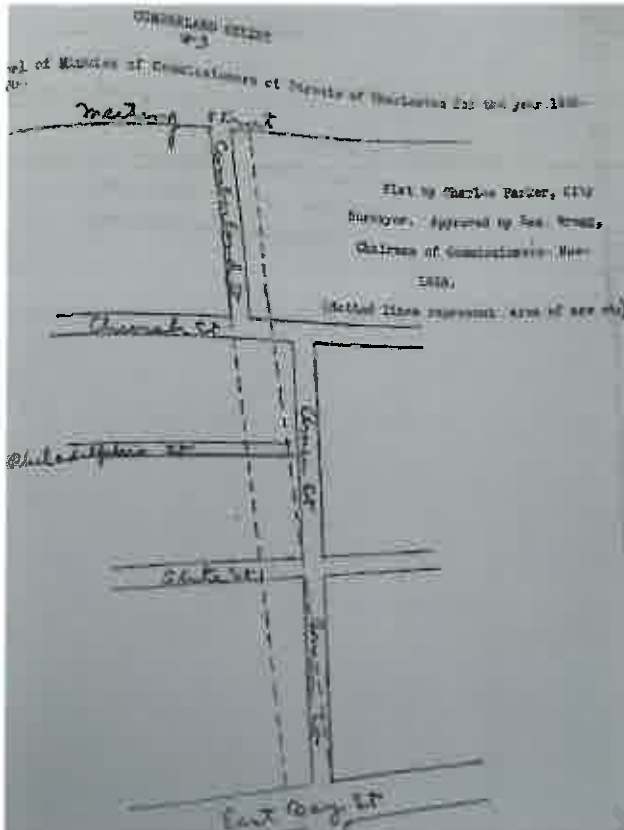


Figure 32: 1838 Map of extension

the streets between Meeting Street and East Bay.¹⁰⁴ The dotted line shows where this new street is going. It is going to be labeled as Cumberland Street. Wragg's Alley is the name that shows up on early plats early. A map from 1788 shows that Wragg's Alley runs from Church to East Bay.¹⁰⁵ The plat from deed book Y12 page 56 from 1853 labels the street across East Bay from Gaillard Street, the now present Cumberland Street, Wragg's Alley. Cumberland Street has had many names and has been moved

and renamed. In 1838, Cumberland Street seen today was laid out and named. However, still in 1853 it is still called Wragg's Alley.

Conclusion

Through many resources and archives, 194-196 East Bay Street history and chain of title has been started. The lot started out in the Cooper River connected to the Grand Model No. 33. As the city and the peninsula grew, the lot became a low water lot until it was filled to a land lot. Buildings were built and torn down. Many businessmen used the connecting wharf for commercial use and many businesses grew. First, it started out as a wharf where commercial use

and trading took place. Next, many stores were used by the Gaillards and the Fabers. The lot went through confiscation acts of the revolutionary war. The lot was surrounded by the cotton industry and thrived through it. Natural Disasters such as fires and earthquakes did not damage the lot of buildings. Through many changes of owners, the lot is now owned by Maverick Southern Kitchen and is a shop that sells Cookery and gives classes on cooking.¹⁰⁶

"In 1678 John Foster (Forster) received a warrant for a town lot on Oyster Point and took possession of lot 33. In 1682 he was still in possession according to the lot descriptions of neighboring lots. In 1693 Captain James Moore received a certificate of survey for lot 33 which "John Forster, late of Barbados," had neglected to build on. In 1694 Moore received the grant to the lot and deeded lot 33 to Captain William Hewitt, late of Jamaica. At that time Dame Margaret Moore relinquished her dower rights to the lot. Apparently during his lifetime Robert Daniell purchased lot 33, for he appeared as the owner on the butts and bounds of neighboring lots. In 1719 Sarah Daniell, widow of Robert Daniell, Jr., who held use of both lots 33 and 34 for her lifetime, relinquished her interest in them to Martha Daniell, widow of Robert Daniell, Sr., in return for full possession of the northern portion of lot 34. 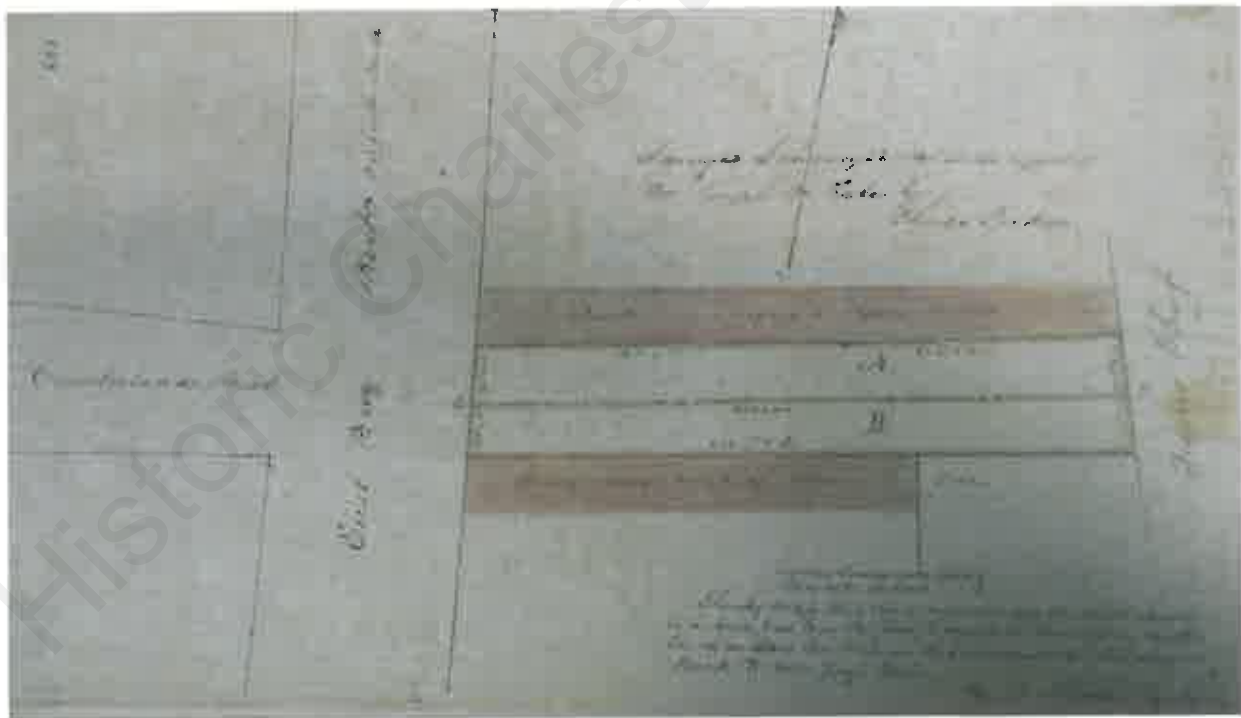

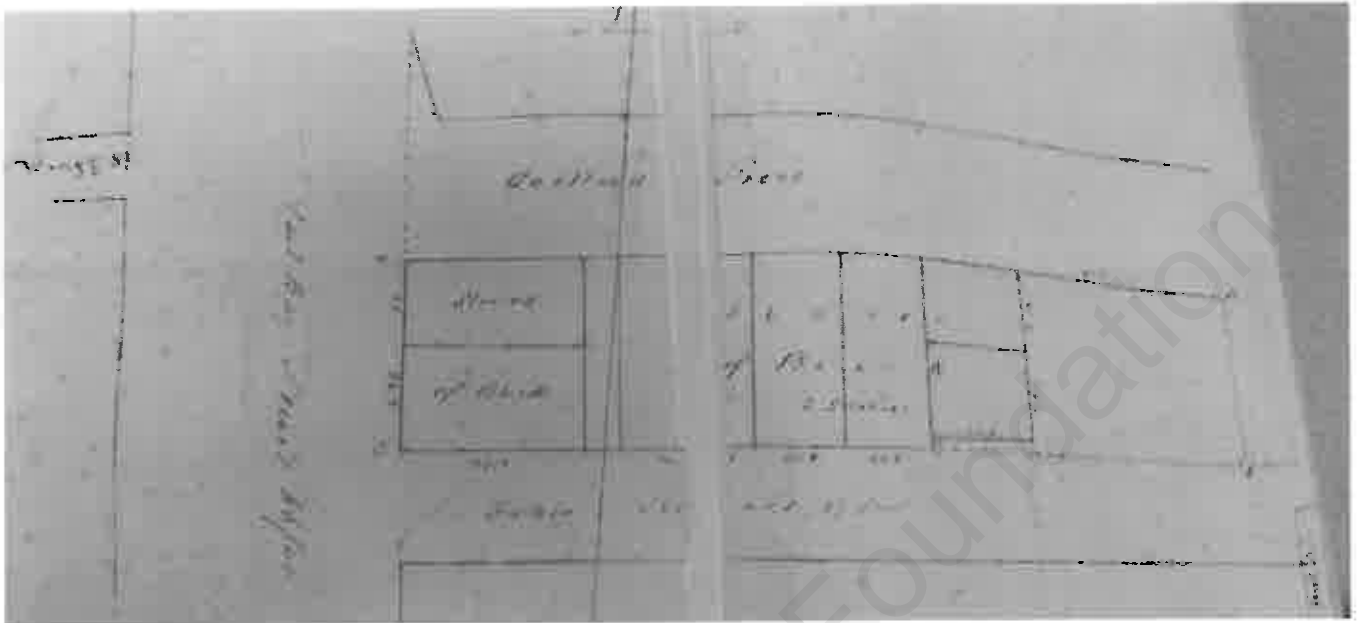

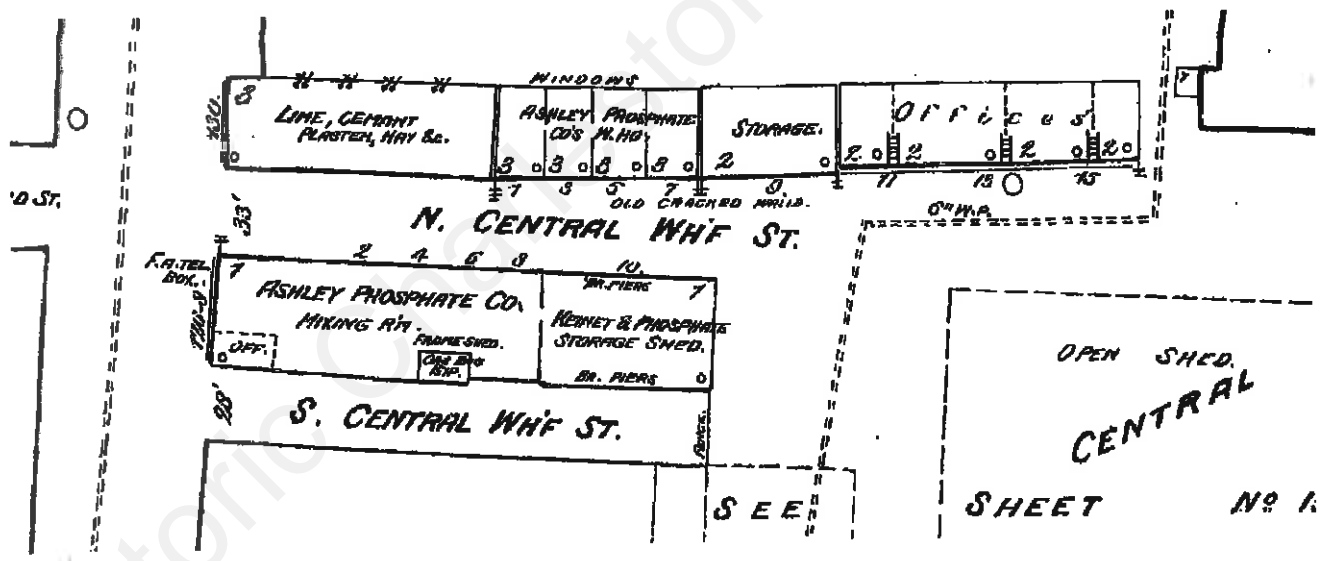
34: Gaillard to Faber Plat in M7 page 336



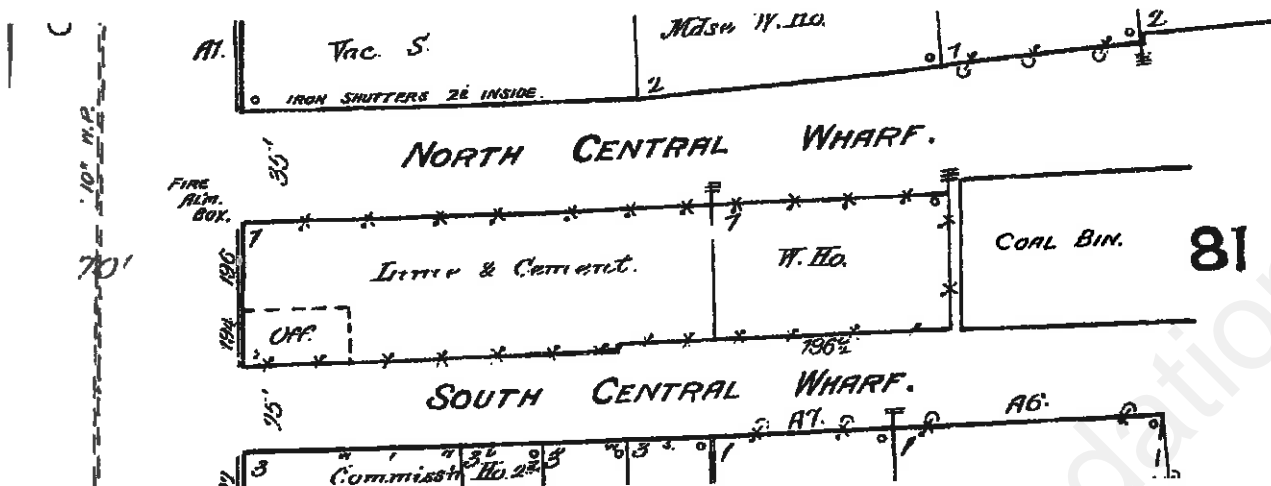
33: Mary Faber's land between lots turned into Pathway



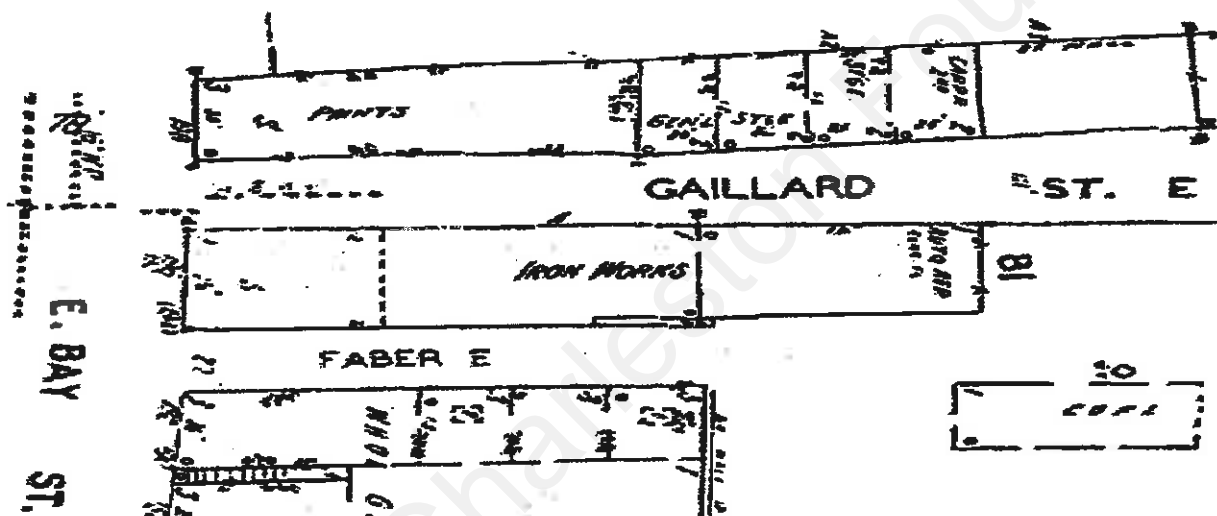
35: Y12 page 56 Plat Used from 1886 to Present
