

HENRIETTA STREET

This one-block long street generated more than its share of controversy in the waning days of the twentieth century. Alarmed about renovations on a once handsome street that had lost all but three of its ante-bellum homes, the Mazyck-Wragsborough neighborhood association called the attention of the city's Board of Architectural Review to improper renovations at 3 Henrietta Street. This and other similar instances in other neighborhoods led Mayor Joseph P. Riley Jr. to recommend beefing up the code enforcement spending by 20% for the coming year. The construction of the Mendel Rivers Federal Building on Meeting Street with its parking areas accessible from Henrietta Street obliterated many of the addresses on the south side of the street. At the end of the century, the building was still standing but vacant because of new federal safety requirements for its installations. The future of the Meeting/Henrietta site was unknown.
