> I just spoke with my dad and he gave me a few more details:
> -The exterior steps were put in by Robert Keller shortly after moving in. This was done to allow access to the 2nd & 3rd floor apartments, while Robert & Iva remained living in the bottom portion of the house. There was a wall put in at top of the steps on the 2nd floor, which was removed this past year in effort to open up the house a bit more for selling purposes.
> -Robert Keller died in the front bedroom (downstairs)
> -A tenant died in the 2nd floor back apartment in the mid 60's
>
> I will see if I can get my hands on some pictures for you. They are all out at my parents house in Awendaw. There actually may be some in the living room of 116—feel free to look!
