

BANQUET FOR THE BANKERS LAST NIGHT SUNDAY CLOSING LAW TO BE ENFORCED

IMPOSING ARRAY OF WEALTH AND BEAUTY GATHERED AROUND THE FESTIVE BOARD

Hon. Geo. W. Allen Was Toastmaster--Eloquence And Scintillating Wit Abounded Among the Bankers--The Menu Was Distinctly a la Key West.

The banquet tendered the Florida Bankers' Association last night at Masonic Temple was one of the most successful and delightful affairs of the kind in the history of the city, and the hall was taxed to its full capacity to accommodate all the guests.

Hon. Geo. W. Allen presided as toastmaster and made a short address of welcome, after which he proposed a toast to the President of the United States, standing. He stated that he had listened to an excellent address during the day on the development of Florida, and as this development was coincident with the tenure of office of President Wilson, he proposed a toast to the Governor of Florida.

The toast, "The Navy of the United States" was responded to by Rear Admiral Lucien Young, whom the toastmaster eulogized as the most able and eloquent officer in this or any other navy. Admiral Young spoke eloquently and in the course of his remarks stated that he could defend the F. E. C. Extension with a patrol of 150 men, owing to its inaccessibility by foreign warships.

Dr. Lincoln Hulley, president of Stetson University spoke next and the crowd called for a recitation of "Tommy Atkins," in lieu of which Dr. Hulley gave them "Fuzzy Wuzzy." Not satisfied,

the banqueters demanded that he recite "Tommy Atkins," which he did in the inimitable manner which has made him famous as a lecturer and orator.

Mayor J. N. Fogarty then spoke taking occasion to eulogize Key West and its beautiful women. The Mayor has never made a more eloquent address than he did last night.

Mr. W. E. Bell then spoke, taking as his subject "The Razor Back" hog, and explaining that he meant the four-footed kind.

Mr. James P. Roache, of New York then spoke, followed by Messrs. John B. Ferguson of New Orleans, Reuben L. Rockwell of Savannah, J. Alfred Beale of Cuba, Harrison of Baltimore.

Mr. C. A. Faircloth who was to have responded to the toast "The Ladies," reneged. Mr. W. E. Bell responded to the toast "The Florida Bankers' Association." Ex-Senator W. H. Milton spoke, referring to his candidacy for Governor and from his remarks one would gather that he held the race between himself and Hon. E. M. Semple of Key West. Mr. H. G. Aird spoke on the subject of "Trust Companies." Souvenirs of the occasion given to the guests were leather cigar cases, coin purses and paper cutters. The menu was typical of Key West and included many of the delicacies which the surrounding waters yield.

Tells a Good Story.

As is generally known, the Rev. Darlington, the genial pastor of the Congregational church of this city, tells a good story, when he is in the humor for telling stories, and the best part about it, he is generally in the humor. Mr. Darlington dropped into the office of The Journal yesterday afternoon and among others told a member of the Journal's staff the following joke, which we pass on to our readers. Some time last fall Mr. Darlington delivered his illustrated lecture on The Passion Play in a theatre in one of the New York cities, and after the lecture he was being congratulated on the evening's entertainment he had provided. Among others who came up to the Rev. Darlington was one very sober looking man, who seemed particularly pleased with the lecture. "I knew," he said, "that there was such a man as Jesus Christ, and that he was a great reformer and was killed somewhere, but I am blest if I knew whether he was killed at the foot of Bunker Hill or crucified in Jerusalem."

Semple, Key West's candidate for Governor. The voters may now decide for themselves. Mr. Milton, in common with the other candidates for Governor is confident of getting into the second primary, and it appears that he has developed considerable strength, which will make him a formidable factor in the election.

DAY AFTER TOMORROW "BLUE SUNDAY" ACCORDING TO CHIEF OF POLICE JOHN CATES

Chief Says He Will Wink At Nothing in Future--City Ordinance Relative to Desertion of Sabbath Will be Strictly Enforced--Saloon Closing

A regular meeting of the City Council was held last night at City Hall, all members being present except Dr. C. F. Kemp. In the absence of the president Councilman Ladd took the chair. The minutes of the last meeting were read and approved as were also the minutes of the special meeting held on March 27.

A communication was read from City Waterworks Engineer, Carol Wetmore calling attention to the extra work he has been doing and the work which is yet to be done and asking that his salary be increased to \$125 per month. A motion was carried that an ordinance be drawn up increasing this salary and the City Attorney was so instructed.

A communication from Chas. Ridlon was read asking that a former communication be reconsidered and no action taken. A communication from Earl W. Page was read requesting that a tax which he had already paid for the privilege of selling gasoline be refunded as small merchants were not required to pay this tax.

Board at some length stating that he wanted all ordinances enforced to show the hardships of the present City charter which was unsatisfactory in spite of amendments made and telegrams sent to Tallahassee.

A communication was read from Robert H. Smith requesting that a fine of \$25 imposed on him recently by Police Judge Curry for attempting to pass liquor into the city jail be remitted, owing to the fact that he had no work in the factories for six weeks, and was not guilty of the charge, although liquor was found on his person at the time of the arrest. The communication was referred to Judge Curry.

A communication was read from the mass meeting held Tuesday night asking consideration of the resolutions they had passed, the first resolution asked that all children under 15 years of age be compelled to attend school, and that a curfew law be passed requiring children to keep off the streets between the hours of 9 p. m. and 5 a. m.

Councilman Ingraham addressed the Council and stated that Key West needs three things: compulsory education, a trust officer and a juvenile court. He was found that the city has a curfew ordinance prohibiting children from playing or loitering on the streets.

between the hours of 9 p. m. and 5 a. m. City Attorney Semple stated that this ordinance does not conform with the State law as children of that age have not arrived at the age of discretion and could not be brought before a court except in capital cases.

The second resolution asked for the appointment by the Council of a law and order committee. Rev. Darlington explained the resolution by stating that the idea was to appoint one man in each ward as the nucleus of a law enforcing society, they to get evidence and try to secure convictions. Rev. Tresca also spoke in favor of this plan. The Council requested that the President of the Board make these appointments.

In accord with the third resolution, an ordinance was introduced regulating the hours of saloons, requiring them to close from 11 p. m. to 6 a. m. on week days and from 11 p. m. Saturday night until 6 a. m. Monday morning, and fixing the penalty for violation of this ordinance at not more than \$250 or 60 days in jail. The ordinance passed on the first reading.

Resolution 4 requesting the employment of a plain clothes officer brought on a lengthy discussion but no action was taken.

Councilman Valdez spoke of the good work being done by the Mercedes Hospital and requested the Council to appropriate the sum of \$100 per month to assist in defraying the expenses of the institution. Councilman Curry amended this to \$50 a month on account of a shortage of funds at present. The Council voted to appropriate \$50 monthly.

The fifth resolution relative to desecration of the Sabbath brought on a long discussion during which Rev. Darlington, Rev. Tresca and Chief of Police Cates addressed the Board. Chief John Cates Jr. asked if the Council wanted him to enforce all the ordinances in the ordinance book. Being assured that they did, he stated that next Sunday every ordinance pertaining to the desecration of the Sabbath would be enforced strictly.

Mr. A. J. Willis of the Free Shelter Hospital requested the Council to furnish his shelter with salt water for bathing purposes of the inmates. On account of the expense of laying water mains the request was denied. The current bills were then read after which the meeting adjourned.

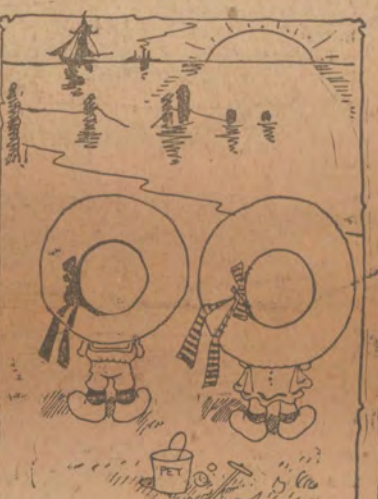

PICNIC HINT OF SOME VALUE

Mix the French Dressing Before Starting and Have It All Ready for Use.

Instead of taking separate bottles of oil and vinegar, with the requisite seasonings for a French dressing, and measuring and mixing it just before using, try what a Little Wise Lady taught a Busy Planner. "Measure all your ingredients, and put them in a tightly corked bottle or small preserve jar," she said. "The salt and sugar will dissolve thoroughly long before you reach the woods."

"When your salad is ready for its dressing simply take the bottle or jar and give it a thorough 'churning.' The mixture will be perfect. Of course, the colder it has been kept the better. I invented this plan after seeing my neighbor pour a little vinegar into her oil bottle, to take up the last teaspoonful that always takes so long to run down and out, when one is in a hurry. She shook it well and poured the 'emulsion' thus formed into the mayonnaise she was mixing, leaving nothing in the bottle."

"It is a far better plan than warming the bottle in order to hasten its emptying."

SIMPLE HAIRPIN CASE

IT IS MADE OF CIGARETTE BOX WITH PARTITIONS.

May Be Prettily Covered With Scrap of Silk—Girl Who Is Neat Also Has Bag for Combing.

Hairpins should be kept in a flat box, with partitions for the pins of each different size. From a cigarette box can be made a small hairpin box, when only short pins are used, by placing one cardboard partition in the center. Some cigarette boxes are of double size, and these are best for all practical purposes. There should be a small space made at one end for the invisible hairpins which are essential to keep the stray locks in place, and then if the center is divided again there will be three partitions left in all—two of equal size for the heavier wire pins.

A hairpin box can be covered with the finest end of chintz or silk, with a bit of gold or silk braid to paste over the edges and hide untidy linings. If there is no scrap box to draw upon, a pretty box can be made with wall paper covering.

The girl who would be neat should also keep in the top drawer of her dressing table a small silk bag for her combings, and then this bag should be carefully emptied every few days. Just a few hairs at a time are apt to stray from the waste basket, and nothing is more unattractive than long loose hairs upon the carpet. There should also be a little combing case in the traveling bag, for on a train or steamer there is seldom a waste basket accessible. This bag is made with a six to eight inch length of ribbon, with two pieces of whalebone at the top. This method of closing a bag with whalebone instead of a drawing string is an excellent one.

The two pieces of whalebone are of equal length and are covered, of course, by the ribbon. Pressed together at each end the bag will open with ease and then keep tight closed at other times.

Somewhat Shopworn.

The widower had married again, and his choice was a wealthy woman about fifty years of age. When the bride and bridegroom returned home from the wedding the husband, introducing the wife to the children, said: "My dear children, kiss this lady; she is the new mamma I promised of being you."

Little Charlie took a long and steady look at the "new mamma." Then he burst forth with an air of virtuous disgust: "Pa, you have been cheated! She isn't new at all!"

Deviled Eggs l'Anglaise.
Six eggs, half a cupful of cream two tablespoonfuls of butter, the yolks of two eggs, one teaspoonful of mustard, one teaspoonful of chutney or tomato catsup, a tablespoonful of minced ham and two teaspoonfuls of chopped pickle. Fry the eggs in the butter and when done lift them out carefully with a batter cake lifter, trim them around the edges with a sharp knife and arrange them on a hot dish. Pour over them a sauce made as follows: Into a stew pan put half a cup of cream, a tablespoonful of butter and salt and pepper to taste. Bring to a boil, then add the yolks of the eggs, mustard and chutney. Stir over the fire until the sauce thickens, but it must not boil. At the last minute add the ham and chow-chow to the sauce. Pour over the eggs and serve very hot, garnishing the dish with triangular crusts of fried bread.

Bread Fritters.

Cut some stale bread into slices one-quarter of an inch thick. Shape into squares about one and one-half inches. Beat the yolks of two eggs in a basin; add half pint of milk and an ounce of sugar. Mix well and soak the bread in this for ten minutes. Fry the pieces of bread in very hot fat until they are a golden brown. Mix together a little powdered sugar and cinnamon and as soon as the fritters are done toss them about in this. Serve very hot.

Cover Jams and Jellies.

One of the best ways of covering jams and jellies so that they will keep well is to cover the jars as soon as they are filled. Have the papers cut steady and the white of an egg slightly beaten, brush the papers with the white of the egg and tie down quickly. The heat of the jam destroys all germs that might cause it to mold and dries the egg so quickly that it is hermetically sealed.

Raisin Puffs.

Two eggs, one-half cup of butter or part lard or drippings, one tablespoon of sugar, one cup milk, one cup raisins chopped, two cups of flour, two teaspoons of cream of tartar and one teaspoon of soda. Put into buttered cups and steam half an hour. Serve with whipped cream, which is not too stiff. This makes eight puffs.

Veal Cutlets.

Fry brown eight slices of pork. Take up, add two spoonfuls of lard. Have ready thin slices of veal, dip them in egg and then in cracker crumbs and fry nice brown, season before dipping with pepper and salt. Serve with the pork with mashed potatoes and vegetables. The fat from beef, pork and poultry for shortening and frying.

YOU MAKE CHICKEN CREOLE

Recipe for Dish That Will Be Welcomed on Table During the Heated Term.

Take two spring chickens and clean nicely and cut into pieces at the joints. Season well with salt and pepper; put two tablespoonfuls of butter into a stewpan and when it melts add the chicken. Let this brown slowly for a good five minutes. Have ready three large onions; add these to the chicken and let them brown; every inch must be nicely browned, but not in the slightest degree burned. Add two tablespoonfuls of flour; let this brown and then add a half-dozen large fresh tomatoes, nicely sliced, and let these brown. Cook very slowly, allowing the mixture to simply simmer. Add chopped parsley, thyme and bay leaf, and two cloves of garlic nicely minced.

Let all brown without burning. Cover and let it smother over a slow but steady fire. The tomato juice will make sufficient gravy. Add a half-dozen of green peppers (sweet), taking the seeds out before adding, and slicing the peppers very fine. Stir well. Let all smother steadily for 20 minutes at least, keeping well covered and stirring occasionally. When well smothered add one cup of cornstarch; let it cook again for a full hour, very slowly over a very steady fire, and season again to taste. Cook ten minutes more and serve hot.

A "Bacon Bat"

A young college friend informed me that the very latest thing in outdoor affairs was "A Bacon Bat." When explained I concluded that it must be loads of fun. Of course, as with all such parties, all depends upon the guests and their love of outdoor functions. We all feel the "call of the wild" these glorious days and I am sure many of our readers will want to have a "Bacon Bat" just as soon as they read this. Six couples are enough, provide plenty of delicious bacon sliced very thin, sweet potatoes and several dozen finger rolls; these are the absolute requirements, other things may be added at the pleasure of the hostess. Build a fire, roast the sweet potatoes (or take a frying pan, have the potatoes boiled at home and fry them over the coals). Grill the bacon on the ends of long sticks, insert the finger rolls and you have a meal fit for a king. Coffee may be made and I assure you the only danger is in not having enough of everything. Nature study classes are in favor all over the country, and after a tramp what could be more appetizing than the repast I have just described? I would suggest roasting Irish potatoes and taking a jar of butter with plenty of tissue paper napkins; hard boiled eggs are a welcome addition with a jar of tiny cucumber pickles and olives both ripe and green.

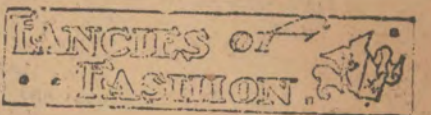

Waists of challis, foulard, pongee or messaline matching the suit in color are very good looking, and are more practical in many ways than washing shirt waists and in the end hardly more expensive. They can be made very simply and worn with lingerie collar and cuff sets.

Reconciliation to God

By Rev. James M. Gray, D.D.,
Dean of Moody Bible
Institute, Chicago

TEXT.—And you, that were sometime alienated and enemies in your mind by wicked works, yet now hath he reconciled. In the body of His flesh through death, to present you holy and unblemished and unspotted in His sight: If ye continue in the faith grounded and settled, and be not moved away from the hope of the gospel, which ye have heard.—Colossians 1: 21-23.



The apostle Paul is here speaking of Jesus Christ as the one in whom all things universal, for that would include not only the souls of the condemned, but the demons in hell and even Satan himself. But he means all the things which it has pleased the father from the beginning to reconcile. The definite article in the Greek suggests this as the thought, which is made clear by the other teachings of the Bible on the same subject. Among those things which it pleased the father to reconcile to himself are the believers on Jesus Christ, and it is of their reconciliation, especially that Paul here speaks.

I. First he shows our need of reconciliation, by telling us that we were "sometime alienated and enemies in our mind by wicked works." "Sometime" covers the whole period of our lives from physical birth to our new birth by the holy spirit. All that time the natural man is alienated from God. And not only alienated, but hostile to God, an enemy, as the text says.

What Are Wicked Works? This enmity need not show itself necessarily in giving way to the lower and baser appetites of the body. There are cultivated men and women who are able to control these appetites, but who are at the same time enemies to God in their mind.—I. e., in their modes of thought and feeling, which are contrary to his revealed will. And this enmity must in the very nature of the case, show itself in "wicked works."

II. Second, he shows the source of our reconciliation, which is God himself. Yet now hath he reconciled us. The very one from whom we were alienated and against whom we were enemies is the one who reconciles us.

"He who might the vantage best have took Found out the remedy."

This is grace, especially when we understand that it does not mean primarily that we became reconciled to God, but that God became reconciled to us. This he did by taking that sin, out of the way which was the barrier to his reconciliation.

III. This leads Paul to speak in the third place, of the means of our reconciliation which was the work of Christ for us on the cross as our substitute Saviour. "In the body of His flesh through death." Why say "the body of His flesh"? Why say "this body," without adding "flesh"? Because there was a heretical sect in that day which denied the materiality of Christ's body. They believed in a spiritual, but not a material, mediatorship.

But Christ had a real body and real flesh and real blood which he offered in propitiation for our sin, he passed through real suffering and died a real death. Such is the teaching of this verse.

IV. And this brings us to the fourth point, which is the result of our reconciliation, presented "holy and without blemish and unchanged in God's sight." This is true immediately of every believer the moment he accepts Christ by faith as his Saviour. Oh, if everybody in this sin-cursed and sin-enslaved world only knew and believed that! If they would only pause in the rush of things and listen to it for a single moment!

The Battle of Concord Bridge. At the battle of Concord bridge, at the beginning of the revolution, when John Buttrick gave the command to fire it was to British subjects he gave it, but it was obeyed by American citizens. In other words, in that instant their condition became changed, though the experience of that change was a thing of growth. So the instant a man takes Christ as his Saviour, he stands before God free from the guilt of sin, without blemish and without charge. And this is grace!

The final point in the lesson is the proof of our reconciliation, which is that we "continue in the faith, rooted and grounded and not moved away from the hope of the gospel." Paul is speaking not to the false teacher who, went out of the church, but to the true believer who stayed in. Those who are true to the "faith delivered once for all to the saints" have the witness in themselves that they are reconciled to God.

WOMAN RUNS A BANK HORN DINNER CALL

Sister of Jane Addams Heads Kansas Institution.

Located in Girard Twenty Years Ago and on the Death of Her Husband Became the Bank's President

Girard, Kan.—The morning sunlight filtered through the little window in the back office of the State Bank of Girard, and the bars across the window cast a network of shadows on the floor. The woman who sat in the heavy office chair behind the desk was fifty-eight years old, but her face showed scarcely a wrinkle, and the white in her hair glistened now and then by way of proof that it once was gold. The woman was Mrs. S. Alice Haldeman, and she is the bank's president. Mrs. Haldeman has another claim to distinction, for she is the sister of Miss Jane Addams of Hull House, Chicago.

"Well, yes, I'm the president," she admitted to a visitor, "only I don't run the bank myself; we all run it together—the two men and I."

It was 20 years ago that Dr. and Mrs. Haldeman came to Girard. The physician's health was poor, and the move was made on this account from the home of their childhood in Illinois.

"My husband became interested in the banking business shortly after we came here," Mrs. Haldeman said, "and he founded a bank of his own. We are the oldest bank in the county and have weathered three panics."

"Dr. Haldeman died five years ago," she added, "and—well, the last words he ever spoke heasked me not to leave the bank. So I took charge, and I'm very glad that I did, for I love the work. But, pshaw, it's not interesting to tell you about myself—you

just ought to know my sister, Jane, or my daughter, Marcell.

Although her name seldom is written in connection with that of her sister, Mrs. Haldeman has done a great deal of work at Hull House.

"I usually spend about three months of every year there," she said, "just to be with Jane and the girls who are helping through life; I have learned to love them all, and I look upon Hull House as my home. Home, that is, since my daughter has gone."

Mrs. Haldeman's daughter has been on the stage for several years. She won't play in any cast in which work must be done on Sunday, and wherever it is possible she goes to Sunday school and teaches a class.

"Do I find life here in Girard tedious? No things move fast enough for me, with my club work and bank and letters and reading."

The walls of Mrs. Haldeman's house are lined with shelves and on these are crowded hundreds of books. Above the shelves are pictures, drawings and paintings; of these last there is a life-size oil painting of her sister, Jane. Marble busts are set on pedestals and the grand piano is littered with books of classical music.

On the center table there was a book of photographs and Mrs. Haldeman leaned through it slowly while she talked. They were old pictures of the old days, most of them showing scenes of the Addams home at Cedarville, Ill.

At one of the pictures Mrs. Haldeman paused.

"That's the old mill at home," she said, and added after a moment, "Jane and I used to play hide-and-go-seek in that musty old place. Jane was the greatest little bunch of enthusiasm I ever saw, and she always was asking people to forgive her for the naughty things she fancied she had done."

And as she turned the pages of the book and saw once more the faces and scenes of the past her eyes became moist.

Benchers, Barristers and Students Summoned by Ancient Method—Recalls Days When Clocks and Watches Were Unknown.

London.—Nowhere do old customs cling more firmly than in the ancient seat of legal learning, the Middle Temple, London, which still jealously guards the traditions it has inherited.

To the present-day benchers, barristers and students are summoned to dinner each evening during term time by the blowing of a horn—a custom which has survived on this spot since the romantic days of the crusaders. Every evening at 5:30 during the three weeks of the legal terms, a warder, in gold-braided uniform, procures the ox horn from the strong room of the Middle Temple, and proceeding to the famous fountain in Fountain court, summons the members to dinner by blowing a blast on this primitive instrument.

He then visits each court in turn, according to ancient custom, and many a benchers throws up his window to listen to the sound of the winding horn, which has been heard continuously in these precincts since the time when the Knights Templar established themselves there in 1154.

Its use recalls the days when clocks and watches were unknown, and the voice of the watchman, calling out the time, was a familiar sound through the night watches. Sun dials were then the only guides the people possessed as to the flight of time, and of these more than one still survives,

with its quaint motto, on the walls of the Temple buildings. It is to the sworn enemies of the Knights Templar, the Saracens, oddly enough, that we do, indeed, the greater part of our mathematical knowledge as well.

When the Templars founded their new monastery between Whitefriars and Essex house in the Strand, the latter was, as its name implies, merely a beach beside the silver Thames, and all around was open country, the site of the present law courts being a large field which was used as a tilting ground by the knights. In later days, when the men of law had taken over the settlement of the Knights Templar, the students, who were resident in the Temple, were dependent on its kitchen for their daily meals. After a hurried breakfast in the buttery at eight o'clock they would take their law books, and wander off along the Strand, where, in summer time, they lay under the trees and bushes studying law. Some would row across the river to the Surrey fields, and wander through the open country.

Half an hour before dinner the panyer man, who was formerly charged with the duty of winding the horn, had also to provide the hall with mustard, pepper and vinegar, his annual wages in 1638 amounting to £26. Other useful members of the staff were the chief wash pot and the under wash, the chief turn broach, the steward's servant and under turn spit; the last named receiving \$6 a year.

The horn now in use in the Middle Temple possesses no antiquarian interest in itself, dating back only some ten years. It was brought over from the Argentine by one of the members shortly before it was found necessary to discontinue the use of the old one. "Ye horn of ye Middle Temple" had become so decrepit, through age and constant use, that the weird and fancy sounds it emitted were calculated to bring it into ridicule. It had become a mass of silver bands, which had been added from time to time to keep it together, and close up the cracks in its sides. But in spite of these bands the air still escaped so freely that the warder who blew it had to place a wet handkerchief over the horn every time he used it.

So the ancient horn, which had sounded the welcome summons to dinner in term for generations, was placed on the retired list, and now it only sees the light on grand nights in hall, when it is placed on the table with the rest of the Middle Temple's proud display of silver plate.

Nearly all the ribbons are reversible. This is a great advantage, as they may be twisted and draped in most artistic folds.

A black satin ribbon with a striped gray and white border has a reverse of hazel nut brown, black and white also dividing honors in the reverse border.

Distinct novelties are those centered with a mock close lying fur with a contrasting border.

A chinchilla simulated fur has a purple border.

Attention should be drawn to those that represent the extremes of fashions.

For instance, they are 12 inches broad, centered with a lace pattern with a striped border.

The shot ombres are extremely attractive.

Then there are those with black back grounds with a radium spot design.

Collars and Revers.

The collars and revers of the new coats and jackets require careful attention. After all they are a most distinctive detail of each season's style. They can be made of satin or velvet. The cuffs must match the revers, and this autumn all the newest coats have quite deep cuffs. This fashion began last year, but the cuffs now are deeper and wider.
