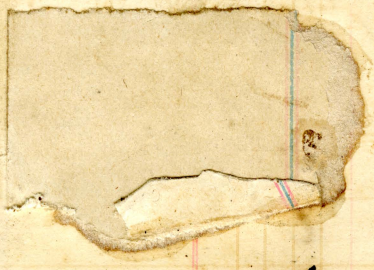

## Warrant.

You are hereby commanded to collect from each of the persons and Corporations named in the annexed Roll, and of the owner of the real estate described therein the Tax set down in each roll opposite their name and to the several parcels of land therein described; and in case any person or Corporation upon whom any such Tax is imposed shall refuse or neglect to pay the same, you are to collect the same by levy and sale of the goods and Chattels, lands and tenement so assessed of the person or Corporation so taxed; and all sums collected you are to pay to the City Treasurer at such time as may be required by law and at the same time you are to pay and he is hereby further required to make final settlement with the Chairman of the Finance Committee of the City of Key West.
