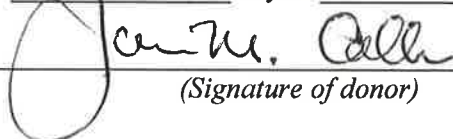

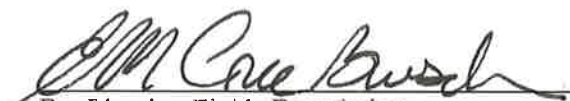

Table, English Gothic style oak trestle table with tracery and rose motif along the trestle and at either end, late 19th – early 20th century.

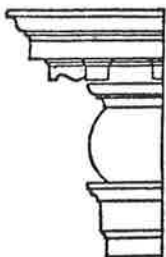
Measurements: 69 1/2" length x 19" width x 29 1/4" height
