by **FRANK OWEN SALISBURY**, ENGLISH, (1874-1962)

A framed oil-on-canvas of *Caroline Graham Slaughter Coe*, c.1930, three-quarter length, *Ms. Coe* sitting in a settee, showing her in a grey-beige silk gown, with vibrant red shawl and red silk flower, pearls at her neck, large diamond ring on left hand, large emerald ring on right hand, framed in a carved gilt wood *Copley*-style frame, with curviate, foliate design, 6" molding.
