## DEED OF GIFT

THIS DEED OF GIFT by and between 11560 Corp. (Paul. J. Mateyunas) ("Donor(s)") and Planting Fields Foundation ("Foundation"), a nonprofit corporation, having a principal place of business at 1395 Planting Fields Road, Oyster Bay, NY 11771 is effective as of May, 17, 2021, which is the date the object(s) described on Schedule A hereto ("Object(s)") was received by Planting Fields Foundation.

The Donor(s) acknowledges that upon execution of this Deed of Gift that Object(s) irrevocably becomes the property of the Foundation, and may be displayed, stored, maintained, and disposed of as the Foundation sees fit, with one exception: should the Foundation make the determination to deaccession the object(s), the Foundation will offer to return the object(s) to Donor(s) or their heir before making any other arrangements. Donor(s) acknowledges that because of limited space and exhibition policies and practices, the Foundation has not promised, and is in no way obligated, to exhibit Object(s) at Foundation.

Object(s) acquired by the Foundation shall be accessible without restrictions for use by scholars, researchers, and all persons having a need to use such Object(s) in accordance with the Foundation mission, policies, and procedures. Donor(s) understands that the Object(s) listed on Schedule A may not be incorporated into the permanent collection of the Museum and that the Objects may be used for educational or research purposes.
