Conditions Governing Loans

- 1- The Nassau County Museum of Art will exercise the same care in respect to loans as it does in the safe keeping of comparable property of its own.
- 2- It is understood that the Museum will not clean, restore, or otherwise alter the work without consent of the lender.
- 3- The work shall remain in possession of the Nassau County Museum of Art and/or other museums participating in the exhibition for which it has been borrowed for the time specified on the loan agreement, but may be withdrawn from exhibition at any time by the Director of the Museum. Loans will be returned only to the owner or his or her duly authorized agent or representative.
- 4- Unless the lender expressly elects to maintain his own insurance coverage, the Museum will insure this loan wall-to-wall under its fine arts policy, for the amount specified on the face of this loan agreement, against all risks of physical loss or damage from an external cause while in transit and on location during the period of this loan.

The Museum's policy contains the usual exclusions for loss or damage caused by or resulting from wear, tear, vermin, insects or worms, including larvae or pupae thereof, gradual deterioration, inherent defects or damage sustained due to the process or while being actually worked upon and resulting there from, including any repairing, restoration or retouching process.
- 5- Unless permission is declined to the contrary, it is understood that this loan may be photographed and reproduced for publicity purposes connected with this exhibition, for illustration in the Museum's catalogue and other publications, and that digital files may be made and distributed for educational use.
- 6- The aforesaid conditions shall apply to all works sent to the Museum on loan and cannot be altered, changed, waived, or otherwise affected except by written consent of the Museum.
