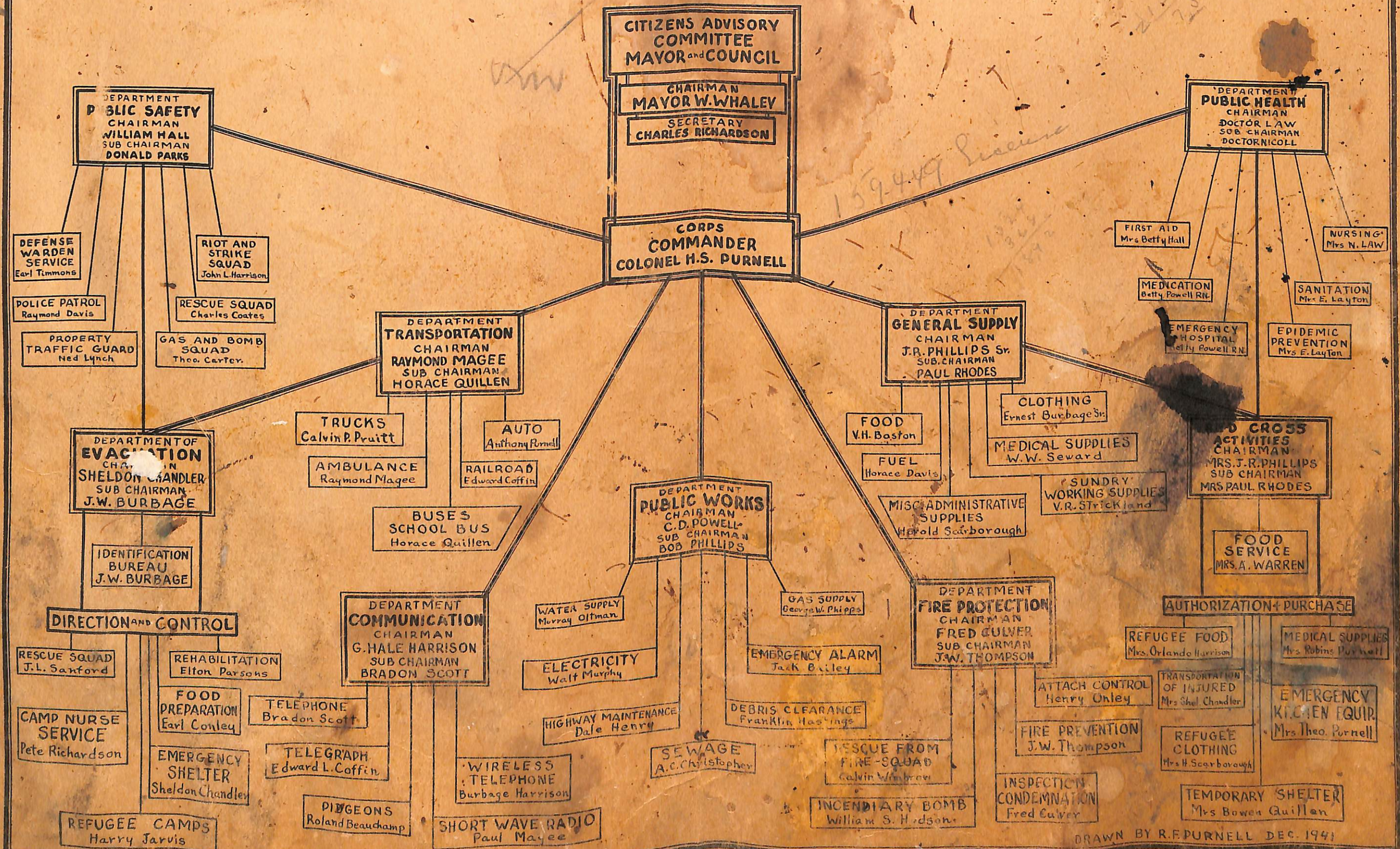


CHART OF ORGANIZATION
