

Know all Men by these Presents, That

the receipt whereof P. do hereby acknowledge, do hereby give, grant, bargain, sell, and convey unto
the said Deasy Q. Candy and their Heirs and Assigns forever

A certain tract or parcel of Land situated on Onesqueek point
so called in said town of Gouldsboro and butted and bounded as
follows. to wit

Commencing on the eastern shore of onesqueek point
thence running on the N line of land owned by G. W. Wescott
S. 79 West one hundred thirty four rods to the western Shore
thence N west by the Shore in a straight line. 92 Rods to
a Spruce Stump and near a Step Bluff with notch in it thence North 79 East
one hundred (2) forty Rods to a Tree Spur and Hacmatae Spotted on two sides
thence S. East by the Eastern Shore on a straight line to the place of beginning
Ninety two Rods and containing Eighty acres

and be it understood that my meaning is to sell and convey
to Deasy Q. Candy the south half of the aforesaid lot
the one half which I herein Convey to Deasy Q. Candy to contain no less
than forty acres also with the right of way two and from the same
across my land

to their use and behoof forever. And P. do covenant with the said Deasy Q. Candy
their Heirs and Assigns that P. am lawfully seized in fee of the Premises; that
they are free of all incumbrances;

Deasy Q. Candy
to hold as aforesaid. And that P. and my heirs shall and will warrant and defend
the same to the said Deasy Q. Candy their Heirs and Assigns forever
against the lawful claims and demands of all persons.
