Dr. Adrian Ebell was a noted German scholar who saw the time had come in the world's history when a thinking woman was a necessity—a womanhood to meet and solve various questions which the stress of the age was presenting for solution more and more insistently. Realizing woman's limited opportunities for development along scientific lines he labored to establish an international academy with chapters all over the world. While traveling in America in 1876 he formed the first chapter, the Oakland Ebell. It is after this finely organized club that the Ebell of Los Angeles is modeled, consisting of a central organization with departments for study and advancement in all lines of general culture.

Annual Report

The closing of the 12th year of Ebell also closes one of the most eventful in its history. On the morning of July 31 the dream of years became a reality when the corner stone of our new club house was laid. During the long summer months the Directors of the Building Association remained faithfully at their post, hoping to have the Auditorium ready for the first meeting in October. Unavoidable delays prevented its completion and it was finally thought wiser to wait until the entire building was ready before we attempted to take possession. Through the courtesy of Mr. and Mrs. Gregg the Club was made to feel thoroughly at home in the beautiful Cumnock until December, when the first meeting was held in our own Club House on the first Monday and the formal opening was the occasion of a brilliant housewarming given by the Club and the Building Association on the evening of January 9.

Too much cannot be said in praise of the Directors of the Building Association. Theirs was a labor of love. It was due to their concentration of energy and untiring efforts that the Ebell has a suitable home of its own. A word of appreciation is due Mrs. M. L. Moore the chairman of the furnishing committee. With the assistance of Mrs. Seymour Locke the interior was made artistic and harmonious, and the \$3,000 set aside for the furnishings was judiciously used. Through the sale of the lot on Hope street the Club received a profit of \$5,500 which was used to purchase stock. The club now owns 132 shares in the

Club House and with the furnishings represents a property value of \$22,000. The Club has been the recipient of many beautiful and valuable presents including books, pictures, furniture, bric-a-brac, plants, china, silver, money and stock in the Club House. The gifts not only add to the beauty and comfort of our home, but show the love and loyalty of the members.

The Ebell now has 850 active members, fourteen life memberships have been taken and to the list of honorary members have been added Mr. B. R. Baumgardt and Mr. Sumner P. Hunt, who have always taken an active interest in the Club's welfare. Since January two of our beloved members, Mrs. M. E. Galusha and Mrs. C. A. Canfield, have been called to the great beyond.

The real work of the Ebell lies in its Departments which consist of Art, Literature, Music, Education, Science and Home. On the first and third Thursdays in the month a large number of the members interested in Art and Travel met under the leadership of Miss Alice Mitton, studied the Italian masters and their work in Vienna, Pisa, Florence and Rome. The work has been of great interest and value as the class had access to Miss Mitton's rare and large collection of prints.

The second and fourth Thursdays were devoted to the study of Shakespeare with Mrs. Emma Greenleaf. A careful consideration was given to three of the plays. Mrs. Greenleaf delivered her lecture on the Tudors to the section which proved to be a rare treat.

The Book Section was organized on entirely new lines with Mrs. Sumner Hunt and Mrs. P. G. Hubert in charge. Books old and new, poetry, the drama and fiction were reviewed, the reviewers taking not the plot but the underlying thought or

problem as the main topic for consideration and endeavoring to find the vital lesson taught in each book. Browning, Ibsen, and some of the modern novelists were the authors considered. These delightful mornings were followed by a luncheon in charge of Mrs. T. T. Knight.

The Department of Science, popularly called the Round Table, was limited to twenty-five members. Modern, Scientific and Philosophical questions were discussed under the leadership of Mrs. C. N. Flint and Mrs. E. T. Pettigrew. Once a month Mrs. Flint threw open her hospitable home to these earnest students. After an hour of close study tea was served by Mrs. C. W. Lander. The topic chosen for the year was the Unity of Nature, showing how, "through the ages one increasing purpose runs and the thoughts of men are widening the process of the suns."

The French classes have met each week; under the able instructor, Madam B. de Clairbeau Wilson, the work has been both interesting and valuable. At the end of the year this section presented the Club with a beautiful French bronze.

Mrs. Mary J. Schallert has been Curator of the Music Department. On the third Thursdays of each month most instructive lectures on the History of Music have been given by Miss Helen Parcels, taking the music before the Christian era to the time of Palestrina and Luther. Fine musical programs were given by the members on the fourth Thursdays. The attendance has been large, regular and enthusiastic. Two excellent programs and many musical numbers have been furnished the open club meetings. Also a very fine lecture recital was given by Dr. Hanchette, the net receipts of which were given to the Grand Piano fund.

The department of Home met each Monday before the regular club meetings. The Club lost a very able and enthusiastic Curator when Mrs. Robert J. Burdette was compelled to give up the work through ill health. Her assistant, Mrs. W. R. Dickinson, took her place and has given through the specialists she secured most valuable information on pure foods and pure food legislation. Dr. Woodroffe and Mrs. C. A. Burcham have conducted a section of this department by having specialists give an hour to practical talks on hygienic subjects. The club owes a debt of gratitude to these speakers who are men active in the business and professional world. The information they have given has been so valuable that it is unfortunate every club member was not able to be present.

Mrs. Lou V. Chapin in her lectures on Current History has taken the Club into all corners of the world and has presented its social, industrial, commercial and political development. The programs have been varied and of a high order of excellence. The Club has been fortunate in securing several fine lectures during the year. Dr. George Kress on "The Great White Plague," Dr. Burt Estes Howard in a brilliant review of Gladstone. Prof. Frederick Munson on the "Prehistoric Dwellers of the Southwest." Miss Myra Reynolds showed from rare old prints the men and manners of the Eighteenth Century. A lecture full of pathos and quaint humor on the "Uses and Abuses of Christmas" by Rev. Robert J. Burdette. Mr. B. R. Baumgardt on "The Latest from the Heavens," showing the wonderful strides made in photography. The Club has enjoyed a number of fine musical programs: "a Shakespearean song cycle; 'An Afternoon with Edvard Grieg'; a Chopin recital by Mr. Peje Storck; Mr. Tom Karl, Miss Heartt and Miss Goodwin in a

program of Spring music and a delightful musicale by two of our members, Miss Jean Wakeman and Miss Maud Reese Davies.

We were given an interesting afternoon on Education by Prof. Gates and Prof. Francis; through stereopticon views we have been transported to palmy Hawaii, with Mr. M. H. Flint; to Rome with Fraulein Stolle, and have seen the mighty fjords of Norway and the ruin and desolation of San Francisco with Mr. B. R. Baumgardt. Longfellow's Hiawatha was read by Mrs. Merrill M. Grigg with an accompaniment of weird Indian music played by Miss Coleman. The Hanfort Dramatic Club presented George Eliot's play, "Armstrong," preceded by a scholarly appreciation of the author by Mrs. Eliza Tupper Wilkes. At the last open meeting of the Club Miss Constance Crawley and her company presented an episode from Hamlet and the balcony scene from Romeo and Juliet.

The children of the Club members at their annual Christmas party entertained the children of the Day Nursery with a program of music and living pictures followed by a gaily dressed Christmas tree laden with gifts and later were taken upstairs where refreshments were served. Large cases of toys were also sent to the College Settlement and the Church of the Neighborhood. Fifty dollars were given towards pictures for the new Polytechnic High School; \$25.00 to the Student Girl's Home in Berkeley.

When the great disaster occurred in San Francisco through the Club and its members \$550.00 were subscribed and several large cases of clothing, food and household linen were sent to relieve the sufferers.

In April, an Arts, Crafts and Loan Exhibit was held lasting three days. It was most satisfactory from an artistic standpoint.

Many rare and beautiful things were seen in the Japanese, Indian, Spanish and Colonial exhibits, but nothing excited more pleasure and surprise than the fine work exhibited by our pupils in the public schools. The Arts and Crafts Societies of Los Angeles, Santa Barbara and San Francisco showed much beautiful work done by their members that was rich in the promise of California becoming an art center. Many informal teas and luncheons have been given during the year which serve to bring the members closer together and create a fraternal spirit that strengthens the growth of the Club.

A card party given in February for which a small admission was charged paid for the upright piano.

The Club closed on June 21 with the Annual Breakfast.

Articles of Incorporation

Know all Men by these Presents, That we, the undersigned, a majority of whom are citizens of the State of California, have this day voluntarily associated ourselves together for the purpose of incorporating under the laws of the State of California an association, and in pursuance of said purpose we do hereby adopt these articles of incorporation, and

We do Hereby Certify:

First—That the name of this corporation shall be

“The Ebell of Los Angeles”

Second—That the purposes for which it is formed are for advancement in all lines of general culture.

Third—That the place where the principal business of this corporation is to be transacted is in the City of Los Angeles, County of Los Angeles, State of California.

Fourth—That the term for which said incorporation is to exist is fifty (50) years from and after the date of its incorporation.

Fifth—That the number of Directors of said corporation shall be seven and that the names and residences of the Directors who are appointed for the first year and who are to act until their successors are elected and qualified, are as follows:

Sixth—That the said corporation has no capital stock.

Seventh—That pursuant to a call therefor, this association was organized at a meeting duly held at 1054 Flower street, in the City of Los Angeles, County of Los Angeles, State of California, on the twenty-sixth day of June, A. D. 1897; and it was then and there resolved to proceed to incorporate this said association; and an election was then and there duly held for the election of Directors of this said corporation; that a majority of the members of the said association were then and there present, and voted at the said election, which said election resulted in the choice of the above named Directors of the corporation; all of which is more particularly set forth in the certificate and verification by the officers conducting the said election, hereto annexed, and made a part and portion of these articles of incorporation.

By-Laws

Article 1

The incorporate name of this society shall be the Ebell of Los Angeles.

Article 2

The object of the Society is advancement in all lines of general culture.

Article 3

The officers of this society shall be a President, three Vice-Presidents, a Corresponding Secretary, a Recording Secretary, a Treasurer, and a General Curator. These officers with its Board of Seven Directors (one of whom shall be the President) shall constitute the Executive Committee.

Article 4

Powers and Duties of Directors

Section 1. The powers of this corporation, except as herein otherwise provided in the By-Laws, are vested in the Board of Directors.

Sec. 2. The Board of Directors shall consider and control all permanent matters, i. e., financial investments, disbursements, and all established matters that pertain to the life, welfare, and methods of the Society.

Sec. 3. The Directors shall appoint their own Secretary from their number.

Sec. 4. Resolutions passed by the Directors shall be handed in writing to the Executive Committee to be entered on their minutes.

Article 5

Section 1. The Executive Committee shall arrange and control the current affairs of the Society, receive the reports of all committees and act upon them. The chairman shall reports matters of general interest at the business meetings and at the annual meetings of the Society.

Sec. 2. The Executive Committee shall incur no indebtedness beyond the necessary current expenses of the Society.

Sec. 3. Five members shall constitute a quorum.

Sec. 4. Any vacancy occurring in the Executive Committee shall be filled by the Board of Directors.

Sec. 5. The Curators of the Sections shall constitute an Advisory Board to be called upon when required by the Executive Committee.

Article 6

Duties of Officers

Section 1. The President shall be chairman of the Board of Directors and of the Executive Committee; shall preside at all meetings, call all special meetings, appoint all committees, sign all bills authorized by the Executive Committee, and make an annual report.

All appointments of committees made by the President shall be subject to the ratification of the Executive Committee.

The President shall exercise supervision over all the affairs of the Society and shall be an honorary member of all committees. In the absence or disability of the President, her duties shall be assumed by the Vice-Presidents in the order of their rank. In the absence of the presiding officers, if a quorum is present, a temporary chairman may be appointed.

Sec. 2. The First Vice-President shall be chairman of the Program Committee.

The Second Vice-President shall be chairman of the House Committee.

The Bell of

The Third Vice-President shall be chairman of the Membership Committee.

Sec. 3. The Corresponding Secretary shall be ex-officio chairman of the Printing Committee, and shall attend to the correspondence of the Society, and issue all notices except notices to proposed members. She shall see that each new member signs the By-Laws and shall keep a list of the Charter Members. She shall assist in the preparation of the year book.

Sec. 4. The Recording Secretary shall keep the minutes of the meetings of the Society, and of the Executive Committee, furnish a report of the membership to the Corresponding Secretary when called upon, and shall submit a report at the annual meeting, sign all bills and corporation papers. She shall hand to all committees their instructions in writing.

Sec. 5. The treasurer shall have charge of all the funds of the Society; shall pay all bills audited by the Executive Committee; shall submit a report of all receipts and expenditures monthly to the Executive Committee and annually to the Society and to the Board of Directors when called upon. She shall give a bond for the faithful performance of her duties to the Society in such sum as the Board of Directors may require, which bond shall be executed by some reliable security company. The cost of obtaining said bond shall be defrayed by the Society.

Sec. 6. The Curator shall keep posted upon the Bulletin Board in the rooms of the Society a statement of the time and place of all Section meetings, and any information which may be of general interest to the members of the Society. She shall ascertain which section a new member desires to enter. She shall receive application for the formation of new sections, and shall keep herself informed of the general character of the work of each section, reporting the same to the Executive Committee monthly, and make reports of the same at the annual meeting of the Society. She is also ex-officio chairman of Committee on Sections.

Sec. 7. A Clerk shall be engaged by the Executive Committee, who in addition to her duties as Clerk, shall act as Librarian

and Custodian of the property of the Society. She shall keep an inventory of all such property and deliver the same to her successor in office, requiring from her a receipt. She shall give a bond similar to the Treasurer's for the faithful performance of her duties.

Article 7

Standing Committees

Section 1. Chairmen of the Standing Committees shall be members of the Executive Committee.

The Standing Committees shall be:

1. Committee on Membership;
2. Committee on Printing;
3. Committee on Programs;
4. Committee on Sections;
5. House Committee.

Sec. 2. The Committee on Membership, upon receiving the properly endorsed names of applicants for membership from the President, shall act upon the same and report at the next regular meeting of the Executive Committee; shall receive and act upon all resignations before reporting to Executive Committee.

Sec. 3. The Committee on Programs shall see that a program is provided for each regular meeting of the Society.

Sec. 4. The Printing Committee shall attend to the necessary printing of notices, membership cards, blanks, bulletins, etc., and the year book.

Sec. 5. The Committee on Sections shall assist in the organization of Sections and advise the Curator of Sections in arranging their course of study.

Sec. 6. The House Committee shall have charge of all social occasions, buy all house supplies ordered by the Executive Committee and supervise the building and its contents.

Sec. 7. It shall be the duty of all committees to assist the Executive Committee. They shall meet on the first Monday of each month and shall report in writing to the Executive Committee.

Article 8

Members

Section 1. An applicant for membership shall sign blank provided. Her name shall be endorsed by three members in good standing and of more than one year's membership. This application shall be handed to the Membership Committee. Upon receiving the endorsement of this committee, and having been posted for two weeks, it shall be voted upon by the Executive Committee at their next meeting. All applicants shall be personally known to their endorsees.

The notice of acceptance shall be sent to the proposed member by the Clerk, together with bill for admission fee and half yearly dues.

No member of the Society may sign more than three applications for membership during one year.

Sec. 2. Complimentary members may be elected for the current year who may have the privilege of attending the open meetings but not business meetings. They shall not be required to pay admission fees or dues. They shall have no interest in the management, property, or assets of the Corporation.

Sec. 3. A non-resident may become an associate member for the current year by having her name duly presented and upon the payment of the annual dues. She shall have no interest in the management, property, or assets of the Corporation nor be privileged to attend business meetings. She may become a regular member at any time by the payment of the initiation fee.

Sec. 4. Election to membership shall be forfeited unless confirmed by the payment of the admission fee within one month after notification of election as a member. A lapsed or forfeited membership may be restored by the Executive Committee upon the unanimous vote of the Committee on Membership.

Sec. 5. Any member may resign at any time upon the presentation of such resignation in writing and the payment of all back dues.

Sec. 6. Each member of the Society must sign the By-Laws before she shall be entitled to any of the rights or privileges of membership.

Sec. 7. Honorary life membership in this Society may be given by vote of Society in recognition of distinguished services. Such honorary membership shall confer all rights and privileges to ordinary membership without payment of dues.

Sec. 8. Members in good and regular standing who resign may upon application receive a resignation card stating their standing.

Article 9

Dues

Section 1. The admission fee shall be \$25.00.

Sec. 2. The annual dues shall be \$8.00 payable in advance; one-half on the first day of October, and one-half on the first day of March each year. Non-payment of dues for one year shall cause forfeiture of membership, but such members may be restored upon regular application and payment of back dues; if such application is made within eighteen months of lapse of membership.

Sec. 3. Any member paying \$100 shall receive a certificate of life membership and shall be exempt from payment of dues.

Sec. 4. The executive Committee shall have authority to remit the fees and dues of any member when it shall be deemed for the best interest of the Society.

Sec. 5. Members who may be absent from the city for one year or more shall pay half the annual dues.

Article 10

Meetings

Section 1. Excepting during the months of July, August, and September, a regular meeting of the Society shall take place

on each Monday at 2:30 p. m., at which Sections may report, papers be presented or business be transacted.

Sec. 2. On the first Monday of each month shall be held a business and social meeting of the Club for regular members only, at which time the Executive Committee may report on business transacted and bring new business before the Society.

Sec. 3. A regular meeting of the Board of Directors shall take place on the second and fourth Thursdays at 9:30 a. m.

Sec. 4. A regular meeting of the Executive Committee shall take place on the second and fourth Thursdays at 10 a. m.

Sec. 5. The semi-annual business meeting of the Society shall take place on the first Monday in January.

Article 11

Elections

Section 1. The annual meeting for the election of Directors and Officers for the ensuing year shall be held on the first Monday in June. No further notice of the election shall be *necessary*.

Sec. 2. Nominations for Directors and Officers shall be made at the regular monthly meeting on the first Monday in May.

Sec. 3. After nominations of candidates for Directors and all Officers are made, as above provided, a Committee on Nominations shall be selected, consisting of three members, two of whom shall be selected by the members of the Society at the same meeting at which nominations are made, and the third shall be named by the Executive Committee. It shall be the duty of this committee to forthwith notify each nominee of her nomination and ascertain which candidates accept, and which decline nominations, and when ascertained, they shall prepare the form of ballot, placing the names of the accepting candidates thereon, and make all other necessary and proper preparations for the annual election at the annual meeting.

Sec. 4. Elections shall take place by ballot, and a plurality vote shall elect.

Sec. 5. Two Directors to hold office for three years, shall be elected at each annual election. Officers shall be elected for one year. The President, by virtue of her office, is elected a Director for one year.

Sec. 6. No member shall be eligible for election to the same office for more than two consecutive terms.

Sec. 7. Installation of officers shall take place at the last regular meeting in June, and they shall enter upon their duties at the close of the year.

Article 12

Section 1. The Society shall be divided into Departments for the study of special subjects or the carrying on of different branches of work. Such Departments to be Art, Science, Literature, Language, and such others as from time to time the Society may deem advisable. (Amended April 7, 1902).

Rule. 1. All members of Sections must be members of "The Ebell of Los Angeles."

Rule 2. Members wishing to form Sections must apply to the Executive Committee through the General Curator.

Rule 3. Curators shall preside at the meetings of their Sections and plan a course of study and make an annual report of the work of the previous year when called upon to do so by the Executive Committee. Section Curators shall notify the General Curator of the dates when their Sections are to meet and when they adjourn for vacation. A Curator may appoint a secretary to assist her in the Section.

Rule 4. Sections have no power to organize or disband, nor to dismiss or appoint Curators, but may express a preference to the Executive Committee.

Rule 5. Sections may limit their number and close admission, by showing ability to keep their number complete. New sections

may then be formed based on the same line of work, bearing the same name and numbered according to order of formation, 1st, 2d, etc.

Rule 6. All members of Sections are required to perform their portion of work assigned by the Curators.

Rule 7. All Departments are open and free to all members of the Society. (Amended April 7, 1902).

Rule 8. No Section or any officer thereof shall have power to incur any indebtedness or liability binding upon the Society, but shall defray all its expenses not properly authorized in detail by the Executive Committee.

Article 13

Section 1. Copies of all papers read before the Society and in Sections shall be placed on file with the Curators and at the end of one year shall be placed under care and charge of Librarian.

Sec. 2. All papers shall be written on legal cap, on one side of the paper only and fastened securely at the top.

(Former Article XIII repealed and subsequent Article re-numbered, April 7, 1902.)

Article 14

All communications on business must be made in writing.

Article 15

Ten members in good and regular standing may in writing at any time request special action by the Executive Committee, which will include amendments, complaints concerning neglect of duty, or transcending of privilege by any officer or member, or concerning any other matter pertaining to the Society. The Executive Committee shall at once refer the Communication to the Board of Directors for immediate attention, after which it shall be referred back to the Society for final vote. In the case of

Los Angeles

amendments to the By-Laws a two-thirds vote of the Society is required. (Amended June, 1903).

Article 16

All meetings of the Society and of the Executive Committee shall be governed by Roberts' Rules of Order.

Article 17

The twenty-seventh day of October of each year shall be known as "Charter Day" commemorating the organization of the Society. A reception shall be given on this day, when the President of the previous year shall present the members of the Society to the newly elected officers.

Article 18

No notice of any of the stated meetings of this Society or of the Board of Directors or of any of the committees or other convening bodies of the Society, the time of holding of which are fixed by these By-Laws, need be given. Any of such meetings may be adjourned to a day certain, even though less than a quorum be present, and no further notice of such adjourned meeting need be given, and any business may be done at such adjourned meeting which might have been transacted at the original meeting. Notice of all special meetings must be given, either personally or through the mail, or by posting on the bulletin board for such reasonable time as the officer calling the special meeting may prescribe.

Article 19

Whereas the provisions of these By-Laws require the signature of each member of the Ebell Society and those who have already signed the By-Laws of the Society have, by such signing, bound

The Ebell

and pledged themselves to abide by the laws and regulations of the Society, therefore we do hereby, in signing the same, pledge ourselves also to abide by these laws and regulations.

The original By-Laws passed by the Executive Committee at the first regular meeting in September, 1898, and the foregoing revised and amended By-Laws adopted by resolution at the regular meeting of the Society held the 14th day of June, 1906, after the required reading, and in accordance with the rules of the Society and adopted by the Board of Directors at a regular meeting of the Board held the 14th day of June, 1906.

Membership Cards can now be obtained at the office upon payment of dues for the current term.

Attention to this matter in advance will save members the annoyance of waiting in line for their cards.

A non-resident may become an associate member for the current year by having

her name duly presented and upon the payment of the annual dues. This privilege shall be extended for one year only. She shall have no interest in the management, property or assets of the Corporation. She may become a regular member at any time by the payment of the initiation fee.

A non-resident may become a temporary member by having her name presented by one member in good and regular standing with the approval of the Chairman of the Membership Committee upon the payment of \$2.00 per month. She shall have no interest in the management, property or assets of the Corporation.

Art. VIII. Sec. 14.

The name of any member may be dropped from the roll of membership upon the written request of twenty-five (25) regular members in good standing and the approval by a majority vote of the members of the Executive Committee.

Art. XI. Sec. 7.

Amended by striking out the words "the close of the year" and inserting the following, "the first meeting of the Executive Committee in July." Section to read:

Installation of Officers shall take place at the last regular meeting in June, and they shall enter upon their duties at the first meeting of the Executive Committee in July."
