- GRAY, WARNER THORNTON: Pvt., Co. C. b. 77/34. Enl. Clarke Co., 4/1/62 (also as Rockingham Co.). Present, 11/1/62-12/31/62, had his own horse. Present, 1/1/63-2/26/63. Ab., 10/31/63-3/31/64, at horse hosp. Present by 4/30/64. Post war resident of Berryville. Suffered from exposure to cold, Sangster's Station, 12/17/63. d. 4/20/73. Bur. Berryville Baptist Church Cem., Berryville, Clarke Co.
- GREEN, JAMES LANE: Pvt., Co. E. Prior service, CS Navy, until wd., Drewry's Bluff, in the hand. Post war rosters show service in the Rockbridge Arty. Enl. Swift Run Gap, 4/27/62. Transf. temporarily to Inf. by order of Gen. R. E. Lee, 11/14/62. Present, 1/1/63-2/28/63. Adm. Gordonsville Hosp., continua fever, 6/15/63. Transf. to Hanover Junction Hosp., 6/15/63. Present, 9/1/63-10/31/63. Present, 10/31/63-3/31/64, detailed as a wagoner in the QM Dept. Transf. to Breathed's Batty., 4/22/64. Record also shows transf. to CS Navy. 4/15/64. Post war resident of Rockbridge Co. d. 12/2/64. Thought to be bur. at Wesley Chapel, Rockbridge Co.
- GREEN, JOHN B.: Pvt. Co. H. Ent. Frederick Co., 1/1/63. Present, 1/1/63.4/30/63, had his own horse up to 2/28/63. Present, 12/31/63-4/30/64. Cpd. Cedar Creek, Shenandoah Co., 12/8/64 (or 12/7/64). Sent to Harper's Ferry, W. Va., then to Washington D.C., 12/16/64. Confined at the Old Capitol Prison, 12/16/64. Transf. to Elmira Prison, 3/1/65. Confined at Elmira Prison, 3/3/65. Took the oath of allegiance and was released, 7/11/65. Desc.: age ?, 5'5", fair comp., dark hair and hazel eyes, a resident of Carlisle, Pa. Post war resident of New Orleans, La. NFR.
- GREEN, JOHN WILLIAMS: Co. D/Sgt. Maj. Prior service, Co. F, 1st Va. Cav.; clerk in the Ordnance Dept.; and Chew's Batty. Transf. to 11th Va. Cav., 8/31/63. Not on muster rolls. KrA. Jack's Shop, 9/22/63, struck in the throat, the ball passing out his right shoulder. He was partially buried on the field, James H. Williams, of Chew's Batty., discovered the body, which had been robbed. His body was taken to Gordonsville and then sent to Richmond.
- GREEN, JOSEPH: Pvt., Co. K. Post war roster only. NFR.
- GREEN, WILLIAM P.: Pvt., Co. G. b. Bath Co., c. 1828. Farmer, age 32, Millboro Springs, Bath Co. 1860 census. Enl. Bath Alum Springs, 3/31/62, Bath Cav. Co. Transf. to Co. G, 5/6/62. Present, 1/1/63-2/28/63, AWOL 1/14/63-2/21/63. Charged, not fried by 2/28/63. KIA, Upperville, 6/21/63. Widow filed claim 10/12/64.
- GREEN, ZACAHARIAH W.: Pvt., Co. E. b. c. 1842. Farmer. Prior service, Boliver Mills Co., Va. Militia, 6/2/61, and the 1st Rockbridge Arty. Transf. to Co. E, 11th Va. Cav. Ent. Swift Run Gap, 4/27/62. Employed by the QM Dept., 12/19/62-1/31/62, as a wagoner. Present, 1/1/63-2/28/63. Present, 9/1/63-10/31/63, bought a sorrel horse from the gov't. for \$100. Present, 10/31/63-3/31/64. Employed by the OM Dept., 1/10/64-2/24/64. Transf. to Breathed's Batty. (Shank's Co., Va. Horse Arty.), 4/22/64. Post war resident of Harrisonburg, Rockingham Go. NFR.
- GREEN, ZACHARIAH G.: Pvt., Co. G. b. c. 1847. Age 13, 6th Dist., Rockbridge Co., 1860 census. Prior service, Jr. Reserves, Rockbridge Co., 2/2/65. Enl. Co. G. 11th Va. Cav., Brownsburg, Rockbridge Co., 3/14/65. Desc.: age 16, 5'10", fair comp., light hair and blue eyes. Not on muster rolls. NFR.
- GREENE, HENRY A.: Pvt., Co. ?. Enrolled as a conscript at Camp Lee, near Richmond, 4/21/64 and was assigned to the 11th Va. Cav., 4/30/64, NFR.
- GREGG, OMAR G. V.: Pvl., Co. K. b. c. 1845, Eni, Berryville, 7/1/62 (or 8/31/62) [could be 1863]. Ab., 9/1/63-10/31/63, AWOL. Ab., 12/31/63-4/30/64, taken prisoner while at home AWOL, not yet exchanged. Arrested Newtown, 10/22/63. Confined at Atheneum Prison, 10/29/63. Desc.: age 18, 5'9", light comp., dark hair and gray eyes, a resident of Clarke Co. Transf. to Camp Chase, 10/30/63. Confined at Camp Chase, 10/31/63. Transf. to Rock Island, III., 1/22/64. Confined at Rock Island, III., 1/22/64. Eni. in US service, for frontier duty, 10/6/64, NFR.
- GRIGSBY, HENRY CLAY: Pvt., Co. I. Enl. Fairfax, 4/25/61 in Ball's Co., Co. A, Va. Vol. Cav. Not on muster rolls of the 11th Va. Cav. Provided a substitute for himself in the person of J. P. Carrigan, NFR.
- GRIGSBY, J. R.: PM., Co. I. Not on muster rolls. Provided a substitute for himself, in the person of George W. Rutter, NFR.
- GRIGSBY, P. C.: Pvt., Co. I. b. Fairfax, c. 1843. Prior service, 5th Va. Cav. Enl. Charlottesville, 11/1/62. Desc.: age 19, 5', florid comp., light hair and gray eyes, a lawyer. Ab., 1/1/63-2/28/63, sick, left in King William Co., by authority of the surgeon of the 5th Va. Cav. Ab., 1/1/64-4/30/64, AWOL. Served also as 1st Lt., 2nd Co. M, 62nd Va. Mtd. Inf. and in O'Ferrali's Battin. Va. Cav. NER.
- GRIGSBY, T. M.: 1st Lt., Co. I. Prior service, 5th Va. Cav. Enl. Fairfax, 4/25/61. 2nd Lt., Co. A, Va. Vol. Cav. Ab., Pvt., 1/1/63-2/28/63, AWOL. Cpd. Warrenton Junction, 1st Lt., 5/3/63. Confined at the Oid Capitol Prison, 5/6/63. Paroled there on 5/18/63. At Winchester, 7/15/63. Served as Capt., 2nd Co. M, 62nd Va. Mtd. Inf. and in O'Ferral's Battin. Va. Cav. Post war rosters show that he was not with the co. after his being cpd. at Alexandria in 1861. NFR.
- GRIGSBY, TAZEWELL: Pvt., Co. C. Post war rosters only. NFR.
- GRILLS (GRILLO), SALVADORE: Pvt., co. F. b. c. 1839. Prior service, 1st Co. A, 62nd Va. Mtd. Inf. Not on muster rolls. Cpd. 1/10/64 and confined at the Alheneum Prison. Took the oath of allegiance and was sent north. Desc.: age 25, 5'6", fair comp., dark hair and hazel eyes, a resident of Staunton. NFR.
- GRIM, ANDREW J.: Pvt., Co. D. b. Pa., c. 1830. Enl. Shenandoah Co., 4/20/62. Ab., 4/20/62-6/30/62, AWOL since 5/22/62. Ab., 1/1/63-2/28/63, detailed as wagoner in the QM Dept., 11/24/62. NFR.
- GRIM, L. T.: PM., Co. A. Prior service, 51st Va. Militia. Enl. Winchester, 10/7/61. Ab., 12/31/61-6/30/62, sick. NFR.
- GRIMES, DANIEL J.: Pvt., Co. K. Enl. Berryville, 11/6/62. Present, 11/6/62-2/28/63. Present, 9/1/63-10/31/63, had his own horse. Present, 12/31/63-4/30/64, had his own horse, appraised at \$825. Wd. Wilderness, between 5/4/64-6/3/64. Post war resident of Loudoun Co. NFR.
- GRIMES, GEORGE: Pvt., Co. K. b. c. 1846. Enl. Berryville, 11/6/62. Present, 11/6/62-2/28/63. Present, 9/1/63-10/31/63, had his own horse. Ab., 12/31/63-3/31/64, on detail, with leave. Present by 4/30/64, had his own horse, appraised at \$950. Cpd. Clarke Co., 27/65. Confined at Ft. McHenry, 2/11/65. Charged as being a guerrilla and was not to be exchanged during the war. Adm. USA Gen. Hosp., Ft. McHenry, 2/23/65, conjuctivitis. RTD. 3/1/65. Age given as 28. Adm. USA Post Hosp., Ft. McHenry, 2/20/65, lonsilitis. RTD. 3/26/65. Age given as 19. Took the oath of allegiance and was released, 5/1/65. Post war resident of Clarke and Loudoun Co's. NFR.
