MEMBERSHIP CANCELLED

Delinquency for three (3) months in the payment of dues or assessments shall automatically cancel membership in a local lodge of this Association and all rights, privileges and benefits incident thereto. The period of good standing membership of any person whose membership has been cancelled for delinquency or other cause shall date from the date of his last reinstatement in a local lodge, as shown by the Grand Lodge records, and his rights, privileges and benefits under the provisions of the Constitution shall attach and date from the date of his last reinstatement, as though he had never before held membership in a local lodge of this Association.

IMPORTANT

Every member should carefully study the Grand Lodge Constitution and especially the provisions governing retired and exempt members, transfers, unemployment and strike stamps, strike and victimized donations and death benefits.

ASSESSMENTS

In case of emergency local lodges may levy assessments on all members under their jurisdiction. No special assessment can be levied until the same has been approved by a two-thirds (%) vote of the members of the local lodge attending a summoned meeting, notice of which has been served in writing on each member, by mail or otherwise, at least seven (7) days before the date of the meeting. Every member present at such meeting shall vote unless excused by the president, and those not voting shall be recorded as voting in favor of the assessment.

All assessments and fines shall be due within thirty (30) days after levied. If not paid within that time the financial secretary shall notify those in arrears in writing, and should they fail to make payment within sixty (60) days from the date of such written notice, their membership shall be cancelled regardless of the date to which their dues are paid.
