last month. The agreement provides for pay increases for pilots flying present aircraft as well as for those who will fly the turboprop Vanguards and the turbojet DC-8's which TCA will put into service this year.

Captains flying in domestic service with piston aircraft will earn between \$10,000 and \$17,000 per year, the average being approximately \$14,000. The rates for DC-8 aircraft will be approximately 30% in excess of the top salary for flying piston aircraft. Only 17 TCA captains will be eligible for the DC-8 differential during 1960.

First officers will earn between 50% and 60% of captain's rates. They constitute slightly more than 50% of the airline's total strength of 725 pilots. The new agreement is for a period of 18 months and is retroactive to Oct. 1, 1959.

## Okanagan Honored

Okanagan Helicopters Ltd. last month was presented with the Lawrence D. Bell He'icopter Pioneer Award at the 12th annual meeting of Helicopter Association of America at Anaheim, Calif. ## Hunting Re-shuffle

## The Numbers Game

For the purposes of reporting statistical and financial data, the ATB has classified licensed Canadian carriers into five groups according to type of services provided and/or gross annual flying revenues. The reclassification has been effected by ATB Rule No. 12/60, which became effective Jan. 1 and supersedes Rule No. 11/59. The five classes are:


**Group I:** TCA, CPA, and every domestic or foreign carrier licensed to operate Class 8 international scheduled services from within Canada.

Group II: Every Canadian carrier licensed to operate Class 1 scheduled services (excepting TCA and CPA), plus Wheeler Airlines Ltd. and Nordair Ltd.

Group III: Every licensed non-scheduled Canadian carrier (except those classified as Group II) with gross annual flying revenues of \$400,000 or over.

Group IV: Every licensed non-scheduled Canadian carrier with gross annual flying revenues of \$60,000 and over but less than \$400,000.

Group V: Every licensed non-sched-
