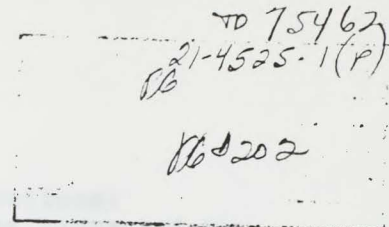


Dear Ms. Collette:


At long last the Department of National Defence has returned the Avro Arrow reports requested by you some time ago under the Access to Information Act.

With the exception of two pages in the report indicated as your #19 priority, the reports have been declassified and are available for your inspection in the Aero Library. You may wish to call Mrs. Joan Leonardo at 613-993-2757 to make arrangements to see them. The two pages referred to above have been severed under Section 15(1) of the Access to Information Act because they refer to US weapons systems that are still classified. (A copy of this section of the Act is enclosed.)

I regret that it has taken so long to make these reports available to you, and hope that they have arrived in time to be useful for your project.

As you are probably aware, you are entitled to file a complaint with the Information Commissioner if you are not satisfied with this response.


Dear Mrs. Deakin:

I refer to your letter of 27 May 1987 enclosing for review, under the terms of the Access to Information Act, 29 technical and engineering reports pertaining to the AVRO Arrow. For ease of reference, I have enclosed a copy of the same list you forwarded to us under cover of your letter of 27 May 1987.

I am pleased to inform you that they have been reviewed by officials of this institution and from a defence perspective we have no objection to disclosure of those (reports) numbers 4-9, 12-18, 21-24, 32, 35, 37 and 38. In regard to report number 19 it is recommended that pages 93 and 95 be severed and exempted pursuant to section 15(1) of the Access to Information Act. With the exception of the aforementioned pages, e.g. 93 and 95 of report 19 which refer to US weapons systems which are still classified, the appended reports have been declassified, properly annotated, and are returned to you for disclosure.

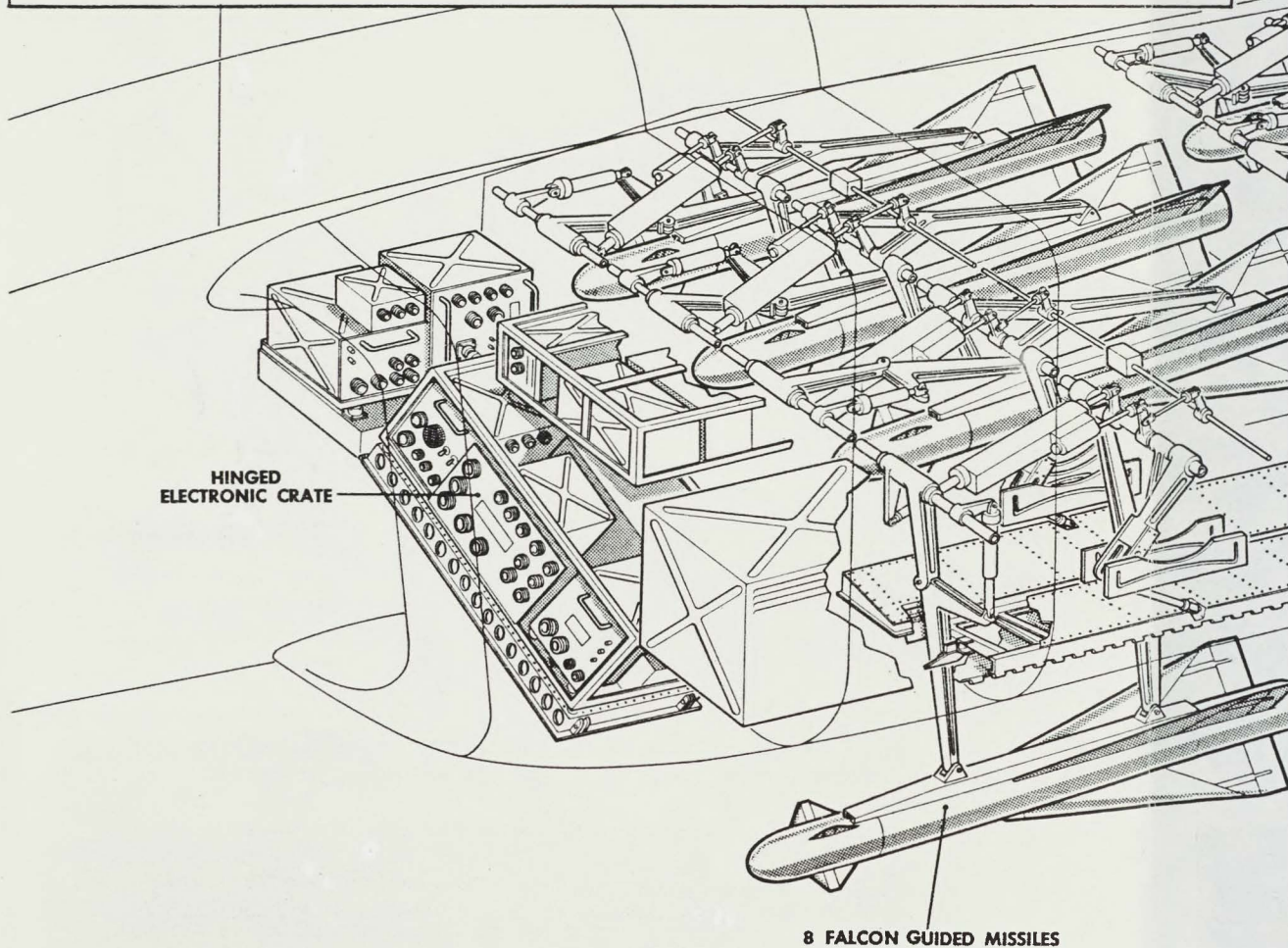
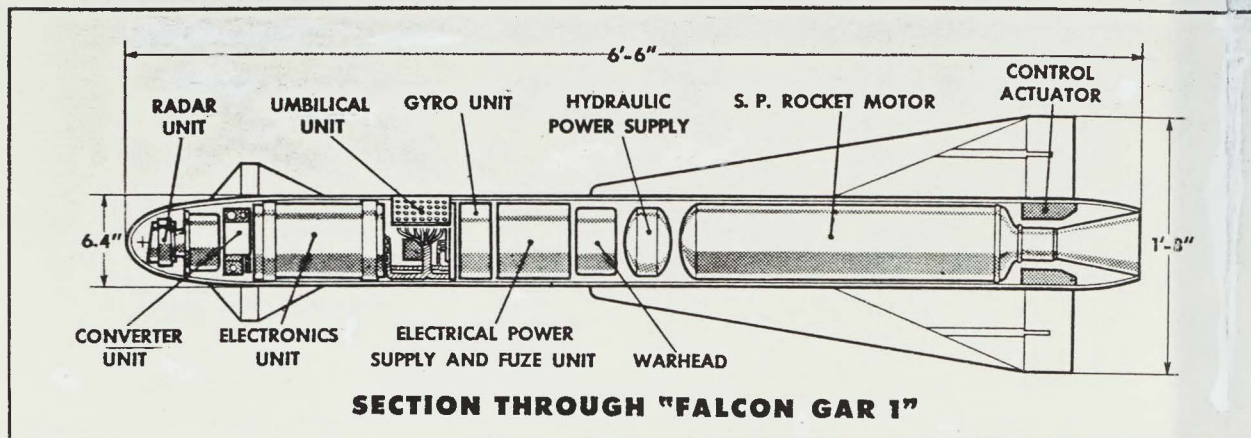
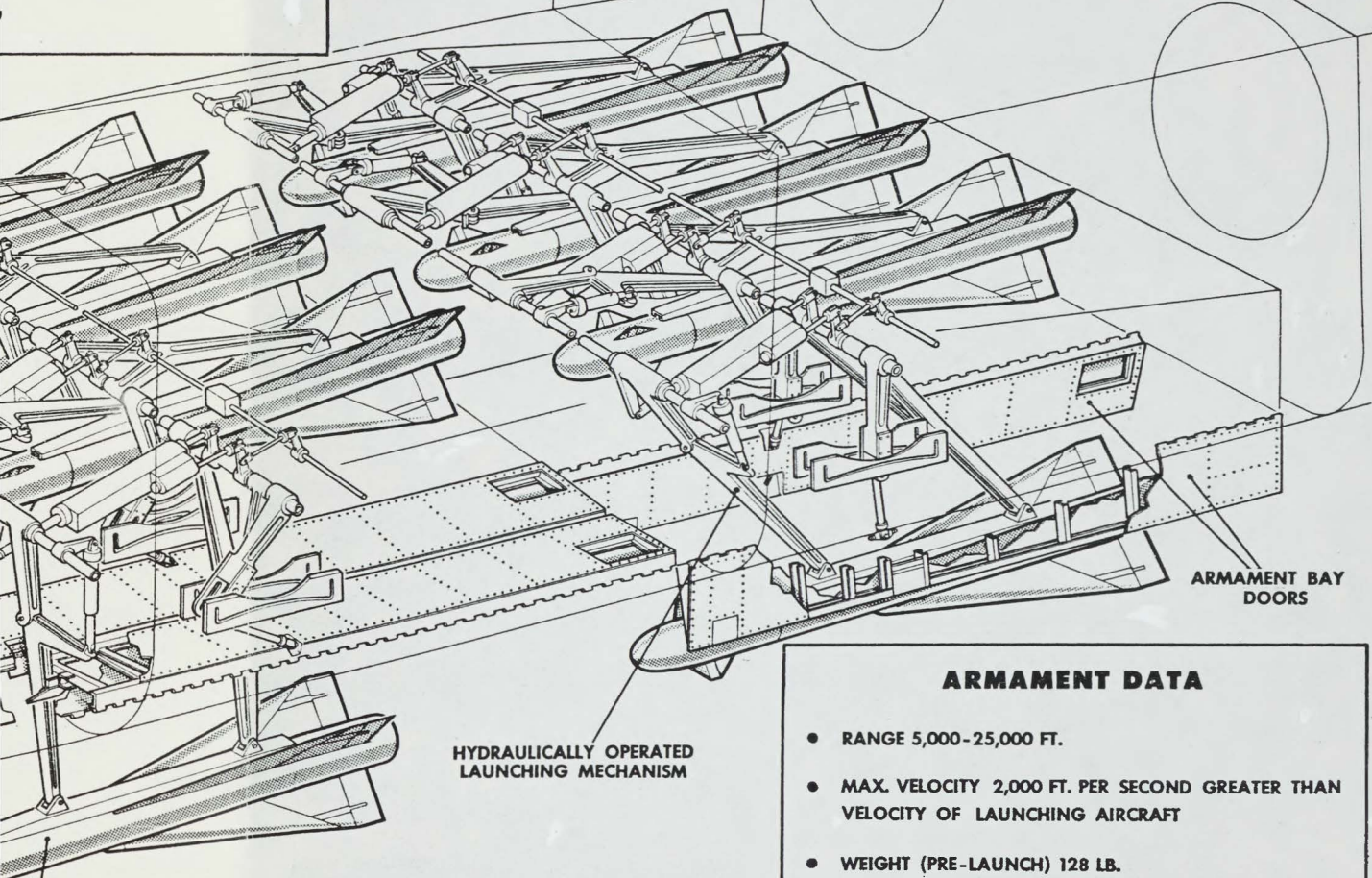
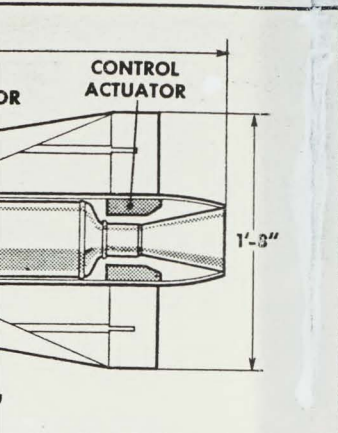
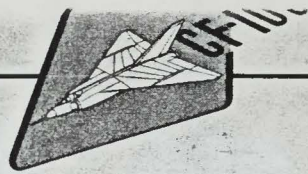


FIG. 37 ARMAMENT AND ELECTRONIC EQUIPMENT

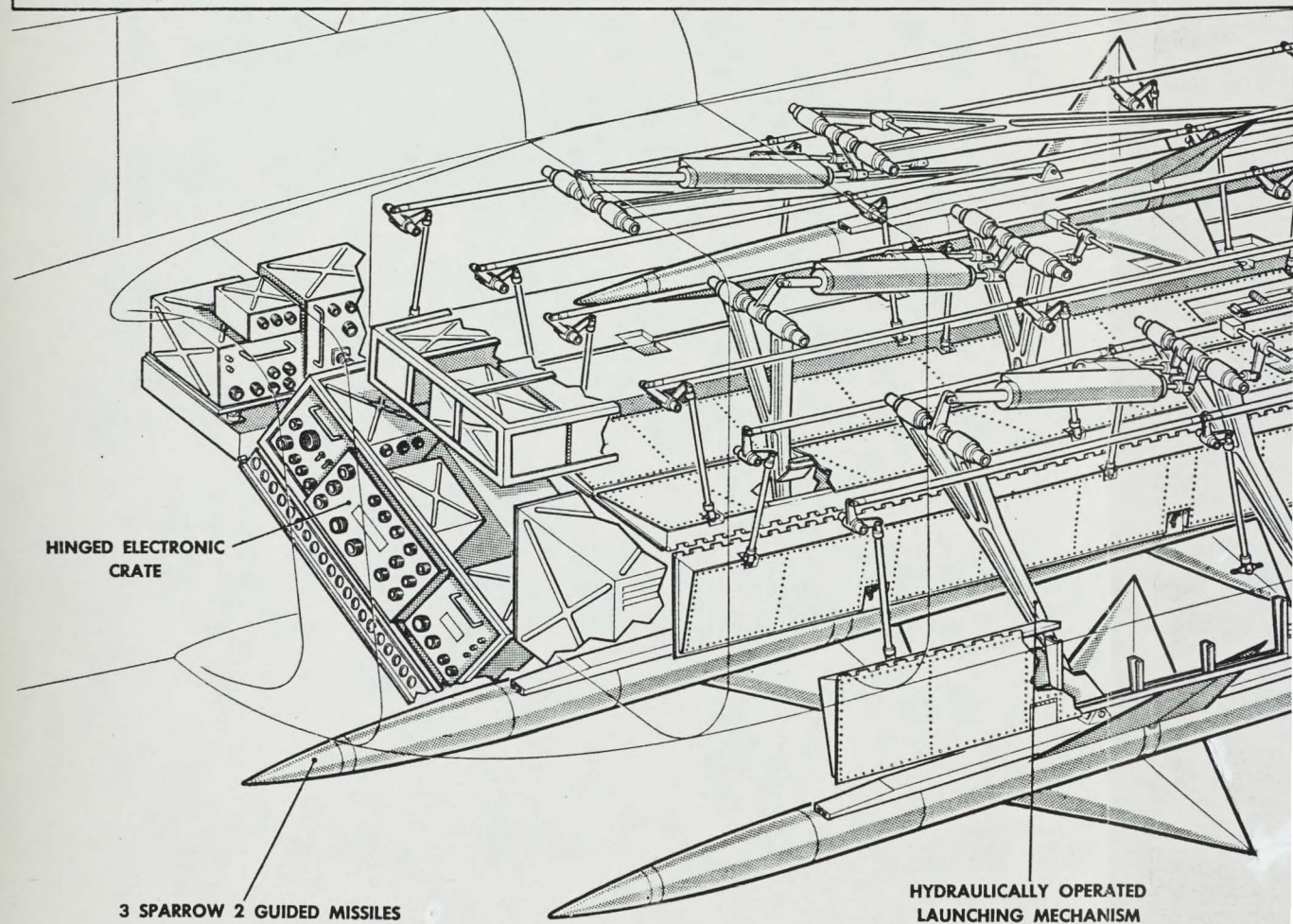
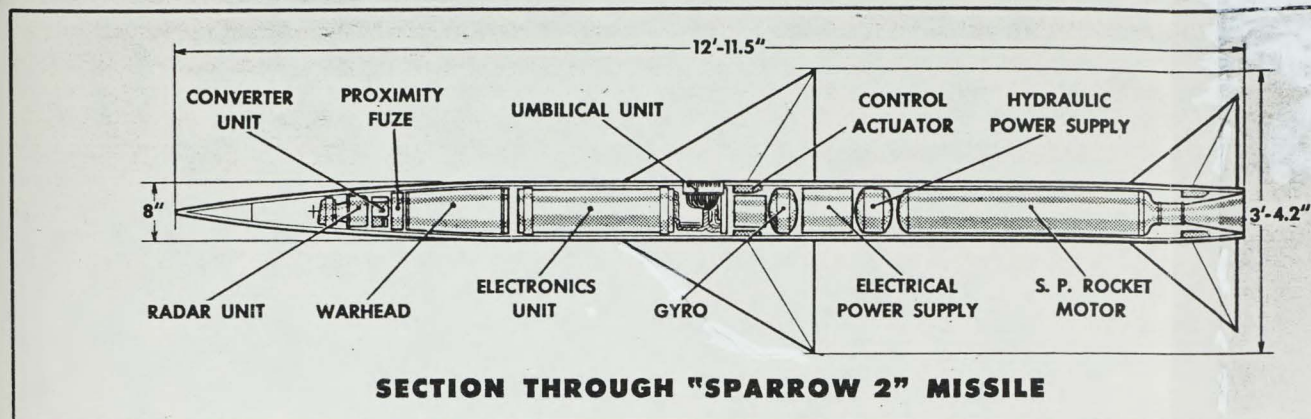
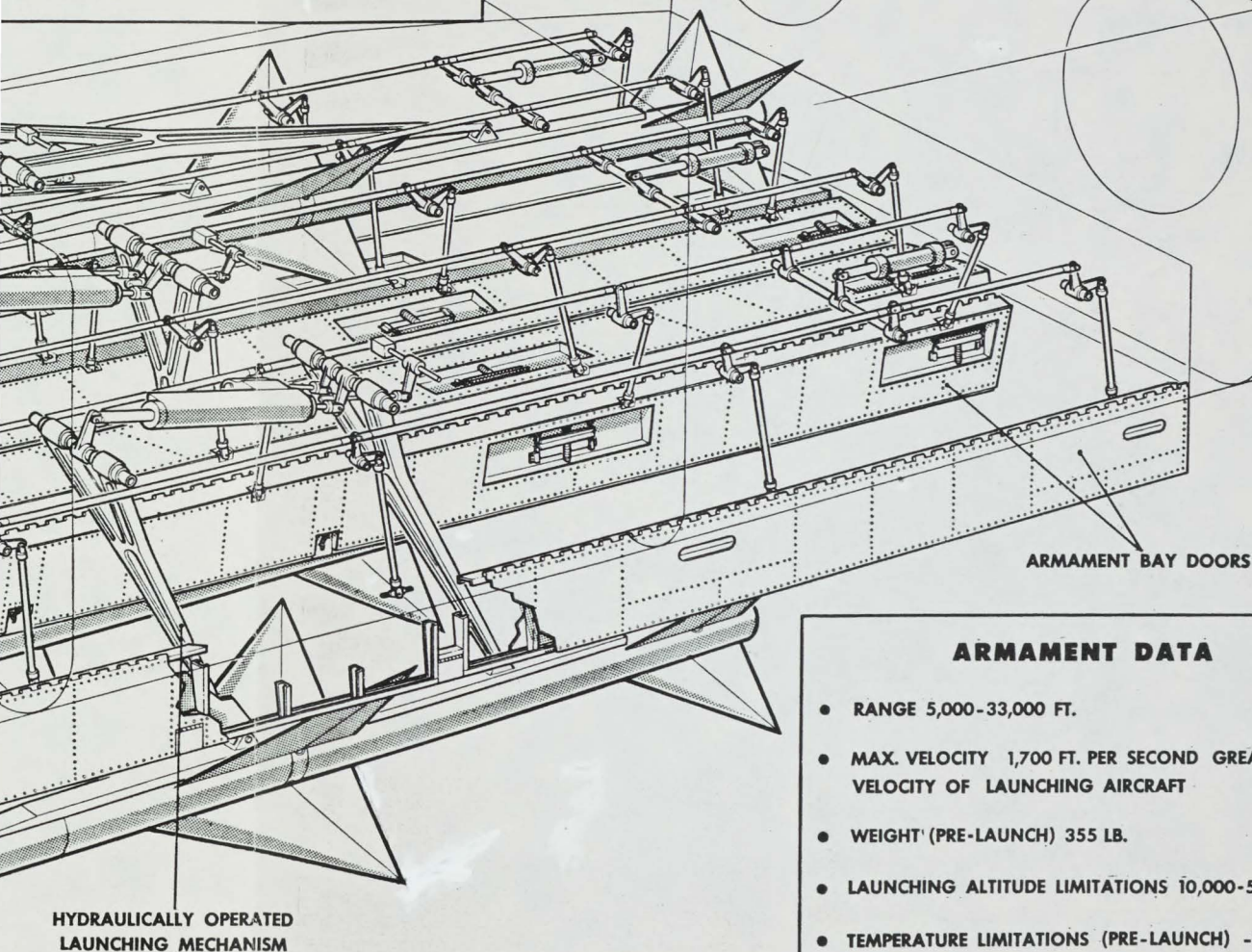
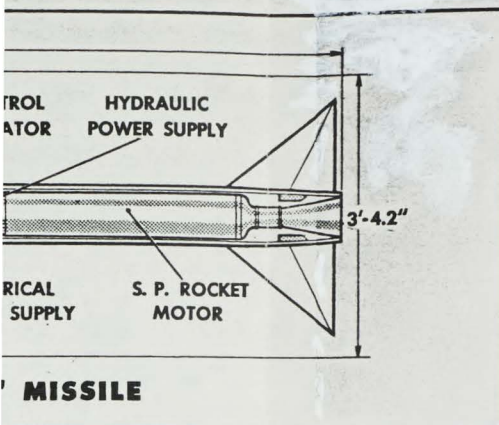
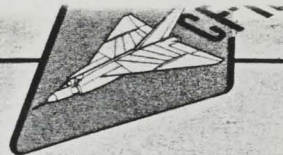


FIG. 38 ARMAMENT AND ELECTRONIC EQUIPMENT IN
