• **David Boyd, OBE, BSc, FCAI**, newly-elected president of the Canadian Aeronautical Institute for 1960/61, started his term of office at the Institute's annual general meeting on May 24. Mr. Boyd is works manager for Rolls-Royce of Canada Ltd., Montreal.

He first became concerned with aviation in 1938 when he was appointed general works manager of Canadian Car & Foundry Co. From 1942 to the end of the war, he was general manager of Victory Aircraft Ltd.

• **William F. English**, one of Canada's commercial aviation pioneers and former TCA vice president, operations, died last month. Born and educated in Toronto, Mr. English joined TCA in an executive capacity when the airline was formed in 1937. He played a key role in the company's development from a relatively small domestic carrier to one of the world's largest airlines.

During the years of WW II, Mr. English contributed greatly to the organization and operation of TCA's part in the National Defence effort, including the operation of the Government's Trans-Atlantic Air Service. He retired from TCA in September 1956.

• **John C. Morrison** has been appointed director of the newly established Emergency Supplies Planning Branch of the Department of Defence Production.



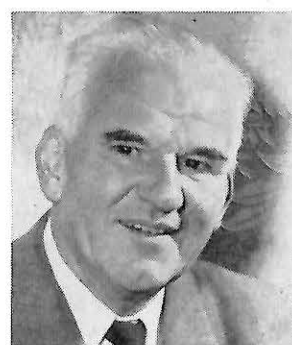
