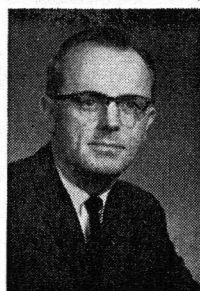

Twin Otters for military

An order for four DHC Twin Otters makes the Royal Norwegian Air Force the second military service to choose the PT6 turbine powered STOL twin for light transport and liaison work. The Chilean Air Force is already operating Twin Otters and has ordered a total of eight.

More F-5s for Norway

Norway has ordered an additional 16 Northrop F-5 tactical fighters, bringing their total to 80 aircraft. In all, 15 allied nations, including Canada, plan to acquire the F-5 for their defence forces. Canadair Ltd., Montreal, will build 115 for the Canadian air force.
