## NAMES IN THE NEWS


Wilbert Jamieson Matthews, QC, chairman of the Air Transport Board since 1954, died in Ottawa September 2nd. Born in Port Arthur in 1899, Mr. Matthews attended McMaster University and the University of Toronto. He was called to the Bar of the Province of Ontario in 1924 and practiced law in Port Arthur and Toronto from 1924 to 1936.

He was appointed assistant counsel of the newly formed Department of Transport in 1936. Three years later he was appointed counsel of the Department and in 1949 was made director of administration & legal services. In July, 1954, he was named chairman of the Air Transport Board, a post which he held until his death. He had been ill since mid-summer when he suffered a serious heart attack.

James B. Turner has been appointed sales manager for MEL Sales Ltd., Arnprior, Ont. Formerly on the sales staff of Computing Devices of Canada Ltd., and Measurement Ltd., he is well known in the industry.
