

—NAMES IN THE NEWS

CPA recently announced two appointments to top flight operations posts:

Capt. Harvey H. Johnston, formerly superintendent of flying, has been appointed director of flight operations.

W. Arnold Andrew, previously manager of flight technical services, has been named assistant director.

William M. Keddie, M.Sc., has joined the Renfrew Electric Co. Ltd., as general manager. A retired RAF group captain, Mr. Keddie was until recently vice pres., engineering, of Renfrew Aircraft & Engineering Co. Ltd.

H. P. Illsley, of Montreal, has been elected president of the Air Cadet League of Canada. Mr. Illsley, one of the group responsible for the formation of the League in 1940, succeeds **J. G. LeDroit**. The election was held at the annual meeting at the Seignior Club.

R. F. Hunt, president of Dowty Equipment of Canada Ltd., has been appointed deputy chairman of Dowty Group Ltd., with headquarters in Cheltenham, England. The post is a new one in the Group.

Rolls-Royce of Canada Ltd. has announced the appointment of **A. M. Scott** to the newly-created post of chief engineer, Aero Division. **K. J. Bhole** is named to Mr. Scott's former post as sales manager, Aero Div.

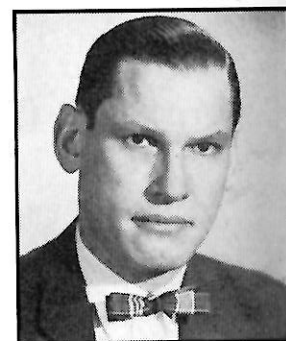
