INTRODUCTION

TO: THE HONORABLE CITY COUNCIL AND CITIZENS OF THE CITY OF GULFPORT

This is the third annual report requested by City Council and prepared by the Administrative Services of the City of Gulfport.

The purpose of this report is to bring to you, as official representatives of the citizens of this City, general information on the status of the City our accomplishments, and our aspirations for the future.

This year's report is a departure from the former reports in that we are concentrating on problems we have overcome and many we still face. It is not intended this year to cover activities of each department separately. We have done this for the past two years. We will detail the net costs and results of our Capital Improvement Program now underway and due for completion by early 1960.

The record of your City Council and of all public employees during the past year has been exemplary. The turmoil of a massive sanitary sewer construction program has strained every City resource to cope with adverse weather conditions, restoration of streets, alleys and re-beautification and the problem of maintaining basic municipal services such as garbage and trash service.

We of the City's Administration are grateful for the many kind, understanding words and efforts on the part of City Council and citizens of the City who have adapted themselves to the adverse conditions and contributed their efforts in healing the scars of our improvement program.

This year the Annual Report is divided into four sections: 1. Who do you have working for you? 2. What is the City doing? 3. How much does it cost and where does the money come from? 4. What are the plans for meeting the needs of our citizens now and in the future?

We sincerely feel that if each resident of Gulfport would read this report, many questions of the City's operation will be answered and this will serve to assist us in bringing the best possible municipal government to the Citizens of Gulfport.

SECTION I

INTRODUCING YOUR CITY OFFICIALS

Immediately following this section of your Annual Report is a table or chart showing the Legislative and Administrative Chain of Command and responsibility. It places you, as voters and citizens, at the top of this organization. It is by your selection of a Mayor and City Council and holding them responsible for the entire City Government that you, the voter and citizen of this City, provide for Municipal Government.

We believe that as voters and citizens you want to know more about the officials you have selected and, in turn, the employees the City Council and Manager have selected to serve you.

Under a Council-Manager type of Municipal Government many people feel the office of Mayor has been reduced in statue, but contrary to general beliefs, this is not true. Your Mayor is a delegate of all the citizens of the City. He must assume leadership in Legislative Affairs of the City and must actively participate in advancing the progress of the City.



MAYOR JOHN ROBINSON is 29 years of age. He is an aggressive leader; married; three children; a graduate of St. Petersburg High School. He operates two leased shoe departments. He is active in the Gulfport Community Baptist Church and a member of the Gulfport Lions Club.




Councilman from Ward 1: Willard C. Norton age 61, actively operates a motel at 2802 Beach Boulevard. A Veteran of World War I.


City Council makes four appointments to fill key positions in the operation of your Municipal Government:

SECTION II

WHAT IS YOUR CITY GOVERNMENT DOING?

Your City Council is concerned with all phases of the operation of your City affairs. They are charged with the duty of passage of City Ordinances (your laws), and are responsible to you for what is to be accomplished and the operation of all the housekeeping services which are performed by the Administrator Services of the City.

The City Council meets regularly on the first and third Tuesday of each month at City Hall and, in addition, meets on each Thursday evening in open meeting prior to each formal meeting to discuss City affairs and prepare the agenda for formal Council action.

Your Council serves without pay and gives freely and conscientiously of its time and energy to serve you as citizens of this City. Their task is not easy, for City Business is Big Business and municipal services are vital to modern day living. We have all learned to rely upon them and accept the benefits of public facilities as part of our daily lives without much thought or cencern regarding what efforts must be expended to supply our needs. Your City Council plays a vital role in meeting your demands for urban living.


Ordinance permitting monthly billing of Water and Sewer Service Charges




WHAT IS IN THE FUTURE?

This report has been devoted to the expression of who is serving you, what have we been doing and, last but not least, what is it costing. It would not be complete unless we gave you an inkling of what Gulfport Officials are planning for the future, our needs and aspirations. Many of the projects are now under way, others in the process of study for formal activation.

To plan for future projects one must first analyze our needs and our ambitions for a better and more responsive City Government. Even more important, we must recognize our capabilities to finance capital improvements, set up a time table and establish a priority.

Your City Council has, for the past few years, placed first things first. They have been and are concerned with meeting basic service needs ahead of important, but nevertheless non priority, projects. What has been done to give proof of this Council activity?

First, the Sanitary Sewer and Water Improvement Project now in process and due for completion by early 1960. This project, at a cost of \$2,200,000, will provide sanitary sewers to every improved property and service adjacent to every unimproved lot within the existing City limits of Gulfport.



What has this done for you, Mr. and Mrs. Gulfport? It has given you assurance that a proper sanitation condition exists in the entire City. A modern sanitation system to protect your health and the generations to follow you. Likewise, the investment you have made has added real value to every home and vacant lot in the City. Your City's expenditure of \$2,200,000 has added over Five Million in real property values. This is progress no one can scoff at.

The water improvements, included in the project, have been designed to insure you a continued supply of water to your homes. How many have experienced the hopeless feeling of turning on the household faucet with no flow? Your City is concerned, and has taken steps to insure water pressures are maintained and, as a side effect, reduce your fire insurance rate. These things are in your future, Mr. and Mrs. Gulfport. We believe you will agree that your City Government is concerned with your personal well-being and welfare.

There are four basic necessities recognized by municipal officials which are required for modern urban living. Three of them are "put out of sight and out of mind" too often by citizens who want to be able to see tangible evidence of their tax dollar expenditures. The fourth is before them and citizens are more prone to accept it. The three out-of-sight expenditures are sanitary sewers, water service and storm drainage, all buried out of sight under our soil, but nevertheless necessary. The fourth is streets and sidewalks which must come after the former three as they are built on top. What is your Council doing about the two necessities you still lack?

Streets and Drainage: Your City Council has entered into a contract with Smith and Gillespie, our present engineers, to perform a study to provide Storm Drainage and a Street Improvement Program for the entire City.

This program is designed to provide adequate storm drainage, pave and curb all presently unimproved streets, curb our existing asphalt streets and, finally, resurface approximately twenty miles of existing brick streets with durable asphalt concrete.

This project, expected to exceed 11/4 million in cost, undoubtedly will be financed by a square foot assessment within drainage districts and a front foot assessment for street improvements, payable over a ten year assessment period.

Street Lighting: The 1959-60 Budget provides for new, improved street lighting on Beach Boulevard (55th Street) from Gulfport Boulevard to Boca Ciega Bay. These lights, already authorized, are the mercury vapor type now being utilized and installed on Gulfport Boulevard and 49th Street South during the past two years. In addition, all existing fixtures and twenty new lights of regular design have been authorized for 15th Avenue from 49th Street South west to Gulfport Boulevard.

Yacht Basin: The Yacht Basin, owned and operated by the City, has been experiencing rapid yearly improvements. The clean up of the east area adjacent to the boat basin is now completed. Seawall installed and additional boat facilities constructed, all with net income derived from



rent of boat slips, sale of gasoline etc. We anticipate a continuation of this progress if funds derived from the basin are permitted to be used for further improvements. The process is slow, but steady and most certainly in the correct direction. Existing plans call for complete seawalling, extension of slip and berth facilities and ever increasing activity. A profitable and worthwhile City project.

Gulfport Pier and Beach: At this writing of your Annual Report, a private contractor is busily engaged in restoring and making vitally needed repairs to your Municipal Pier. Another example of your City Council's interest in not only providing for your present and future needs, but protecting your City's capital assets. During the past two and one half years, more than \$50,000 has been expended in restoration of the Beach, the Gulfport Casino and now the Pier. The future? Who knows? We can all visualize magnificent improvements along our waterfront. A park, an Olympic Swimming Pool, an auditorium, hotels, etc. The citizens of this City will make the decision on what will be done. Your City Council has aided you in providing five acres of filled waterfront property. You own it. Your City Council, by vision and cooperative effort have built 58th Street from 28th Avenue South to the Bay, providing a north - south traffic artery from the heart of St. Petersburg to Boca Ciega Bay.

Parks and Playgrounds: Hoyt Field, lighted with modern mercury vapor lighting, can now be used by our youth more extensively than ever before. Continued cooperation between the City and The Andy Anderson Post

No. 125, American Legion can and will provide stands for adequate seating. Recreation to be enjoyed by a large segement of our citizens.


The new picnic area recently developed at the Yacht Basin will be expanded to provide additional recreational facilities and will include a sheltered, magnificent beach.


All City parkways and parks will continue to be improved. A system of lakes to be created in our Drainage Program will contribute immeasurably to City beautification.

These improvements in our City's future are all possible and involve real items we can visualize, tangible evidence of a City's progress. What about existing city services that we enjoy, or in some cases endure, from day to day—Police, Fire, Dust, Trash and numerous other city services?

Everything indicates that, as municipal services catch up with demands resulting from massive expansion of the City's population (3,000 in 1950. Estimated 10,000 in 1960), everyone will enjoy more prompt and responsive attention to meet their needs for urban living.

Police: The first important step was taken this year in expanding the City's Police Department from seven to twelve officers and providing our own vital radio communication system. No longer must we wait agonizing minutes to get a message through St. Petersburg's busy dispatcher to relay





information to our patrol cars; no longer must we leave the City without a single police officer on duty to protect you and your homes while the officer is escorting a law breaker to St. Petersburg's detention facilities. Your future in Gulfport has been made much safer with the services of a trained and adequate Police Force.

Fire: Your Fire Department will be equipped to meet your needs. As the City grows, so will the Department. If new equipment is needed and if full time Fire Department personnel is necessary to protect you and reduce your insurance, your City will respond, have no fear.

Dust Control: Unlike any other city in Pinellas County, your City has been waging a battle to control dust on unimproved streets. When will this end? When every street in the City is paved and dust free. Until that glorious day arrives, the battle against dust will continue. City Council has authorized oiling of all unimproved streets at the expense of the City's General Fund.

Garbage and Trash: The Garbage service providing for twice per week pick-ups was assumed by the City a bare year ago. This service will continue to maintain its excellent schedules.

Trash service will be improved as soon as we can provide more equipment and personnel, and even more important, a shorter haul for disposal.

New plans now under study are considering a bi-weekly pickup of trash, combined with household garbage, removing once and for all the ever present trash piles scattered along our City parkways and alleys. Our greatest contribution to this new and improved service will be your cooperation.

Laws and Ordinances: The codification of existing City Laws is now in process and is a process whereby each new law enacted is inserted into the code, providing more responsive action on the part of all City Officials in enforcing laws which are designed to protect all citizens from the abuses which can arise from urban living.

A new Zoning Ordinance now being prepared will modernize our private development with realistic use of land within our borders. At the same time, existing developments and private ownership will be protected from zoning changes now detrimental and "hodge podge" in magnitude.

We of the City's Administration and the City Council have faith and confidence in Gulfport and the people who live in it. If we appear enthused, it is because we see the opportunity, with your assistance, to make this a City we can all be proud to live, work and retire in.

GENERAL INFORMATION

City Employees are desirous of rendering prompt, efficient and courteous service. They are loyal, hard working people who appreciate a pleasant word or smile the same as you do.

Do not be impatient with the clerk trying to help you. The employee had nothing to do with making the ordinances, rules or regulations with which you may not agree.

Do not ask for special favors or treatment. To do so places officers or employees in an embarassing position, as partiality has no place in the administration of the City.

The employees of the Water and Sewer Department are not mind readers and can only act on the information given to them. Be sure to notify this department if you want the water service discontinued on a given date. The minimum charges continue if proper notification is not given. Be sure to notify by card or letter, allowing ample time for mail delivery, when you expect to return if water services was discontinued during your absence.

Remember City Hall is not open Saturdays or Sundays. Request turn-off or turn-on service so it can be done Monday through Friday, prior to 4 P.M. when the service men are through work for the day.

If your property is rented, be sure to inform the Water and Sewer Department of change of tenant. Correct billing cannot be made unless it is known when one party moves out and a new one moves in.

When renting your property, be sure to notify the Water and Sewer Department before the water is turned on so the usual \$10 deposit required from tenants can be obtained. This will protect you in part at least from the possibility of having to pay a delinquent Water and Sewer and Garbage bill incurred by your tenant.

If you sell your property, be sure to advise City Hall. Give name and address of new owner and date of title transfer; also ask for a reading of your water meter on the day you leave the property.

WATER, SEWER & GARBAGE RATES

Date of Billing:

Bills will be rendered monthly with the changeover from the present two months billing being made in November, 1959. The City is divided into sections for purposes of meter reading and billing so that each section has a different billing date.

Minimum Water Bill:

Minimum water bill on all bills rendered on and after December 1, 1959 \$2.00 for one month with water consumption of 2,000 gallons or less.

No water charge when water is turned off.

Consumption above the minimum is on a graduated scale, beginning at 55.75c per 1,000 gallons above the minimum of 2,000 gallons.

15 to 31 days considered as a month.

Sewer Service Charge:

- \$2.50 per month for one living unit with kitchen facilities plus 15c per 1,000 gallons of water used in excess of 2,000 gallons.
- \$1.25 per month for each additional living unit with kitchen facilities being served from one water meter.
- \$1.25 per month "Sewer Service Standby Charge" for one living unit with kitchen facilities when the water is turned off for a period exceeding fifteen days and 60c for each additional living unit with kitchen facilities.

Garbage Service Charge:

\$1.75 per month for one family unit.

88c per month for each additional living unit on same water meter.

88c per living unit when water is turned off.

HOW TO DESTROY YOUR CITY!

In closing this 1958-59 Report, we would like you to read a quoted article from the Dawson (Ga.) News and was compiled by the Sedalia (Mo.) Democrat. An interesting observation is to figure how many of the ways apply to our own lives or to our fellow townman.

Don't pay taxes. Let the other fellow pay his. Vote against taxes. Then fuss because the streets are not kept up.

Never attend any of the meetings called for the good of the town. If you do, don't have anything to say. Wait until you get outside and then cuss those who made the suggestions. Find fault with everything that was done.

Get all the city will give you and don't give anything in return. Write unsigned letters to the editor demanding more for your tax money.

Talk cooperation, but don't do any work for your city unless you get paid for it. And by all means refuse to serve unless they make you chairman.

Never accept an office. It's easier to criticize than to do things. Accuse anybody who serves in an elected office of being a publicity seeker. (Or a crook.)

Don't do any more than you have to. When others willingly and unselfishly give their time to make a town better, howl because that town is run by a clique.

Don't back your fire department or your police department. If the firemen work to bring the insurance rates down, tell everybody that is what they are supposed to do. Don't thank them or the police for endangering their lives that you might have a safer town in which to live. Demand special treatment; raise cain if anybody expects you to obey traffic and parking laws.

Look at every proposition in a selfish way. If you are not the one who gets the most good out of it, vote against it. Never consider what it will do for the town as a whole.

Don't do anything for the youth of the town. Criticize them as potential delinquents. Keep your feet on them. Encourage them to move away when they grow up.

If you have good town leaders, don't follow them. Take a jealous attitude and talk down every thing they do.

Don't work on any committee. Tell them, "I'm too busy."

Don't say anything good about your town. Be the first to point up its short-comings. Pretend that if trouble comes your way it will be residents of some other town who will visit you while you are ill; bring in their department if your home is burning; comfort you if you lose a dear one; stand back of you in disaster.

And don't support your local retail stores and industries. Claim the prices and services in stores of other towns are better. Claim industry and its payroll hurts the town. But if you need a donation, ask your local stores and industries for it. Expect them to back you, but don't back them.
