

This indurture made this Twenty sixth day of November Eighteen hundred and fifteen between Jacob Baplat of Frederick county and state of Maryland of the one part and **Clotwotrhy Birnie** of the same county and state of the other part whereas the said **Clotworthy Birnie** hath sold to the said Jphn Baplat a certain negro woman slave named Bet about the age of twenty two years and her son colled King George about the age of ten months at t and for the sum of four hundred dollars, for the payment of which sum the said John Baplat hath passed his obligation to the said **Clotworthy** Birnnie the first whereof is payable with intent on the twenty sixth day of April Eighteen hundred and sixteen, the second on the twenty sixth day of April Eighteen hundred and seventeen the this on the twenty sixth day of April eighteen hundred and eighteen, and the fourth of the twenty sixth day of April Eighteen hundred and nineteen each of the said obligations being for the payment of one hundred dollars; and whereas the said John Baplat in order to seem the payment of the obligations above mentioned is willing to execute there presants now this indenture **withpath** that the said John Baplat for and in consideration of how the premises, and for and in consideration of the sum of one dollar current money to him in hand paid by the said Clothworthy Birnnie his executors administrators and assigns, one negro woman slave named Bet about the age of twenty two years, and her son called King George about the age of ten months to have and to hold the said negro slaves unto him the said Clotworthy Birnnie his executors administrators and assigns to the only proper use and behoof of the said Clothworthy Birnie his executors administrators and assigns forever, provided always and these presents are upon this condition that if the said John Baplat his executors or administrators, shall and do well and truly pay on cause to be paid unto the said Clotwrthy Birnie his executors, administrators assigns the said sevrsl sums of money by the aforementioned obligations seemed to be paid, at the several times in the said obligation mentioned, and according to the tenor and effect of the same then and in such care there presents and every matter and thing here contained, shall () determine and be utterly said to all intent and purpose any thing herein contained to the contrary thereof in anywise notwithstanding
