Rather than offer books from his parents vast library to his siblings, he left them to his wife Alice and she proceeded to offer them at auction instead of giving to family.

Letter from Sybil Geiger, granddaughter Emilie Ethel Cohen (daughter of AA and Emilie G Cohen to Mr Hank Dunlop in response to an article he wrote about Fernside in the magazine of the Victorian Society in America. She states what she inherited from her grandmother Ethel, that was part of the Emilie Cohen Estate.
