STIPULATION TO MODIFY ORDER OF
MAY 23, 1979 AND ORDER OF NOVEMBER 23, 1979

It is hereby stipulated by Plaintiffs and by Defendants, through their attorneys, that the Orders entered on May 23, 1979 and November 23, 1979 are modified to the extent that:

a. The deadline for compliance with the United States District Court, District of Hawaii, Order of September 15, 1977, whereby Defendants shall identify, inventory, protect and submit for nomination to the Secretary of the Interior those sites on Kaho'olawe which appear to qualify for listing in the National Register of Historic Places is extended from June 17, 1980 to August 17, 1980.

b. The Defendants will, within thirty (30) days of the date of signing of this stipulation, obtain from their archaeology contractor, Hawaii Marine Research, Inc., a revision of the Multiple Resource Nomination Overview which recently was submitted to the Defendants by Hawaii Marine Research, Inc. Within thirty (30) days following receipt of this revised Multiple Resource Nomination Overview, the


Defendants will submit a Multiple Resource Nomination Overview to the Keeper of the National Register of Historic Places. The Defendants are not required by this stipulation to submit to the Keeper of the National Register of Historic Places the revised Multiple Resource Nomination Overview received from Hawaii Marine Research, Inc.; however, the Defendants will provide the Plaintiffs with the revised Multiple Resource Nomination Overview prepared by Hawaii Marine Research, Inc. when the Navy submits any Multiple Resource Nomination Overview to the Keeper of the National Register of Historic Places.


