June Term, 1921

On motion it is ordered that certain boundary lines of voting precincts number 1 and 2 of Mercer County, as heretofore established, to wit; Perryville Tell-gate and ~~Dixville~~ precincts, respectively, be and the same are hereby changed and ^{re-established} ~~re-established~~, so that the boundary lines of said precincts ~~shall be as follows~~ Number 1 and 2, as aforesaid, shall be as follows:-

Precinct Number 1 (Perryville Tell-gate),- Beginning at the Harrodsburg and Danville turnpike at the point of its crossing the Mercer and Boyle County line, and running thence westwardly with the Mercer and Boyle County line to the point of crossing the same by the Harrodsburg and Perryville turnpike; thence, north-easwardly, a straight *line* to point of intersection of the New Dixville turnpike with New turnpike ^{which intersection is near the place of James Davis;} running to Rose Hill; thence, a straight line to the residence of P. B. Leonard on the Old Dixville turnpike, ^{including it;} thence, with the old Dixville turnpike to old Hungate Tell-gate house ^{at intersection with} Harrodsburg and Mackville turnpike, excluding it; thence, northwardly a straight line to Simon Whitenack house on Harrodsburg and Cornishville turnpike, excluding it; thence, ^{to} eastwardly with the Harrodsburg and Cornishville turnpike to city limits of Harrodsburg; thence, with city limits of Harrodsburg to Harrodsburg and Mackville turnpike; thence, with city limits of Harrodsburg to Harrodsburg and Perryville turnpike; thence, with city limits of Harrodsburg to Harrodsburg and Danville turnpike; thence, with Harrodsburg and Danville turnpike to place of crossing by same of the Mercer and Boyle County line, the place of beginning;

Precinct Number 2 (Dixville),- Beginning at the point where ^{the} Mercer and Boyle County line is crossed by the Harrodsburg and Perryville turnpike, and running thence, westwardly with the Mercer and Boyle County line to the point where the same crosses Chaplin river at or near Robert ^{Bowles's residence,} ~~Bowles's residence,~~ including it; thence, a straight line to Wm. F. Bailey's on Dixville and Stewart turnpike, including him; thence, a straight line northwardly to Wm. Tyler's on Deep Creek turnpike, excluding him; thence, with said turnpike to intersection of the same with the Harrodsburg and Mackville turnpike; thence, eastwardly with Harrodsburg and Mackville turnpike to ^{intersection of} ~~old Dixville turnpike at Hungate Tell-gate house;~~ ^{old Dixville turnpike at Hungate Tell-gate house;} thence, with old Dixville
