HEROES OF AMERICAN HISTORY



Lee was descended from a renowned American family. His father was governor of Virginia. Two of Lee's relatives signed the Declaration of Independence and he himself married the great-granddaughter of Martha Washington. After the war Lee retired and accepted the presidency of Washington College, now called Washington and Lee University.

Lee was graduated from the Military Academy at West Point, returning to it later as instructor and then as superintendent. When the Civil War broke out, he was tendered the command of the Federal forces but refused the honor and offered his services to his native state, Virginia. It was through his excellent leadership and military skill that the Confederate States were able to stave off the Union forces for four years. Few generals have been as loved and respected by their troops as he was.
