I have paid on account of said purchase price the sum of \$ 29 00 cash, and I am to pay the balance as follows: \$ 230 each and every 2 weeks, until full amount is paid. To secure such deferred payments, I hereby relinquish unto the said TRIBBLE & PICKETT FURNITURE CO. all my right, title and ownership in and to said chattels to have and to hold the same until said indebtedness is paid, and in consideration that I will meet said payments promptly, and will safely keep said chattels and use the same with care at and that I will not remove the same therefrom, without their knowledge and consent first obtained, the said TRIBBLE & PICKETT FURNITURE CO. hereby permits me to hold said chattels for them and to enjoy the use of same, while in my possession, on the following conditions:

If I fail to pay any of the deferred payments when the same becomes due, or if I misuse any of said chattels, or remove or attempt to remove same, or any part thereof, from said location, or in case of seizure of the same by process of law, or in case the said TRIBBLE & PICKETT FURNITURE CO. has, in their opinion, good reason to fear for the safety of their interests in said chattels, the said TRIBBLE & PICKETT FURNITURE CO. is to have and is hereby conceded the right to take said chattels back into their possession without previous demand and without legal writ; and for that purpose I hereby give them or their agents the authority to enter my premises without process, at any reasonable hour of the day, and take said chattels away.

IT IS EXPRESSLY UNDERSTOOD, however, that if, for any of the foregoing reasons, said chattels are taken by said TRIBBLE & PICKETT FURNITURE CO., under the terms of this instrument, the said TRIBBLE & PICKETT FURNITURE CO. may repair and store same at my expense and may sell the same within a reasonable time at private sale or otherwise, in the regular course of business and pay over to me or my assigns the proceeds of such sale remaining, after first deducting therefrom all sums still owing by me on account of the above mentioned payments, together with all reasonable charges and expenses attending the recovery, repair, storage and sale of said chattels, including Court costs and attorney's fees. It is expressly agreed that the title to the above described goods shall remain in the TRIBBLE & PICKETT FURNITURE CO. until all of the above amount is fully paid.
