### MEREDITH WINS GOLF TOURNEY

Makes Net Score of 68 in Handicap Bout at Danville Country Club, Ransdall is Runner-Up.

Dr. T. O. Meredith won the golf tournament held Sunday between the Harrodsburg members of the Danville with a net score of 68. F. L. Ransdall was runner-up with a 69. These two topped the playing of twelve other Harrodsburg golfers who were in the meet.

The tournament was planned and sponsored by several local merchants in cooperation with the golf players. Eight prizes were awarded, seven to the best players and one booby prize. Quite a number of Harrodsburg people witnessed the match.

Prizes awarded were as follows: 1st, five dollars in golf equipment, Dr. T. O. Meredith; 2nd four dollars in golf equipment, F. L. Ransdall; 3rd and 4th went to Jesse Cotton and James Stagg who tied with a net score of 70, \$2.50 of equipment each; 5th and 6th to Fisher Wilmore and Harry Blanton, each with net scores of 71, five gallons of gas from Watts and Durr Oil Co., and fifty cents in trade at Bonta and Noel went to each one; the 7th prize of one dollar

in trade at Phillips & Phillips was divided between William Gatchel and Roy Sutherland who each had a set score of 75. The three golf balls given to the man with high score by Pat McNamara, pro at the Danville club, went to R. T. Edwards. Other players who were entered in the tournament were J. W. McClellan, W. H. Phillips, Douglas Curry, Willard Gabhart and Marshall Royalty.

### Delegates Return From Baptist Meeting

### STATE TAKES TITLE TO LINCOLN HOMESTEAD

Title to the Lincoln Homestead Park in Washington County near Springfield was accepted Saturday on behalf of the Commonwealth by Gov. A. B. Chandler, Attorney General B. M. Vincent and Finance Commissioner J. Dan Talbott.

The park, consisting of twenty-two acres of land, a replica of the original Lincoln homestead, a club house and a shrine to Nancy Hanks, mother of Lincoln, was donated to the State by the Washington County Historical Society, with the agreement the society would maintain the park at no cost to the State.

### FIRE LADS BEST DANGEROUS FIRES

Grass Fire and Blaze From Coal Oil Water Heater Burn Within An Hour.

Two fires, occurring within an hour Monday, were put out by the fire department before serious damage was done although both fires were of a dangerous nature.

At about 11 o'clock a defective coal oil water heater in the Marlowe Beauty Shop blazed up. Mrs. Clara H. Marlowe, who operates the shop, removed the danger of any great damage by quickly taking the oil container from the burner. She then tried to beat out the flame with a mop but this also caught on fire. When she threw mop out the back door it caught some scrap paper on fire there. However, the firemen arrived then and all was soon well in hand.

About a half acre of dry grass burned an hour later on the vacant lot of Richard Corran on Beaumont avenue, and on surrounding property. It was feared, Fire Chief K. B. Phillips said, that the fire might spread to the homes of Ernest A. Prewitt, Walter Keightley and Will Sims near by. With the help of a Royalty-Keightley Lumber Co. truck which aided in reeling out the hose, the firemen were able to bring the blaze under control before it reached the houses. The cause of the fire was undetermined.

The work must be done on or after July 1. The notice is published in this paper.

### BLESSING OF BERRIES OFF BECAUSE OF DROUGHT

There will be no ceremonies blessing the berry crop at Parksville in Boyle county this year. The drought has wiped out the raspberries.

The berry crop, usually worth from \$5,000 to \$10,000, last year gave employment to from 150 to 200 persons. It has been the custom to have a clergyman bless the crop.

### Gatchel to Occupy Vivion's Old Store

W. C. Gatchel plans to occupy the Vivion Racket store room with his five and ten cent store by July 25, according to plans he announced this week. It is expected to terminate the closing out sale by July 11 when the store room will be turned over to remodelers.

"We intend to continue to feature the complete line of fishing tackle for which Mr. Vivion's store has been long noted throughout Central Kentucky," Mr. Gatchel stated.

Mr. Gatchel said that Harrodsburg labor would be exclusively employed in the remodeling and redecoration of his new location. The store will be redecored, including painting of the front and interior and installation of equipment now in use in Mr. Gatchel's present location. New electrical fixtures also will be installed.

### WHO KNOWS TOM HART FORMER RESIDENT HERE?

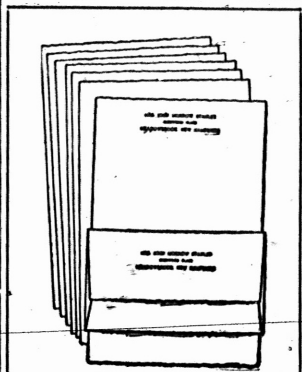
