She states that the defendant has no other property in this state, known to the plaintiff, and that the said crop is of such a perishable nature that for her to undertake to cultivate and mature it would result in great loss to all parties. She states that an immediate sale of same is necessary in order to be of any benefit to her and her child. She states that the defendant has left the State of Kentucky, is a ~~non-resident~~ non-resident thereof, and plaintiff believes is now absent therefrom. She states that she does not know the post-office address of the defendant, but when last heard from he was in Kansas City, Missouri.

Wherefore she prays that a warning order be issued against the defendant and for an order of attachment against his property in this State, and especially the property ~~main~~ mentioned in this petition. She prays for an immediate sale of said property and for all orders necessary to protect her interests and that of her child in this crisis. She prays for all general and equitable relief. She prays for an order that the proceeds of the sale be turned over to her ~~as~~ and that said proceeds be adjudged to be exempt to her under the laws of the state.
