Tax records/polls: Attleboro, Raynham, Rehoboth, and Taunton

Historical & Biographical Note: Attleboro, Raynham, Rehoboth, and Taunton are all cities and towns in Bristol County settled in the late 1630's and early 1640's. At that time, Attleboro was part of Rehoboth and Raynham was settled as a part of Taunton. This box contains original tax receipts, records, polls, and censuses from the early years of these towns.

Scope & Content Note: This box contains tax records, receipts, and census from Attleboro, Rehoboth, Raynham, and Taunton from 1638-1857.
