Historical & Biographical Note:

Taunton is a city in Bristol County Massachusetts and one of the oldest in the United States. It was founded as a town in 1639 and incorporated as a city in 1864. The city has a Mayoral-Council form of government and is the seat of Bristol County.

Scope & Content Note:

The Taunton City Records includes 9 boxes, 400 folders, and 1 box of street directories, maps of Taunton, Bristol and Plymouth County, pathfinders, mayoral correspondences, revised ordinances and charters, cemetery rules and regulations, flood insurance studies and maps, water quality reports, water commissioners annual reports, Taunton histories, school department reports, municipal registers and annual reports, city of Taunton annual reports, Taunton housing authority reports, Taunton zoning districts, departmental reports and recognitions, mayoral addresses, assessor's street list, Taunton city documents, register of voters street list, petitions, orders and committee notices from the committee of Public Property, Fire department, committee of Streets and Bridges, the City Clerk's office, and the committee of finance, and correspondences to and from people in and working for the city of Taunton.

Series Description:

1890 - 1892; Claims and reports of the Taunton Railway Co., Petitions to dig up streets, put up barber poles and signs, and miscellaneous petitions, Annual police report, Reports of the City Solicitor
