The membership, Board of Directors, officers and staff of the Springfield Area Chamber of Commerce can be justly proud of the success of the Chamber in 1983.

The Chamber, with the leadership of the Economic Development Committee and the Board of Directors, continued to devote maximum effort to the area of economic development. The Chamber has worked with the Oregon-Pacific Economic Development Corporation and most significantly entered into a Joint Venture Agreement with the Eugene



Chamber of Commerce, the City of Springfield, and the City of Eugene for industrial recruitment.

The two Chambers and the two Cities have pledged to promote the metropolitan Eugene/Springfield area as the site for new businesses under a metropolitan concept. The Metro team this past year has attended trade shows and will continue throughout the coming year to attend trade shows for the purpose of selling our metropolitan area. The Metro team has also been instrumental in contacting potential businesses and showcasing our area when several of those businesses have visited for the purpose of exploring location here.

The Governmental Affairs Committee, under the able leadership of Jack Eberly, and with the cooperation of Association of Oregon Industries, had a successful lobbying year supporting business, industry and the professions in the Oregon Legislative Session.

The members of the other standing committees of the Chamber have contributed virtually hundreds of volunteer hours for the purpose of advancing the economic, industrial, professional, cultural and civic welfare of Springfield.


