Scope and Content

The collection consists of deeds, contracts, administrative records, correspondence and textual ephemera likely gathered by Alice Schenck Teller and her descendants. Most notably, the

collection includes administrative records of seven companies serving in the American Revolution garrisoning the forts of the Hudson Highlands from 1776 until 1777. These records include payrolls, accounts of rations and mileage.

Historical Note

Johannes Schenck was born in circa 1656, married Maria Magdalena and gave birth to Johannes Schenck on April 30th, 1691. Maria passed away on April 9th, 1792, and the elder Johannes died on February 5th, 1748 at the age of 92. The younger Johannes gave birth to Abraham Schenck on August 6th, 1720, Issac Schenck at an unknown date, and passed away on April 1st, 1729.

The Dutch-speaking Abraham Schenck and his wife Elsie Vandervoot (born August 23, 1720, died October 2nd, 1784 (consumption), gave birth to 15 children:

Elizabeth Schenck married John MacPherson (born November 12th, 1758) on November 10th, 1774. They gave birth to a daughter, Maria Magdalena MacPherson on August 25th, 1780. The child died on February 9th, 1782.

The elder Abraham Schenck, whose account listed the above information, was the grandfather of Alice Schenck Teller. Alice Schenck Teller married Isaac DePeyster Teller and gave birth to Isaac Teller, who died single in 1868.

It may have been Alice Schenck Teller who gathered material on her father's side of the family. Francis Rombouts married Helena Teller, sister of William Teller, on September 20th, 1683. They

gave birth to Catherine Rombouts who married Roger Brett. Rombouts was an elected official in New Netherland, serving as Mayor of New Amsterdam in 1679-1680. In 1683, Rombouts, along with Gulian Verplanck and Stephanus Van Cortlandt, purchased around 85,000 acres in modern-day southern Dutchess County. The land was granted by King James II in 1685 as the Rombout Patent which encompassed the east bank of the Hudson River between the mouths of Fishkill and Wappingers Creeks to an eastern boundary roughly halfway between the river and the Connecticut border. Rombouts died in 1691. Another daughter of Helena Rombouts, Maria, married Isaac de Peyster.

In 1709, 300 acres directly north of Fishkill Creek along the Hudson was transferred to merchant William Peartree. Roger Brett was found on the 1714 list of the 445 inhabitants of Dutchess County (including slaves but probably not women); he died in 1716. In 1737, Catherine Brett transferred 150 acres on the north side of Fishkill Creek to Richard Prippen. Catherine Brett gave birth to two children, Francis Brett and Robert Brett, before dying in 1763. The estate was split between Francis Brett and the children of Robert Brett: Matthew, Francis, Rombout, Sarah, and Robert, and two grandchildren: Theodoures the son of Francis & Robert the son of Robert.
