This Agreement made and entered into the 30th. day of October 1929 by and between A.L.Pitassi hereinafter called the window contractor and the Myers Park Methodist Church South hereinafter called the owners.

Witnesseth, that the contractor and the owners for the consideration hereinafter named agree as follows:-

Article 1. The contractor agrees to provide all the materials and build the Church windows as follows:-

Four clearstory windows and four side aisle windows are to be built at once and delivered in approximately seventy five days from the date of this Agreement. The large front window is to be started at once and delivered October 1930. The other windows are to be started ^{not} until the owners notify the contractor to start. The owners are not bound by this Agreement should the first group of windows installed be unsatisfactory. It is understood that all the windows are to be made of English Antique Glass.

Article 2. For the windows F.O.B. Cars, ~~Philadelphia~~ Pittsburgh. the owners agree to pay the contractor in current funds the sum of \$1200.00 for each clearstory window, \$250.00 for each side aisle window and \$6400.00 for the large front window. The owners are to pay transportation for the windows and are to set same in the building.

Article 3. The contractor and the owners for themselves, their successors, executors, administrators and assigns, hereby agree to the full performance of the covenants herein contained.
