- E. To the HINDSBORO METHODIST CHURCH, Hindsboro, Illinois - FIVE THOUSAND DOLLARS (\$5,000.00).
- F. To EASTERN ILLINOIS UNIVERSITY FOUNDATION, Charleston, Illinois - TEN THOUSAND DOLLARS (\$10,000.00). I direct that said sum be placed in the Teacher College/Eastern State Normal School High School Alumni Scholarship in honor and memory of SOPHA E.
