Roosevelt Day Is Planned For April 30

The achievements of President Franklin D. Roosevelt since his inauguration March 4th, has started a movement to have the Nation express its gratification and confidence.

The movement started in Los Angeles Monday, and churches, civic organizations and the general public, will meet and prayers will be offered to give him health and strength to

carry out his plans.

It is proposed by Governor Rolph and many civic bodies to set this day aside as "President's Day," and all citizens will be urged to join and pray for the continued success of the President.

This is a worthy plan, as President Roosevelt has made an outstanding record since his induction into office.

Local Aviator Narrowly Escapes Death

Escaping death by a mere accident, Carl Prahl, youthful Encinitas pilot, is this week telling friends of his crackup in a potato field last Friday morning at Ponto, 10 miles south of Oceanside.

Prahl had gone up in the morning for a little flight. When his motor began to miss an emergency landing became necessary in the field. When the wheels struck the soft dirt, the plane nosed over, practically demolishing it. The only injury to Prahl were bruises around the eyes, and a cut nose, where his goggles broke when he hit the dashboard.

Just after Prahl had been fixed up in Dr. Lindsay's office, Frank Cable, carpenter, who was repairing a house on the bluff, was brought into the office to be treated for a broken wrist, the result of falling from a scaffold erected to work on the second story of a house. He lost his balance and fell to the ground.

New Trust Deed Ruling Made By Supreme Court

Decision of the state supreme court last week, of interest to every person who has made a trust deed or who holds one, was announced Saturday by B. Grant Taylor, clerk of the court. The opinion, written by Justice John W. Schenk, rules that the holder of a promissory note secured by a trust deed first must exhaust the security before suing on the note.

The new decision is a reversal of a former one given by the same court in the same case, that of the Bank of Italy against G. J. Bentley and others. The litigation originated at Stockton, when Judge D. M. Young of San Joaquin county superior court ruled as the supreme court now has ruled.

Judge Young gave judgment for the defendants on the theory that no independent suit could be maintained on the note, but that the security for the note first must be exhausted by the appropriate remedy under a deed of trust, and an action brought thereafter for any deficiency.

It was explained here that it has been the practice of many persons holding trust deeds to sue to recover on the note signed at the time the trust deed was made, and to make no mention to their pleadings of the security, and then to attach any or all property of the defendant, without first looking to the security given in the deed of trust.

Solana Beach Woman Is Seriously Shot

Deputy sheriffs early Monday morning were investigating the shooting of Miss Francesca Martinez, 40, at Solana Beach last Sunday night.

Miss Martinez was brought to the county hospital in San Diego where she is not expected to live. Investigation by Boyd Moran, deputy sheriff, revealed that the shooting occurred in the woman's home in Solana Beach. Moran said the woman admitted shooting herself. Moran was unable to learn whether Miss Martinez attempted suicide or shot herself accidentally.

The bullet penetrated her left side near her heart.

Who's Who: In Washington, D.C.

JAMES A. FARLEY

James A. Farley, popularly known as "Jim,"—Postmaster General—was born at Grassy Point, N. Y., May 30, 1888.

From his early youth Jim took an active interest in sports, and was the best first baseman Haverstraw ever saw. He is a splendid specimen of manhood, stands 6 feet 2½ inches, is a notable Elk, has been the exalted ruler of Haverstraw Lodge, district deputy in Southeast New York district; the largest Lodge in the United States, and president of the Past Exalted Ruler's association of the district. He is also a prominent member of the Eagles, Redmen and Knights of Columbus.

His first entry into politics was way back in 1896 when, as a mere boy, he carried a torch, whooping it up for the famous "Bill Bryan." In 1912 he was elected town clerk of Stoney Point, which office he held for 7 years.

In 1917 he met Al Smith, and a friendship sprung up between Jim and the "Happy Warrior," and after the 1918 election was rewarded for his good work by being appointed Post Warden of New York.

In 1924 he was appointed to State

Boxing Commission, which position he held until recently, when he resigned to accept his present position as Postmaster General.

In 1930 he was appointed chairman of the Democratic State Committee, and immediately began his campaign in behalf of the great friend of the people, Franklin D. Roosevelt.

Jim started a 30,000 mile trip over the west. While on this trip he contacted thousands of people, and on his return he wrote personal letters to every one of them.

It is a known fact that the beaming smile and booming voice of Big Jim Farley is contagious, and when the Democratic convention was at its height in Chicago, the big figure of Jim Farley moved amongst the various state delegations and candidates' headquarters with his winning ways, and was the means of swinging many votes to the banner of Franklin D. Roosevelt.

Jim Farley, at the age of 44, is one of not the youngest members of President Roosevelt's cabinet. Full of energy and enthusiasm, and through his able salesmanship, sold Franklin D. Roosevelt and his New Deal to the American people.

Grieving Widow Leaps To Death

After writing a "farewell note" to her brother, Mrs. Madeline Murphy, 32, of Oceanside, leaped four stories from a Los Angeles apartment house Sunday to her death, according to an Associated Press dispatch.

Her brother, R. A. Morris, said she had been morose and grief-stricken and he believed she may have become mentally deranged. The note was penciled on the back of a telegram of sympathy she received five years ago when her husband, Charles L. Murphy, superintendent of the Oceanside Gas company, was killed in an explosion.

"I am sorry, but I cannot make the grade," the note read.

Poultry Co-op Opens Branch in Encinitas

Due to an increased demand for its service, products and marketing service in the northern section of the county, the San Diego Co-Operative Poultry Association has found it practical to open a branch in Encinitas where feeds of the Association brand are available to poultrymen and livestock feeders of this section.

This station, located on the east side of First street (Highway) one-half block south of the Bank, is in charge of R. L. Threlkeld.

It is the intention of Mr. Threlkeld to save producers the expense of a trip to San Diego in being able to buy at San Diego rates. If practical, every effort will be made to economize the poultry industry in the Encinitas section, which seems so well adapted to this business.

San Diego County Poultry Producers Ass'n was organized in 1916.

The first place of business was at the foot of G street in San Diego, in a small warehouse.

With a membership of less than 100 the operating capital was less than \$1000 paid in, with a gross yearly business of \$75,000.00.

In June, 1919, the association was incorporated the pass capital Stock corporation with Key to the Script-chased by Mary Baker Eddy, says: avenue and Love may require many with rail facilities.

The 1933 valuation for land, buildings, equipment, are upwards of \$100,000.00, with stock of feed carried of approximately \$100,000 value.

G. C. Keeney has been president and manager continuously since 1923. During the past twelve years there has been returned to members over half a million dollars in refunds and interest. The amount of feed sold during 1932, one of the best years of the Association, amounted to 16,566 tons.

Another valuable asset to the Association is its supply department where practically every item in daily use on the poultry ranch may be purchased at a saving.

A recent addition to the Association stock is the inclusion of fertilizers for use by avocado and fruit growers generally.

G. F. Poggi, owner of the Sorrento Poultry Farm, is the poultrymen's representative in the northern district of the county, and for several years has been a member of the Association's Board of Directors. With him are associated the following from other sections:

For the first time in many years this early home of Don Juan Maria Osuna, original grantee and owner of 9000 acres bordering on the San Diego valley, will be open to the public during the two days of the flower show Saturday and Sunday, April 22

and 23. Saturday the show will be open from 1 to 10 p. m. and on Sunday from 9 a. m. to 9 p. m.

Members of the Rancho Santa Fe Garden Club propose to make of this occasion one to be remembered for its keynote of hospitality, as well as a display of well-arranged flower exhibits. The charming gardens which surround the house have never been in finer condition, the beautifully terraced rose garden, vine-clad porches, and sweeping lawns which lead away toward sequestered paths among the

EDITORIAL

The major oil companies apparently want the independents to do all the "conserving," but when John B. Elliott of Los Angeles, (and prominently mentioned as Democratic nominee for Governor of California next election) and his associates get through with them they'll know that they've been in a fight. The old style of monopoly is passe.

BANK GUARANTEE

Senator W. G. McAdoo has announced that he will propose legislation to turn control of the banking system of the country over to the government and to guarantee bank deposits. There are now 49 banking systems, one set up by each state and one by the government. Proposal for the guarantee of bank deposits is attracting widespread support among conservatives who, a year or more ago, would have turned a deaf ear to the suggestion. There are objections to guaranteed bank deposits. Every state that has attempted the idea has failed. Federal guarantee, however, could be a different thing from state guarantee. Banks with sound management protest the plan would force them to pay for improper management. The objections are reasonable.

But the time has arrived when the country must re-establish confidence. Nothing else approaches that problem in importance. The necessity for confidence wipes out the minor objections to the deposit guarantee plan.

Somebody would have to pay for the guarantee of bank deposits. And of course that somebody would be the depositor. A portion of the interest now paid by banks on savings deposits would be appropriated to the guarantee fund.

Supporters of the idea for government guarantee of bank deposits believe that the instant such a guarantee went into effect hoarding would cease and credit would be plentiful. Such a situation is still desired. The new strains have the spring bloom, stems and large flowers, rangarful color from white through to red. They would be anxious to get money into the channels of business.

The entire banking structure is certain to be overhauled during the next few years. Failure to function during periods of stress has condemned the existing system.

The fourth stein was added, while the platter was pushed before me.

"Carven, I wish you would secure the recommendation of the Central Committee for me to be Minister to Gobi," was asked me by one.

THERE MUST BE TAX REDUCTION

In 1930 the population of the United States was a trifle less than twice that of 1890.

The national wealth was six times as great. The tax collections of government, federal, state and local, were twelve times the 1890 levies. An 827 per cent increase was registered by the federal government, with state and local taxes jumping 1754 per cent and 1139 per cent respectively. Since 1930 taxes have continued to increase. National income has taken an appreciable drop. There has been little change in population. At the moment, more of the individual and business dollar goes to government than at any other time in our history. During 1933 it is estimated that taxes will take at least 30 percent of national income.

Taxation is as serious an economic problem as we have ever faces. There has been, on the one hand, an unprecedented collapse in incomes and values—on the other, an unprecedented orgy of governmental spending and indebtedness. Until taxes are reduced, there can be no recovery—unless taxes are reduced we face a black future.

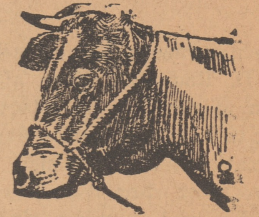

Mt. Helix Easter Sunrise Services

For the 16th consecutive year the picturesque nature amphitheatre atop Mount Helix next Sunday will be the scene of an inspiring Easter sunrise service, with an expected attendance of more than 10,000 southern Californians. Considered by many, the outstanding event of the year, Mount Helix is the mecca each Easter for an increasingly large throng of worshippers. Here was held the first sunrise service of its kind, after which programs in the Hollywood Bowl and at Mount Rubidoux have been fashioned.

Garden Hints

Gerbera (Transvaal Daisy)

Judging from recent interest at flower shows only a few home gardens have seen the improved Gerbera now being grown and sold in California. Colors range from yellow through crimson, rose, pink, white and lilac shades. Any home garden can have success in raising this very beautiful flower provided there is plenty of heat to insure good growth and the winters are not too severe.

Gerberas will bloom over a long period but have been said to bloom best in summer. Winter bloom is not uncommon in places where the weather is warm, as in the warm foothill belt of central and southern California. Well established plants of the best varieties in different colors are available and will be suited to many home gardens.

Pentstemon

Pentstemons are often recommended in place of snapdragons when snap dragon rust is serious. The pentstemons are similar in appearance and have very few troubles, but the flowers do not keep as well when cut. There is a caterpillar that likes pentstemons and must be hand picked, or the foliage sprayed with lead arsenate to prevent trouble. Pentstemons like a well drained, fertile soil and will not do well on a soil that is kept saturated with water. A cool place in the full sun is best.

The large flowered pentstemons (Pentstemon gloxonioides) have been grown in many California gardens. Named varieties like Sensation and Sensation Improved have been outstanding for their size and color. More recently home gardeners have begun to realize the merits of some of the smaller flowered western native species running to pinks and blues or lavenders. Certainly these natives are well adapted for home gardens.

Pinks

(Dianthus)

There are many species of garden pinks being grown in gardens in California. The increased interest in rock gardens has given more emphasis to the planting of pinks. The Chinese pink (Dianthus chinensis) includes many strains, the variety Hedd ewig being most common and usually treated as an annual. The old spice pink (Dianthus plumarius) is still popular for the late spring bloom. Alwoodi pink (Dianthus alwoodii) is a native of California (Dianthus caryophyllus), are extensively grown. Many of the garden pinks now being passed from one neighbor to another are of this hybrid origin. Seedlings also appear in many gardens. The blooming season is longer than in the ordinary spice pink. Still another hybrid group has recently been developed

ed by crossing the Alwoodi pinks with the sweet williams to give annuals of the general habit of the sweet william but with individual flowers more like the pinks.

Phlox

Experience has taught that the well-known perennial phlox (phlox paniculata and P. maculata) only occasionally does well in California. Some gardeners of the north coast and also in the citrus belt of southern California have had very satisfactory results. A southern California nursery lists over a dozen named varieties and the plants are doing very well considering the dry climate. Persons who are interested should test out a few popular varieties like Professor Schliemann (lilac-rose) and Rynstrom (rose-pink) to see how they thrive under local conditions. Other colors ranging to lavender lilac, salmon and red are available in California nurseries.

Other perennial species of phlox have done very well near the coast in the northern portion of the state. Phlox subulata is a gem in the rock garden when the right conditions are provided. P. amoena is another species which has done well in rock gardens in central California near the coast. Good drainage, cool growing weather, and some moisture with fertile soil is about all these phloxes need.

Poppies (Perennial)

Most people are familiar with the annual poppies which have been grown in gardens since ancient times, most of these belonging to Papaver somniferum, the opium poppy. The Shirley poppy was developed about 1880 from Papaver rhaeus, the corn poppy of Europe. The perennial poppies are not so well known as the annuals but should have a great appeal because of their permanency and excellent blooms.

The oriental poppy (Papaver orientale) has many colors including pink. The Iceland poppy (Papaver nudicaule) is now receiving a great amount of interest, which is justly deserved. It is a true perennial, is easily grown, transplants well, and it makes an excellent cut flower. There are both single and double forms and the color range is all that could be desired. The new strains have long stems and large flowers, ranging in color from white through orange, pink, yellow, chamois, and salmon rose. Coonara Pink, Gibson (orange) and Orange Gold are good examples of new varieties. The Stanford strain of England is one of the best. Plants started in the early spring will bloom by late June or the first part of July and will be well established for following years.
