Assessment of the age of the house.

The original deed search concluded that the house was built in 1921. This was later amended to 1881. The plaque on the house reads Gerling House c 1881. Either the date the house was built is incorrect or the name on the house is incorrect as the Gerling family did not take possession of the property until 1920. The Hamilton county auditor has the date of the house as 1880. The Kloth family owned the west side of lot134 and built the house on the south side of the west side of lot 134 in 1865. I believe the Kloth family then built the house on the north side of the west side of lot 134 circa 1881 for Elizabeth Kloth and did not deed the property to her until 1903.
