Steward of God

"I am only acting as a steward of God: you must thank Him." – WILLIAM A. PROCTER

The establishment of Saint Elizabeth's was due, in large part, to the financial support of William Alexander Procter of Glendale, Ohio. He served as first president of the Procter & Gamble Company, from 1890 to 1907. He was a faithful member of the Episcopal Church. His philambropy extended to many organizations in Ohio and elsewhere.

When Deaconess Drant sought a sponsor for her missionary work to Hawai'i, Mr. Procter willingly paid her travel costs, salary, and annual hving expenses. As the work of Saint Elizabeth's expanded, a more permanent location was sought. In 1904, Mr. Procter provided the necessary funds to purchase a half-block of land bordered by King and Kanoa Streets and Paa Lane. Upon this property, he financed the construction and furnishing of a church, settlement house, and vicarage.

In 1906, Mr. Procter funded the purchase of a property on the other side of Kanoa Street. It extended from Pia Lane to the middle of the block. The remainder of the block ending at Banyan Street, was purchased through the generosity of another benefactor, Stephen A. Palmer of NewYork. These combined properties became the site of an affordable housing development for mission communicants. Mr. Procter also realized that church

communicants. Mr. Procter also realized that church workers needed an occasional respite from their labors. Though his generosity, a vacation home in Waiähole Valley was purchased for their use. It was named the Olivia Procter Rest House.

The alfordable housing development on the 'Saint Elizabeth's Mission grounds sisted of cottages for narried couples and young families, and a two-stop demultory for single nen, By 1927, there were a total wonly-six cottages. They occupied the area across Kanoa Street, between Pas Lane and Banyan Street, and the site where the sent church now steads.

Mr. Procter unexpectedly died on Good Friday in 1907. In paying tribute to Mr. Procter, Bishop Restarick remarked: "He had been a very large giver to many charities, and to the Church, but nothing had given him more genuine pleasure than the work at Saith Elizabeth's, in every detail of which he was kept informed by letters and photographs. It was a pleasure to be told by his children that his interest in this work had been a great blessing to him?

The shildren of Mr. Procter continued to support the work of Saint Elizabeth's that had meant so much to their father. They presented the stained-glass altarpiece in 1907, in memory of their mother. Created by Tiffany and Company of New York, the altarpiece shows Saint Elizabeth and Saint John the Baptist receiving a visit from Jesus. The generosity of the Procter children also made possible the acquisition of the remaining portion of the block on Kino Street in 1911.



The Rev Cance William E. Detwine was saint Elizabeth's first priest-in-charge. After seeing people living in over-crowded and unsanitary conditions in nearby tencements, he immediately addressed this housing crisis. With the financial support of William A. Proctee, he built the first affordable housing devolement in Houselulu in 1905.
